| We support a statement which clearly explains what is meant by "presumption against closure" in a clear and unambiguous way. |
| Our view is that rural schools should not be treated in any way different from other schools, although we appreciate that the report must be agreed by all parties, which includes rural schools campaigners. |
| Given the 'flexibility' shown, we had anticipated acceptance of all the recommendations by all parties, including the Government. We are disappointed that the Government has chosen not to implement recommendation 20, given, in our opinion, that it offers a clear rationale and common understanding that business decisions can sometimes be made which have a 'neutral effect'. |
