  - (i) the Commission's response to the previous consultation on councillor numbers;
  - (ii) the timetable for the consultation; and
  - (iii) the electorate figures used in the consultation.
- (4) delegate to the Chief Executive, in consultation with the Leader of the Administration and the Leader of the Opposition, authority to conjoin in any action for judicial review of the Commission's decision making and process if it is considered that this would be in the interests of Falkirk Council; and
- (5) authorise officers to inform the Commission of the anomaly in the boundary between Ward 4 (Carse, Kinnaird and Tryst) and Ward 5 (Bonnybridge and Larbert) in the Carronvale Road area and to ask the Commission to amend the boundary between these two wards to reflect the reality on the ground.
