### **PURPOSE** 1.

1.1 The purpose of this report is to present revisions to Standing Orders in light of Council's decision on 24 June 2015 to amend its Service structure.

#### 2. **BACKGROUND**

- 2.1 On 24 June 2015, Council agreed a revised Service structure together with a revised Chief Officer structure with consequential changes to the Scheme of Delegation, Financial Regulations and contract Standing Orders.
- 2.2 The changes are, in the main, minor and reflect changes in post or in Service titles or where a delegated function now lies with a different Chief Officer following the restructure.

3.1 Council is invited to approve the proposed changes to the Scheme of Delegation, Financial Regulations and Contract Standing Orders following the introduction of a new Service and Chief Officer structure in June 2014.
