1. Purpose of Report

1.1 The purpose of this report is to present a timetable of meetings for the period 1 January to 29 March 2017.

2. Recommendations

Council is asked to agree the programme of meetings for the period January to 29 March 2017

3. Background

3.1 Council traditionally agrees at the first meeting after the summer recess its programme of meetings for the forthcoming calendar year. The exception to this is when local government elections are to be held in the next year. In such cases a programme of meetings for January to April is normally set with the newly elected Council agreeing a programme for the remainder of the year at its first meeting in May.

4. Considerations

- 4.1 The programme is based upon three weekly meetings of the Executive (with one in three meetings being the Education Executive) and bi monthly meetings of the Scrutiny Committee/Scrutiny Committee (External). Members should note the following features of the timetable:-
 - The final meeting of Council will be on 29 March 2017. This is later in March than in recent years. However this allows the cycle of meetings to be completed. It would be possible to schedule for further meetings of the Executive and Scrutiny Committees after this date. However it has been the practice in previous years not to schedule policy and scrutiny committees after the final Council meeting in recognition of the demands on members during the election nomination period;
 - As Council's regulatory business (planning and civic licensing) will continue to accrue there may be a need to schedule meetings of both bodies in April 2017. The last scheduled meeting of the Planning Committee is 22 March. Should members decide at that meeting it would be necessary to make site visits in order to inform their decision making then additional meetings may be required in April;

- There may be a requirement to call other meetings in addition to those set today. This could include meetings of ad hoc bodies such as the Appeals and Appointments Committees for example. Special meetings may also be called. Such meetings would be called in accordance with Standing Orders;
- The date of the Council's budget setting meeting is proposed as 22 February.
 However this will be dependent on the timing of the Scottish Government's
 budget settlement announcement. The settlement is expected to be in
 December but the precise timing is not yet known. The date therefore is 'to be
 confirmed'. The final date will be set by the Provost in accordance with
 Standing Orders and communicated to members at the earliest opportunity;
- The programme does not include meetings of the performance panel or Licensing Board. Both bodies will agree their own timetable for the period.
