FC1. Chair

In accordance with section 4(4) of the Local Government etc. (Scotland) Act 1994, Mary Pitcaithly, Returning Officer, presided at the meeting until the election of the Provost.

FC2. Sederunt

The sederunt was taken by way of a roll call.

FC3. Minute Silence

Council observed a minute's silence in memory of the victims of the terrorist attack on Manchester on 22 May 2017.

FC4. Declarations of Interest

No declarations were made.

FC5. Election of Falkirk Councillors

Council considered a report by the Chief Executive which advised of those councillors who had been elected to Falkirk Council following the Local Government Election on 4 May 2017 and of the political composition of the Council. The composition of the Council was:-

Scottish National Party – 12 Scottish Labour Party – 9 Scottish Conservative and Unionist Party – 7 Independent – 2.

Decision

Council noted the results of the Local Government Election held on 4 May 2017 and the political composition of the Council.

FC6. Appointment of Provost and Leader of the Council

Council considered a report by the Director of Corporate and Housing Services which invited Council to appoint a Provost and a Leader of the Council. Further, the report invited Council to consider making appointments to the positions of Depute Provost and Baillie.

The Local Government etc. (Scotland) Act 1994 requires that each Council elects a convener from among its councillors at its first meeting following an ordinary election. In Falkirk the convener of the Council has traditionally been known as the Provost.

(a) Appointment of the Provost

The Returning Officer sought nominations for the post of Provost.

Councillor Meiklejohn nominated Councillor Coleman.

Councillor Nicol nominated Councillor Patrick.

In terms of Standing Order 22.1, the vote was taken by roll call, there being 30 members present with voting as undernoted:-

(d) Appointment of Baillies

- (2) appointed Councillor Ann Ritchie as Depute Provost and continued consideration of remuneration for the position to later in the meeting;
- (3) appointed Councillor Cecil Meiklejohn as Leader of the Council, noting that remuneration for this position was set at £33,857 p.a., and
- (4) agreed not to make any appointment to the position of Baillie.

Having appointed the Leader of the Council, Council then adjourned at 9.55a.m. to allow the Administration and Opposition groups to meet prior to consideration of the remaining items. Council reconvened at 10.20am with all members present as per the sederunt.

FC7. Standing Orders

Council considered a report by the Director of Corporate and Housing Services presenting, as an appendix, the Council's Standing Orders for approval.

The Standing Orders are comprised of two documents: the Standing Orders in Relation to Meetings, and the Scheme of Delegation to Committees and Officers. These documents regulate the process of decision making within the Council and set out the composition of its committees. The current Standing Orders had been approved by Council on 29 March 2017 (ref FC 91).

Councillor Meiklejohn, seconded by Councillor Garner, moved that Council agrees that:-

- the Executive and Education Executive be reduced from 12 to 10 elected members with a better representation of 6 administration and 4 opposition;
- (2) portfolio remits are realigned to match Service areas and create a portfolio that covers across service areas for Performance, Improvement and Best Value;
- (3) a further report be provided on the remit for each of the realigned portfolio areas which will be brought back to Council;

- (5) Baillies are removed, as their role currently adds no real value to the Council.

FC9. The Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007

Council considered a report by the Director of Corporate and Housing Services providing information on payments to councillors where the level of remuneration lay within the discretion of the Council.

The remuneration paid to the Leader of the Council and the basic rate for all councillors was set in accordance with the Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007. As a Band B authority in terms of the regulations, Council could appoint up to 14 senior councillors. The maximum amount the civic head or a senior councillor can be paid is £25,392 (75% of the Leader's salary). Further, the total amount allocated to senior councillor payments could not exceed £296.238.

This officer has overall responsibility for ensuring that the Council's paid service is organised in a manner to allow the proper discharge of the Council's functions. Council was also required to appoint a Monitoring Officer, Chief Finance Officer, Chief Social Work Officer, Returning Officer, and Electoral Registration Officer. Appropriate Chief Officers had been matched against these positions and were set out in the appendix to the report for consideration.
