1. Introduction

1.1 This report sets out an executive summary of Children's Services performance for the period 1st April 2017 to 30th September 2017 and includes:

- significant challenges and changes in Service pressures since our last Performance Panel update; and
- an update on relevant underpinning strategies, i.e. workforce strategy, medium term financial strategy, and digital / technology strategy.

1.2 The attached Performance Panel statement (Appendix 1) updates the Panel on our progress towards achieving the priorities and outcomes within the Corporate Plan, progress on our key Council of the Future projects and areas for reform and our important indicators.

2. Recommendation

2.1 The Performance Panel is asked to note the performance of Children's Services over the period from 1st April 2017 to 30th September 2017.

3. Background

3.1 The Service makes a significant contribution to the achievement of the following Corporate Plan priorities and SOLD outcomes, particularly with regard to:

Corporate Plan priorities:

- People
 - raise aspiration and ambition
 - reduce the impact of poverty on children and their families
- Place
 - grow our economy
 - improve the neighbourhoods we live in
 - promote vibrant town centres

- Partnership
 - work with communities to deliver better services
 - empower and enable people to be self-reliant
 - promote stronger, more self-reliant communities

SOLD outcomes:

- our area will be a fairer and more equal place to live
 - we will grow our economy to secure successful businesses, investment and employment
 - our children will develop into resilient, confident and successful adults
 - our population will be healthier
 - people will live, full, independent and positive lives within supportive communities
 - our area will be a safer place to live
- 3.2 The performance statement attached, notes progress against the actions we are taking forward over the coming year under these headings (Appendix 1).
- 3.3 We will be determining our programme for areas for reform as reported to Council. These will be presented in our next report to Performance Panel.

4. Service Update

- 4.1 There have been a number of significant challenges, risks and changes in our Service since the last report to Performance Panel on 23rd March.
- Expansion of Early Years Provision to 1140 Hours (By 2020). There are considerable challenges around planning and developing an expansion programme which involves managing significant infrastructure change projects and significant workforce expansion over a short period of time. Over the last few months officers from several Services have spent a significant amount of time preparing our Strategic Early Years Expansion Plan and our accompanying financial and statistical estimates. These were submitted to the Scottish Government on 2 October 2017. These plans will be the subject of on-going discussion and meetings with the Scottish Government, The Scottish Futures Trust and the Improvement Service. A progress update report is being prepared for the Education Executive meeting in November.
 - There are considerable resource challenges emerging from the cost and capacity implications relating to Continuing Care which was introduced by the Children and Young People (S) Act 2014.
 - 26 young people are living in continuing care placements; they can remain in placement until they are 21. Previously the age limit was 18. The core of placements are increasing and the availability of beds are decreasing.

- In recent month officers have worked with colleagues from Clackmannanshire, Stirling and West Lothian councils to establish a Regional Improvement Collaborative to meet the requirements of the Scottish Government Education Governance Review. A report will be presented to the Education Executive in early November regarding the establishment of this Collaborative.

4.2 A number of strategies underpin our work. An update on these is provided below.

- Children's Services has submitted its Improvement Plan to the Scottish Government under the National Improvement Framework (NIF). This addresses the statutory requirement for local authorities to gather information on how schools will progress the NIF priorities. These are: tackling inequalities, closing the attainment gap between the most and the least disadvantaged children; improving children and young people's health and wellbeing; and improving employability skills and sustained positive destinations. A report evaluating the impact of the National Improvement Framework will be provided to the Education Executive in September 2018.
- Falkirk Council schools will receive funding of £3.5 million in session 2017-8 under the Pupil Equity Fund (PEF) to be used to close the attainment gap in Literacy, Numeracy and Health and Wellbeing. Schools have produced PEF statements showing how their interventions will raise attainment and improve family learning and parental engagement. Schools will work with officers to track and monitor the impact and effectiveness of these interventions over the next year.
- The Strategic Review of Children and Families Social Work has concluded the first stage of work which was to analyse underlying issues, understand the trends in service demand and identify actions required to mitigate the pressures on budgets. The next stage of work relates to the conclusion and implementation of the Closer To Home Strategy and the resulting action plan which seeks to bring about transformational change to children and families social work. The strategy is the viable solution to address growing financial pressures directly related to the cost of care, whilst improving outcomes for our children and young people.
- As a consequence of funding formula changes, the Criminal Justice Team has reduced budgets. In order to respond pro-actively to reducing budgets some re-design of provision is taking place.
- The Service is progressing the replacement of the Social Work Information System. The new system will deliver improvements to our information management and assist with streamlining workflows, information sharing and enhancing mobile and flexible working for front line staff. The specification of requirements is almost complete and the plan is to proceed to tender and selection of supplier by the turn of this year. Implementation will begin during 2018.

5. Conclusions and Future Actions

- 5.1 Children's Services will continue to progress work to achieve the outcomes identified within the Children's Services Plan.
- 5.2 Key areas of work will continue to be the expansion of Early Learning and Childcare; Implementation of Falkirk's NIF plan; the monitoring of actions identified to close the attainment gap and the use of Pupil Equity Funding; and actions arising from the Strategic Review of Children and Families Social Work Services to improve children's outcomes and significantly reduce revenue expenditure.
