#### 1. Purpose of Report

1.1 The purpose of this report is to seek approval for Councillor Coombes to attend the Scottish Tourism Alliance Conference for which the delegate fee, per person, is £200 plus VAT.

#### 2. Recommendation

### 2.1 The Executive is asked to consider Councillor Coombes' request to attend the Scottish Tourism Alliance Conference at a cost of £200 plus VAT on 1 March 2018.

#### 3. Background

3.1 Decision making on members' attendance at conferences and seminars is delegated to the Chief Governance Officer where the cost does not exceed £200. For conferences and seminars exceeding £200, approval requires to be sought from the Executive. The fee for attending this conference is £200 + VAT and is therefore over the delegated threshold.

#### 4. Considerations

#### Scottish Tourism Alliance Conference

- 4.1 The annual conference will focus on the opportunities and challenges faced by the tourism industry, the importance of tourism on the Scottish economy and the future of the Scottish tourism industry in the context of the UK and global economy. The event will be held on 1 March 2018 in the SECC, Glasgow, at the start of the first Scottish Tourism Month.
- 4.2 Councillor Coombes is a member of the Falkirk Community Trust Board and is the Labour Group's shadow spokesperson for the Culture, Leisure & Tourism portfolio. Attendance at this conference is in accordance with members' approved duties, as defined in the Local Government (Scotland) Act 1973.
- 4.3 Details of members' attendance and associated costs at conferences/seminars are reported annually, as required by the Local Government (Allowances and Expenses) (Scotland) Regulations 2007 and guidance issued by the Scottish Local Authorities Remuneration Committee.

#### 5. Consultation

5.1 No consultation was required.

#### 6. Implications

#### Financial

6.1 The full delegate fee for the Scottish Tourism Alliance Conference is £200 plus VAT. The cost can be met from existing budgetary provisions. In 2017/18, the budget for members' attendance at conferences and seminars is £5,130. Spend so far this year is £235. If the request presented in this report is approved, the total year-to-date spend will be £435, leaving a remaining budget of £4,695.
