1. INTRODUCTION

The Council received Finance Circular No. 5/2008 on 11 December 2008 following an announcement by the Cabinet Secretary for Finance and Sustainable Development in the Scottish Parliament on the amount of financial support being made available to Councils next year. Members will be aware that information for the three year period 2008/09 to 2010/11 was issued in December 2007 following the 2007 Spending Review, therefore next year's settlement will only reflect changes since the provisional figures were released.

2. REVENUE GRANT DISTRIBUTION

The following table sets out the all-Scotland amounts being made available next year:-

The Revised Funding for 2009/10 of £10,756.0m represents an increase of 5.4% over the 2008/09 level, however the bulk of the additional resources are required to meet specific expenditure pressures e.g. Free Personal and Nursing Care.

The amount being made available to Falkirk Council is £286.838m. The sum of £70m is included within the funding to be distributed later to encourage councils to again freeze council taxes at 2007/08 levels. If the Council decides to freeze the Council Tax, we will receive an additional £1.831m of this sum, making the total amount of revenue funding £288.669m.

3. CAPITAL FUNDING

The following table provides a summary of the all-Scotland capital funding for next year:-

The amount available next year is £945.6m, an increase of £17.5m or 1.9% on the 2008/09 level.

After taking account of the allocation of Private Sector Housing Grant which was released following the issue of Circular 5/2008, Falkirk's funding for next year is £17.716m. However, as noted above an element of funding has still to be distributed.

4. NON-DOMESTIC RATES

The non-domestic poundage has been set at 48.1 pence with a supplement of 0.4 pence for rateable values in excess of £29,000. This is an increase of 2.3 pence or 5% on the 2008/09 level. The Council is a significant ratepayer and our liability will increase by around £0.23m next year.

5. PROVISIONAL FIGURES FOR 2010/11

No updated provisional figures for 2010/11 are included pending confirmation of the impact on the Scottish budget of the UK-wide additional efficiency savings target of £5 billion contained within the Pre-Budget Report of 24 November 2008.

6. SUMMARY

Finance Circular 5/2008 provides details of the financial support which will be available to Councils next year. Updated figures for 2010/11 are not available at this time. Work is continuing to present spending plans for Members consideration on Wednesday 11 February 2009.

7. RECOMMENDATION

Members are invited to note the provisional Local Government Finance Settlement for 2009/10.
