1. BACKGROUND

- Members will recall that at their meeting on 12 March 2008 the Board 1.1 determined a number of miscellaneous discretionary application fees in terms of the Licensing Fees Scotland Regulations 2007. At that time the Board were advised that a number of other miscellaneous application fees still remained to be set by the Board.
