1. CONSIDERATION OF PLANNING APPLICATIONS

- 1.1 The above planning applications will be reported to the Planning Committee in the near future. They are related, to some degree, in that there is an overlap of some land affected by both applications: mainly the proposed access roundabouts. The applications are of some significance and application P/10/0188/PPP has had a lengthy period of public consultation. However, Members of the Planning Committee may not be familiar with this background.
- 1.2 It is recommended that the applications be considered at a special meeting of the Planning Committee in order to have time for a fuller than normal presentation and discussion, and the Convener has agreed to this. It is further recommended that this special meeting be preceded by a site visit, given the extent and significance of the applications. The meeting itself could potentially take place in a local building, proposed to be Whitecross Primary School, immediately after the site visit.

2. **RECOMMENDATION**




Planning Committee Planning Application Location Plan P/10/0188/PPP


