## P25. OPERATIONS YARD/WASTE RECYCLING/TRANSFER FACILITY AT SABIC INNOVATIVE PLASTICS, BO'NESS ROAD, GRANGEMOUTH FK3 9XF FOR MASTERTON – P/10/0423/FUL

With reference to Minute of Meeting of the Planning Committee held on 20 April 2011 (Paragraph P10 refers), Committee gave consideration to Report (circulated) dated 12 April 2011 by the Director of Development Services on an application for full planning permission for the development of an operations yard/waste recycling/transfer facility involving the processing, recycling and storage of inert material arising from the demolition, construction and excavation operations on a site bounded by industrial and petrochemical development extending to approximately 6.2 metres at Sabic Innovative Plastics, Bo'ness Road, Grangemouth.

The Convener introduced the parties present.

The Planning Officer (J Seidel) outlined the nature of the application.

Ms Frost and Mr Matheson, the applicant's representatives, were heard in relation to the application.

Ms McIntosh, on behalf of Grangemouth Community Council, an objector, was heard in relation to the applications.

The objections included the following issues:-

- The visual impact on the surrounding area from open storage of materials and the problem of stacking;
- The dust arising from open storage, processing and a lack of robust appropriate mitigation measures and odours;
- The effects on health and that the World Health Organisation guidelines for proximity to residential areas would be exceeded;
- The noise nuisance including cumulative noise from alarms, excavator and increased traffic movements;
- The local pollution and increase in traffic volumes including HGV's on an already busy road;
- The increased vehicle movements would be detrimental to the objectives of the Air Quality Management Area (AQMA);
- The contamination of surrounding roads and the surrounding area;
- The unauthorised operation of the site at Bonnybridge site over many years and the problems of dust;
- That waste was brought from a wide area with Grangemouth being a dumping ground;
- The inappropriateness of the location;
- The lack of Best Practical Environmental Option (BPEO) or sustainable for the community of Grangemouth; and
- The danger of fire or explosion.
