1. BACKGROUND

- 1.1 Members will recall that at its meeting on 17 August 2011, the Board determined annual fees in relation to Premises Licences from 1 October 2011.
- 1.2 The purpose of this report is to set the annual fees for Premises licences from 1 October 2012.
- 1.3 The annual fee for 2012/13 is due on 1 October 2012 for all Premises Licences in effect or suspended on that date or, in any other case, 30 days after the date on which the licence takes effect.
- 1.4 The annual fee payable under regulation 7 of the Licensing (Fees) (Scotland) Regulations 2007, requires to be determined by the Board in accordance with regulation 8. There are six categories of premises referred to in this regulation, determined according to the premises rateable value. For each category there is a maximum fee that may be set, varying from £180 to £900. Should the Board determine to set a fee level lower than the maximum, it must:
 - determine different fees for the six different categories, and
 - set those fees by reducing each of the fees by an identical percentage
- 1.5 It is the recommendation that the annual fees in relation to premises licences are set in accordance with the statutory maximum detailed in appendix 1 to this report. The basis for the recommendation is to maintain and support the necessary resources and staffing levels to ensure that the issues and requirements which have been highlighted by the Board as requiring to be addressed continue for the coming year as set out in Regulation 13 of the Licensing (Fees) (Scotland) Regulations 2007. An analysis of the applications processed since 1 September 2009, when the new act came fully into force is below:

- 1.6 With reference to the annual fee the regulations allow scope for the fee to be paid by instalments. This would be at the discretion of the Board. The instalments may be paid in 4 or 12 equal payments over the course of the year following the date on which the fee would otherwise be due.
- 1.7 The next annual review of premises licence annual fees will be presented to Members no later that June 2013, for consideration and determination. This report will be based on a full appraisal of future service requirements following a sustained period of settled operations and an analysis of resource implications following the realignment of the service.

2. **RECOMMENDATION**

2.1 That the Board agrees to adopt the Premises Licences – Annual Fee levels proposed in Appendix 1, with effect from 1 October 2012.
