Depute Provost Black and Councillor A MacDonald, objectors to the application, entered the meeting.

Chief Inspector Cravens and Constable Kane, Central Scotland Police, entered the meeting.

There was submitted Report (circulated) dated 11 November 2009 by the Director of Development Services on an application for the grant of a new House in Multiple Occupation Licence (a) advising of the background to the application; (b) providing confirmation of the premises proposed to be licensed under the terms of the licence; (c) outlining the supporting documentation which was required to be submitted in support of the application; (d) detailing the consultations undertaken and responses received, and (e) attaching as appendices to the Report, location plan together with schedule of matters issued by Central Scotland Fire and Rescue Service.

### CL56. APPLICATION FOR THE GRANT OF A NEW TAXI DRIVER LICENCE

The applicant, Mr C, entered the meeting.

Chief Inspector Cravens and Constable Kane, Central Scotland Police entered the meeting.

There was submitted Report (circulated) dated 11 November 2009 by the Director of Development Services on an application for the grant of a new Taxi Driver Licence (a) advising that the applicant, Mr C, had been invited to sit the Council's taxi knowledge test on four occasions and that he had failed to achieve the prescribed pass mark of 85% on two of these occasions; (b) intimating that the applicant was unable to sit the knowledge test on 16 September due to his late arrival at the test centre and that he had been unable to attend on 21 October; (c) informing of the consultations undertaken and responses received, and (d) confirming the applicant's record.

Chief Inspector Cravens spoke in amplification of the Police's objection, a copy of which had been circulated to the Committee.

Mr C, spoke in support of his application.

Questions were then asked by Members of the Committee.

**AGREED** that a short adjournment take place to enable the Committee to consider the submissions.

The applicant, Mr C, Chief Inspector Cravens and Constable Kane left and were then recalled to the meeting.

**AGREED** to **REFUSE** to grant the application in terms of the Civic Government (Scotland) Act 1982, Schedule 1 paragraph 5(3)(a)(ii) on the basis that the applicant was not a fit and proper person to be the holder of the licence.

#### CL57. APPLICATION FOR THE GRANT OF A NEW TAXI DRIVER LICENCE

The applicant, Mr R, entered the meeting.

There was submitted Report (circulated) dated 11 November 2009 by the Director of Development Services on an application for the grant of a new Taxi Driver Licence (a) advising that the applicant, Mr R, had been invited to sit the Council's taxi knowledge test on three occasions but had failed to achieve the prescribed pass mark of 85%, and (b) detailing the consultations undertaken.

Mr R, spoke in support of his application.

Questions were then asked by Members of the Committee.

#### **AGREED:-**

- (1) that the applicant be given a final opportunity to take and pass the knowledge test, and thereafter provide evidence that he has passed the Council's medical test and to remit thereafter to the Director of Development Services to grant the application, subject to standard conditions, and
- (2) should the applicant fail either test, to authorise the Director of Development Services to refuse the application without further reference to Committee.

#### CL58. APPLICATION FOR THE GRANT OF A NEW TAXI DRIVER LICENCE

The applicant, Mr C, was not in attendance.

There was submitted Report (circulated) dated 11 November 2009 by the Director of Development Services on an application for the grant of a new Taxi Driver Licence advising that the applicant, Mr C, (a) had failed to achieve the prescribed pass mark of 85% for the Council's taxi knowledge test held on 10 September 2009, and (b) had been invited to retake the knowledge test on two further occasions but had failed to attend.

**AGREED** to **REFUSE** to grant the application in terms of the Civic Government (Scotland) Act 1982, Section 13(5) on the grounds that the applicant, having failed to pass the knowledge test, has failed to satisfy the authority that he has adequate knowledge of matters raised therein.

#### CL59. APPLICATION FOR THE GRANT OF A NEW TAXI DRIVER LICENCE

The applicant, Mr C, entered the meeting.

There was submitted Report (circulated) dated 11 November 2009 by the Director of Development Services on an application for the grant of a new Taxi Driver Licence (a) advising that the applicant, Mr C, had been invited to sit the Council's taxi knowledge test on three occasions but had failed to achieve the prescribed pass mark of 85%; (b) detailing the consultations undertaken and responses received, and (c) confirming the applicant's record.

- (2) should the applicant fail either test, to authorise the Director of Development Services to refuse the application without further reference to Committee.

The applicant, Mr T, Chief Inspector Cravens and Constable Kane left and were then recalled to the meeting.

**AGREED** to **REFUSE** to grant the application in terms of the Civic Government (Scotland) Act 1982, Schedule 1 paragraph 5(3)(a)(ii) on the grounds that the applicant is not a fit and proper person to be the holder of such a licence.

- The proposed renovation of the existing bar area to include a communal seated area, kitchen and laundry facilities
- The necessity to provide tables for residents within the proposed kitchen area
- The occupancy rates for the existing HMO licensed area
- The gender of occupants housed under the current HMO licence
- The information provided to residents in relation to fire safety procedures
- The location of fire exits within the premises
- Clarity on the necessity for an additional HMO licence
- The definition of HMO establishments
- The status of residents accommodated within the HMO, Hotel and 3<sup>rd</sup> floor accommodation
- The minimum requirements under the HMO legislation in respect of toilet facilities
- The emergency lighting within the second floor corridor
- The installation of self closing fire doors

Mr D, replied addressing the issues raised.

The Convener concluded by thanking the parties for their attendance and advising that the application would be determined at the next meeting of the Civic Licensing Committee to be held on 13 January 2010.
