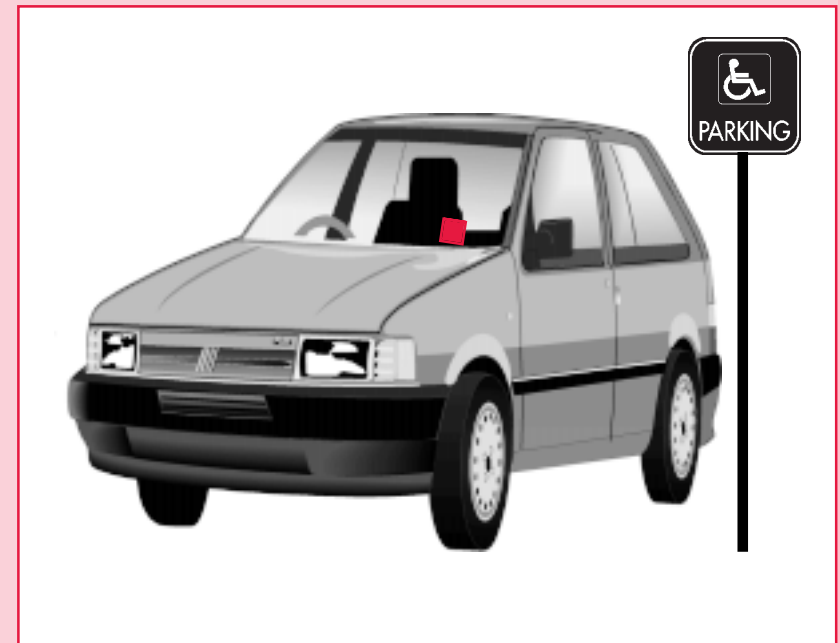

# Red Permit

**Disabled Person's  
Access and Parking Permit**  
*for use in Falkirk High Street*



## What is a Red Permit?

A Red Permit allows you access to certain pedestrianised areas in Falkirk town centre within specified times. It lets you park or be set down and picked up close to the shops without having to walk too far.

## Where and when can I use it?

The Red Permit can only be used in the following places:

**FALKIRK - High Street, pedestrian parts of Cow Wynd, Callendar Riggs and Lint Riggs**

*Daily:* before 11 a.m and after 4 p.m.

Please park sensibly and do not cause any obstructions to other vehicles.

## Can I apply?

You may apply if:

- you are registered blind, or
- you are unable to shop without the use of a wheelchair

## How much does it cost?

A Red Permit costs £5.00 and lasts for a year.

## How do I apply?

Simply complete the Application Form opposite. Enclose two passport sized photographs with the form as a photograph of the holder will now appear on the back of the Red Permit and the other photograph will be kept on file. Then ask your doctor to sign the form and return it to us. You may also be asked to attend an assessment by a Physiotherapist on behalf of Falkirk Council.
