Title: Report on the survey to the future demand for Gaelic

Medium Education in Falkirk Council

Meeting: Education, Children and Young People Executive

1. Purpose of Report

1.1. The purpose of this report is to provide Elected Members with the outcome of the survey exercise undertaken with the parents of children starting their ante pre-school year to determine the future demand for Gaelic Medium Education (GME) in Falkirk.

2. Recommendations

- 2.1 The Education, Children and Young People Executive is asked to:
 - (1) note the contents of this report;
 - (2) agree the proposal set out in paragraph 4.12 below to engage further with parents / carers who have indicated an interest in accessing GME for their children:
 - (3) agree that, should recommendation (2) above be agreed, that the Director of Children's Services be instructed to provide a further report to the Education, Children and Young People Executive Committee; and
 - (4) determine what other actions, if any, officers should be instructed to take.

3. Background

- 3.1. At its meeting on 17 September 2019 the Education, Children and Young People Executive considered a report that detailed the existing arrangements for the delivery of Gaelic Medium Education (GME) to Falkirk's children and agreed that a survey should be undertaken to determine the future demand for GME.
- 3.2. The survey was open from 18 September to 11 October. Parents/ Carers of ante pre-school children attending all of Falkirk's Early Learning and Childcare (ELC) provisions were invited to complete the survey which asked:

- Whether the parent/carer already had a child enrolled in a Falkirk school;
- If the parent/carer would be interested in GME for their child if it was provided within Falkirk; and
- If the parent/carer would be interested in GME for their child if it was provided outwith the Falkirk Council area.
- 3.3. As detailed in the report to the Education, Children and Young People Executive of 17 September there have been around 20 Falkirk children accessing GME across the P1-S6 stages for a number of years.

4. Considerations

Results of the survey

- 4.1. The survey (see attached as appendix 1) was distributed to 885 parent/carers with three year old children attending an ELC provision.
- 4.2. The survey received a 19% response rate (170 out of 885) with responses from 37 ELC settings and nil or no responses from 14 ELC settings.
- 4.3. Of those who responded, 66% already have a child enrolled in a Falkirk school.
- 4.4. 67 parents/ carers out of the 885 who were invited to complete the survey (7.6%) indicated that they would be interested in GME if it were to be provided in Falkirk.
- 4.5. 31 parents /carers out of the 885 who were invited to complete the survey (3.5%) indicated that they would be interested in GME if it were provided outwith Falkirk.
- 4.6. The figures outlined in paragraphs 3.6 and 3.7 above would suggest that there **may** be demand for GME in Falkirk that is greater than long standing uptake figures to access provision.
- 4.7. The survey results are attached as appendix 2 to this report.

Children's Services View of the results of the survey

- 4.8 Given that the survey asked for a simple yes / no response it is difficult to determine how robust these figures are as those responding positively have only been in receipt of information regarding the nature of GME as set out in the survey document. See attached as appendix 1.
- 4.9 Across Scotland, with the exception of Comhairle nan Eilean Siar, Edinburgh and Glasgow Councils GME is usually provided from one central location which necessitates all of the children attending the school to be transported in taxis.

4.10 Other factors, such as continued association with a child's community peer group may also impact a parent / carer final decision regarding whether to access GME provision or not.

Proposed Next Steps

- 4.11 Officers consider that it would be prudent following the completion of this survey for further work to be carried out to seek to establish how many of those who have indicated that they would be interested in accessing GME would retain that interest when they know and understand more about the delivery of GME.
- 4.12 It is proposed that a seminar is arranged for those parents / carers who have at this stage expressed an interest to share more information about GME delivery and to then determine how robust the expressed interest is in accessing GME.

5. Consultation
