Title: Summary of HMI Inspections

1. Purpose of Report

1.1 This report provides an overview of the performance of schools and early learning and childcare settings inspected by Her Majesty's Inspectorate (HMI) and Care Inspectorate between August 2019 and March 2020.

2. Recommendation

The Education, Children and Young People Executive is asked to note the evaluation of each educational establishment.

3. Background

- 3.1 Each year Education Scotland's scrutiny body (Her Majesty's Inspectorate, HMI) inspects and reports on the quality of education in early learning and childcare settings, primary schools, secondary schools and special schools.
- 3.2 HMI reports provide an overall evaluation of the quality of educational establishments. In coming to a judgement HMI will aim to answer three key questions:
 - How good is our leadership and approach to improvement?
 - How good is the quality of care and learning we offer?
 - How good are we at ensuring the best possible outcomes for our learners?
- 3.3 In August 2016, Education Scotland introduced a range of new inspection models to suit particular circumstances and contexts. This enabled them to respond with greater agility and flexibility as key educational policies and priorities are developed. The inspection models introduced from August 2016 were:
 - Full inspection model;
 - Short inspection model;
 - Localised thematic model; and
 - Neighbourhood model.

These inspection models use the Quality Indicators included in:

- How Good is Our School? (4th edition) (HGIOS4), 2015
- How Good is Our Early Learning and Childcare?, 2016
- How Good is OUR School Parts 1 and 2, 2018

There are four reference quality indictors (QIs) in HGIOS4/HGIOELC as part of full inspections. These are aligned to the National Improvement Framework. The four QIs are:

- 1.3 Leadership of Change;
- 2.3 Learning, Teaching and Assessment;
- 3.1 Ensuring Wellbeing, Equality and Inclusion; and,
- 3.2 Raising Attainment and Achievement.

QIs 1.3, 2.3, 3.2 feed directly into the evidence base for the National Improvement Framework.

An evaluation is given for each QI on a six-point scale:

- 6 Excellent
- 5 Very good
- 4 Good
- 3 Satisfactory
- 2 Weak
- 1 Unsatisfactory
- 3.4 Early learning and childcare (ELC) settings are subject to unannounced visits by the Care Inspectorate. There are four quality themes as part of the National Care Standards used to evaluate the quality of provision. They are:
 - Quality of Care and Support;
 - Quality of Environment;
 - Quality of Staffing; and
 - Quality of Management and Leadership.

Settings deemed by Care Inspectorate to be low risk are graded in two of the four standards during a care inspection; the Quality of Care and Support is graded in every inspection.

- 3.5 There are four broad continuing engagement activities that HMI or the Care Inspectorate may select following an inspection, not all of which are mutually exclusive. They are:
 - Area of effective practice;
 - No further inspection activity;
 - Continued engagement for improvement; or,
 - Continued inspection.
- 3.6 HMI and Care Inspectorate Inspection activity ceased in March 2020 during the COVID-19 "lockdown" period. It is anticipated that there will be no formal inspection activity by either organisation during session 2020 2021.

4. Considerations

- 4.1 This report provides an overview of the performance of schools and early learning and childcare settings inspected by Her Majesty's Inspectorate (HMI) and/or Care Inspectorate between August 2019 and March 2020. Full reports are available:

- 4.2 During the period August 2019 March 2020, four primary schools with nursery classes and 1 secondary school were inspected by Education Scotland HMI. 14 early learning and childcare settings were inspected by Care Inspectorate: 11 Nursery classes; 3 Private Partner Providers.
- 4.3 A summary of achievement against the quality indicators for inspections of Falkirk Council ELCs (including private partner providers), primary schools and secondary schools undertaken during the period is shown in **Appendix 1.**
- 4.4 Across Falkirk schools that were inspected during this period, almost all have been graded as good or better across the range of quality indicators.
- 4.5 Across Falkirk ELC settings that were inspected either by HMI or the Care Inspectorate, almost all have been graded as good or better.
- 4.6 Reports from settings where an evaluation of satisfactory or below is given will continue to be taken to Scrutiny Committee.
