## 1. INTRODUCTION

1.1 The purpose of this paper is to update Integration Joint Board members on progress with meeting the national target that no-one who is ready for discharge should be delayed by more than 2 weeks.

## 2. **RECOMMENDATION**

2.1 The Integration Joint Board is asked to note current performance.

## 3. BACKGROUND

- 3.1 As of 15<sup>th</sup> February census date, there were 23 people delayed in their discharge, 14 of whom were delayed for more than 2 weeks. These relate to delays which count towards the national, published delayed discharge target (standard delays).
- 3.2 Trend analysis from April 2015 shows a continuing improvement in the overall performance, over recent months. When compared with the census figures for January 2015, an improved performance can also be seen.


- 3.5 The availability of care homes in Falkirk to support patient's first choice remains limited with ongoing use of Policy on Choice and offer interim places for some patients. Although improving the number and length of delays continues to be challenging with 7 patients delayed for more than 4 weeks and 6 delayed for more than 6 weeks as at 3<sup>rd</sup> March 2016.
- 3.6 The discharge of 4 patients is currently been taken forward under the policy on choice.

#### 4. NATIONAL COMPARISONS


4.1 The following tables show the Falkirk performance alongside other local authority areas in Scotland.


In terms of the performance of the Falkirk partnership this is set against a range of key national performance indicators. The graphs outlined below provide a comparison of performance relating to the total number of delays over 3 days and the annualised rate of bed days lost as a rate per 1,000 over 75 population, broken down by each Local Authority area.

The majority of delays of delays more than 3 days (59.7%) are attributable to five partnership areas.

# 5. PROGRESS WITH ACTIONS

5.1 Work is ongoing to progress the actions included in the Delayed Discharge Action Plan which was considered by Board members at the February meeting. Action Plan progress updates will be provided on a quarterly basis to the IJB, however progress of note since the last meeting includes the ongoing implementation of Closer to Home (including Alfy); the establishment of a planning group to take toward AW1/Power of Attorney campaign and ongoing work to analyse key points in the patient pathway.
