It now therefore agrees to reinstate the funding for the Shelter and to work with partners and the wider community on the sustainability of the facility for the foreseeable future.

However Council are aware that Police Scotland is still insisting that they will withdraw their funding. If this is the case we reaffirm that Falkirk Council will not take over the responsibility

for the duties and powers placed upon Police Scotland in relation to stray dogs should they withdraw from the Partnership;

- (4) agrees to continue to work with our partners and the wider community on the sustainability of the Bandeath dog shelter; and
- (5) also agrees to write to the Chief Constable, Phillip Gormley and Justice Minister, Michael Matheson, asking them to intervene on the decision by Police Scotland of its intention to withdraw its funding.
