1.0 INTRODUCTION

- 1.1 Falkirk Council is leading the multi-million pound regeneration scheme for Denny town centre. The regeneration of Denny Town centre is a key component of Falkirk Council's town centres regeneration strategy. Following extensive community consultation, Phase 1 investment of Denny town centre commenced April 2015 with completion of the new two storey building with retail units and a new library and extensive car parking completed on November 2016. Work on the next phase has now commenced to bring a new town square, completed car park and the introduction of 5 public art installations.
- 1.2 The Denny Public Art project was established within the context of Falkirk Community Trust Public Arts Strategy and the strategy for the economic development of the area. Informed by a year-long period of community engagement, five broad themes were identified to direct the development of the public art during the regeneration period. These themes were - Activity: Trade: Networks: Heritage: Environment. The themes are expanded upon fully in the Denny Public Art Plan 2015/17, together with strategic objectives for each theme. This suggested opportunities that help illustrate the range of potential approaches for public art development within each theme, respectively. The ideas, proposals and creative vision were presented to the community on Thursday 12 March in Denny Primary School and looked at the 5 proposed interventions for permanent artworks, each requiring the appointment of an artist to further develop the proposals with the local community. The five commissions are:
 - 1. The Picture House (way-finding and light projection)
 - 2. The Treasure Trail (small sculptural interventions across the site)
 - 3. The Railings (sculptural and interactive)
 - 4. The Staircase (a visual feature)
 - 5. The Lazy Corner
- 1.3 Creative Scotland is the national organisation that funds and supports the development of Scotland's arts, screen and creative industries.

 Creative Scotland has four objectives: to develop and sustain a thriving environment for the arts, screen and creative industries; to support excellence in artistic and creative practice; to improve access to and

- participation in arts and creative activity; and to deliver our services efficiently and effectively.
- 1.4 Through Creative Scotland, 5 advertisements were posted for 6 weeks and invited experienced public artists to submit their ideas on how they would contribute to the re-imaging of Denny Town Centre through the creation of a public art piece for the new town square. For each of the five commissions an artist(s) are required to work with the community to develop and deliver an artwork for the locations identified, addressing the specifications outlined in the brief.
- 1.5 A community panel was established to conduct short-leeting and interviews; with representatives from the local business community, Denny and Dunipace Community Council, Denny High School, Denny and District Heritage Group, Falkirk Council and Falkirk Community Trust (Cultural Arts) all involved.

2.0 SUBMISSIONS RECEIVED

- 2.1 Nine Public Artists submitted detailed submissions under the terms of the Project Brief. All of the artists were interviewed following a two day long process involving members of the local community panel and Falkirk Council and Falkirk Community Trust.
- 2.2 The decisions taken on the submissions were as follows:-
 - 1. The Picture House (Way-Finding and light projection) further information requested, (£42,000).
 - 2. The Treasure Trail (small sculptural interventions across the site)
 Joseph Ingleby, (£36,000).
 - 3. The Railings (sculptural and interactive) David Annand, (£38,500)
 - 4. The Staircase (a visual feature) Bespoke Atelier, (£25,000).
 - 5. The Lazy Corner Blair Cunningham, (£36,000).
- 2.3 Only one submission was received for the Way-Finding project and the panel invited the artist to provide further information at a second interview. Prior to the second interview the artist withdrew their submission due to other work commitments.
- 2.4 A second advert was placed for the Way-Finding project on 21 September for 2 weeks. Three submissions were received and the panel interviewed all three artists on 9 November 2016. The panel unanimously agreed to appoint James Buchanan for the Way-Finding project at a cost of £42,000.

2.5 Members will be aware that Contract Standing Orders do not apply to contracts for the engagement of the services of artists.

3.0 CONSULTATION

3.1 The artists are now fully engaged with the community to further develop their ideas for each of the 5 commissions underway through on street discussions, school and other community group visits and workshops. A Meet the Artists event took place in Denny Library on 12 January from 3pm-8pm. Visitors were encouraged to share their ideas, memories and aspirations for the public art pieces with each of the artists. Very positive comments were recorded by each of the artists. A public presentation of the final design ideas will be made in April 2017.

4.0 ACTION TAKEN

4.1 Members to note that proposals submitted by the artists indicated in section 2 of this report have been accepted.

1. Introduction

1.1 A new two year contract has been awarded to Order of Malta Dial-a-Journey (OMDAJ) to manage the Shopmobility service. The new contract will expire on 31 March 2019.

1.2 OMDAJ is a registered charity based in Stirling but operates the Falkirk door to door accessible transport service for people who have difficulties in accessing conventional public transport.

2. Background

- 2.1 The shopmobility service hires out manual and electric wheelchairs to provide assistance to people with mobility problems that wish to access the town centre. The service is located at Callendar Square, Falkirk.
- 2.2 The service is currently managed by OMDAJ at a cost to Falkirk Council of £53,000 per annum. The costs of the new contract would be fixed at £53,000 for 2017/18 and £53,000 plus inflation for 2018/19.

3. Procurement

- 3.1 The Shopmobility service is considered to be a Health & Social Care contract falling within Schedule 3 of the Procurement Reform (Scotland) Act 2014. This would permit under certain conditions an award of contract without a call for competition.
- 3.2 Considering the estimated value of the contract, the benefits to people who use the service issues of continuity and the lack of market interest shown in previous competition for the Provision of Accessible Transport Services, it was been determined that best value would be obtained through a direct award of contract to OMDAJ to manage the shopmobility service at an estimated value of £53,000 for 2017/18 and £53,000 plus inflation for 2018/19.
- 3.3 This decision is consistent with the Council's Contract Standing Orders 8.9 which states flexibility is required when deciding how to procure contracts for Social and other Specific Services on a case-by-case basis including whether these require advertising and competition.

4. Consultation

4.1 Consultation was carried out with service users in November 2016 in relation

to the EPIA which considered changes to the service.

4.2 Essentially people were satisfied with the current service in the current location as it was the most accessible for users coming into the town centre by

bus and car drivers found it convenient to park in Callendar Square car park.

4.3 Service users found it accessible, affordable, with a good quality of chairs and

were satisfied that it is open 6 days a week.

5. Legal

5.1 The Central Procurement Unit and Legal Service have been consulted on the

agreement for a direct award of contract for two years contract without

advertising.

6. Equalities

6.1 The service is not changing so will have no impact on protected groups.

7. Action Taken

7.1 Members note that, in accordance with Standing Order 8.9 I have awarded a

two year contract to the Order of Malta Dial-a-Journey to operate the Shopmobility Service in the sum of £53,000 for 2017/18 and £53,000 plus

inflation for 2018/19.
