The parties hereby agree that in the event of any disputes or differences of opinion arising as to the provisions of these presents or the interpretation hereof such disputes or differences shall be reterred to the Sheriff Principal for the Sheriffdom of Tayside, Central and Fife or such other person as muy be nominated by him and the decision of the Sheriff Principal or his nominee as the case may be shall be final and binding; But the provisions contained in this clause shall be without prejudice to the rights of the First Party to enforce these presents or any provision hereof or any condition of any planning pormission to be granted in respect of the site against the Second Party or anyone deriving title from them;


