LB45. Apologies

Apologies were intimated on behalf of Councillors Black and Buchanan.

LB46. Declarations of Interest

Councillor McLuckie declared a non-financial interest in item LB50, Brian Clark Memorial Hall, Burnside Terrace, Camelon. He is a member of Slamannan Lodge No.227 and, while it is unconnected to the lodge which is the main user of the applicant premises, he considered that this distinction may not be generally understood by the public and consequently stated that he would take no part in the decision making on this application.

Councillor Kerr also declared a non-financial interest in item LB50, Brian Clark Memorial Hall, Burnside Terrace, Camelon. He is a member of Laurieston Lord Mountbatten Lodge No. 298 and, while it is unconnected to the lodge which is the main user of the applicant premises, he considered that this distinction may not be generally understood by the public and consequently stated that he would take no part in the decision making on this application.

LB49. Application for Occasional Licence The Parsonage, Dunmore Park, Falkirk

The Board considered a report by the Clerk to the Licensing Board providing details of an application made in terms of section 56 of the Licensing (Scotland) Act 2005 for an occasional licence as detailed in Appendix 1 to the report for The Parsonage, Dunmore Park, Falkirk.

The Board heard from the applicant's representative in support of the application and in clarification of questions raised by members.

Decision

The Board granted the occasional licence from 1300 hrs on 31 December 2017 until 0100 hrs on 1 January 2018.

The Board agreed to an adjournment at 10.10 a.m. and reconvened at 10.25 a.m. with all members present as per the sederunt, with the exception of Councillors Kerr and McLuckie, in accordance with their earlier declarations.

In the absence of the Convener and Depute Convener, and with the agreement of members of the Board, Councillor Hughes assumed the Chair.

LB50. Application for Occasional Licence Brian Clark Memorial Hall, Burnside Terrace, Camelon

The Board considered a report by the Clerk to the Licensing Board providing details of an application made in terms of section 56 of the Licensing (Scotland) Act 2005 for an occasional licence. The application had been continued from the meeting of the Licensing Board held on 18 October 2017 (Paragraph LB42(a) refers). The report also made reference to the Environmental Health Noise Team monitoring one or both occasional licences granted for the same premises for similar events on 4 and 11 November 2017.

It was noted that an objection had been lodged against the grant of the application, and that the objector, Mr D Malley was in attendance.

The letter of objection, which had been circulated to members at the previous meeting, was made available to members.

The Board heard from Mr Malley in relation to his letter of objection.

The Board then heard from Martin MacNiven, Environmental Health Officer in relation to the results of the noise monitoring exercise undertaken by the Noise Team on the evenings of 4 and 11 November 2017.

Mr MacNiven was heard in response to questions raised by members.

The Board heard from Sergeant Mackenzie, Police Scotland.

The Board then heard from the Licensing Standards Officer.

The applicant's representative was heard in response to the noise issues highlighted by the Environmental Health Officer.

The objector and applicant's agent then summed up.

The Board agreed to an adjournment at 11.05 a.m. and reconvened at 11.20 a.m. with all members present as per the sederunt, with the exception of Councillors Kerr and McLuckie.

Decision

The Board refused the occasional licence application in terms of s.59.6(c) in that granting the application would be inconsistent with one of the licensing objectives, namely preventing public nuisance, and in terms of s.59.6(d), having had regard to (i) the nature of the activities proposed to be carried on in the subject premises; (ii) the location, character and condition of the premises, and (iii) the persons likely to frequent the premises.

Councillors Kerr and McLuckie re-joined the meeting with Councillor Kerr, Convener, assuming the Chair.

LB51. Application for the Provisional Grant of a Premises Licence The Ice Grill Parlour, 222 Grahams Road, Falkirk

The Board considered a report by the Clerk to the Licensing Board providing details of an application for provisional grant of a premises licence.

The Board heard from the applicant's representative in respect of the application and in clarification of questions raised by members.

Decision

The Board granted the provisional premises licence.

LB52. Personal Licence Application - Helena Wotherspoon

With reference to Minute of Meeting of the Licensing Board held on 18 October 2017 (Paragraph LB43 refers), the Board considered a report by the Clerk to the Licensing Board providing details of an application for a Personal Licence submitted in terms of s.72 of the Licensing (Scotland) Act 2005.

The Board heard from Sergeant Mackenzie, Police Scotland.

The Board then heard from the applicant in support of her application and in clarification of questions raised by members.

The Board agreed to an adjournment at 11.55 a.m. and reconvened at 12.10 p.m. with all members present as per the sederunt.

Decision

The Board granted the application for a personal licence.

LB53. Premises Licences - Annual Fees

The Board considered a report by the Consumer Protection Manager providing details of the collection of the annual retention fee for 2017/18.
