1. INTRODUCTION

1.1 The purpose of this report is to present the key messages coming out of Ernst & Young's 2017/18 Annual Audit Report to the Integration Joint Board and the Controller of Audit.

2. **RECOMMENDATION**

2.1 The committee is asked to note the contents of this report and the completed action plan at appendix one.

3. BACKGROUND

- 3.1 The IJB's appointed auditors, Ernst & Young, are required to produce a number of reports as part of their annual audit. The International Standard on Auditing 260 (ISA 260) "Communication of audit matters to those charged with governance" requires auditors to communicate matters relating to the audit of the financial statements to those charged with governance of a body, in sufficient time to enable action. In addition, an annual report on matters of significance that have arisen out of the audit process is required. The Ernst & Young report attached as appendix one covers both these requirements.
- 3.2 As part of the audit process Ernst & Young prepare an action plan which requires management responses. This is also included at appendix one.

4. KEY AUDIT FINDINGS

Audit of the Financial Statements

4.1 The unaudited accounts were considered by the Audit Committee on 25 June 2018 and passed to Ernst & Young by 30 June. Ernst & Young have completed their audit of the financial statements and issued an Auditor's Certificate which is free from qualification.



- 4.2 Following approval by the Audit Committee, the accounts will be signed by the Chair of the IJB and the Chief Officer. This process is in line with the requirements of the Local Authority Accounts (Scotland) Regulations 2014.
- 4.3 There are a number of points to note in respect of the audited annual accounts as noted below:
 - There were no adjusted or unadjusted audit differences arising from the audit.
 - No material issues or unusual transactions were found.
 - No material weaknesses were found in the controls tested as part of the audit work.
- 4.4 A number of improvement actions have been identified as part of the wider scope audit work covering financial sustainability, financial management, governance and transparency and value for money. These have been included in an action plan in appendix one. Four actions have been identified and all have been agreed with management. These actions are:
 - Longer-term budget management arrangements, especially in respect of cost sharing arrangements need to be embedded and agreed between the Partners.
 - Continued work is required to finalise a medium term financial strategy.
 - The pace of integration requires significant improvement.
 - Increased focus is required to address the outstanding actions in the Governance Action Plan, particularly those rated red.

5. CONCLUSIONS

5.1 The audit of the IJB's annual accounts for 2017/18 will be formally concluded following the approval of the accounts. The action plan arising from the audit process has been agreed and will be monitored to ensure completion.

Resource Implications

There are no resource implications arising from the report recommendations.

Impact on IJB Outcomes and Priorities

The production and audit of annual accounts is a statutory requirement of the IJB.

There are no legal and risk implications arising from the report recommendations.

Purpose of this report

In accordance with the Local Government (Scotland) Act 1973, the Accounts Commission appointed EY as the external auditor of Falkirk Integration Joint Board (the IJB) for the five year period 2016/17 to 2020/21.

We undertake our audit in accordance with the Code of Audit Practice (the Code), issued by Audit Scotland in May 2016; Auditing Standards and guidance issued by the Financial Reporting Council; relevant legislation; and other guidance issued by Audit Scotland.

This Annual Audit Report is designed to summarise our key findings and conclusions from our audit work. It is addressed to both members of the IJB and the Controller of Audit, and presented to both IJB management and those charged with governance. After consideration by the IJB, this report is provided to Audit Scotland and published on their website.

We draw your attention to the fact that our audit was not designed to identify all matters that may be relevant to the IJB. Our views on internal control and governance arrangements have been based solely on the audit procedures performed in respect of the audit of the financial statements and the other procedures performed in fulfilling our audit plan.

Scope and responsibilities

The Code sets out the responsibilities of both the IJB and the auditor. We provided details of these in our Annual Audit Plan, which was presented to the audit committee on 16 March 2018. We summarise these responsibilities of the IJB in Appendix A.

Our Annual Audit Plan set out an overview of our audit scope and approach for the audit of the 2017/18 financial statements. We carried out our audit in accordance with the plan. We applied the following level of materiality to our audit:

	Materiality for our audit - no change to that reported in our Annual Audit Plan	£2.0 million
►	Tolerable Error is our materiality applied at an individual account balance - no change	£1.5 million
►	Reporting threshold, set in line with the requirements of the Code – no change	£0.1 million

Financial statement audit

We are responsible for conducting an audit of the financial statements of the IJB. We provide an opinion on the financial statements as to:

- whether they give a true and fair view of the financial position of the IJB as at 31 March 2018 and its expenditure and income for the year then ended; and
- whether they have been properly prepared in accordance with the Local Government (Scotland) Act 1973 and the 2017/18 Code of Practice on Local Authority Accounting in the United Kingdom.

We also review and report on the consistency of the other information prepared and published by the IJB along with its financial statements.

Wider scope audit

Our responsibilities extend beyond the audit of the financial statements. The Code requires auditors to provide judgements and conclusions on the four dimensions of wider-scope public audit. Our audit work over the wider scope audit dimensions compliments our financial statements audit.

Independence

We confirm that we have undertaken client and engagement continuance procedures, included in which is our assessment of our continuing assessment of our independence to act as your external auditor.



Financial statements audit

We [have issued] an unqualified audit opinion on the IJB financial statements.

We have concluded satisfactorily in respect of each of the significant risks and audit focus areas identified in our Annual Audit Plan.

The annual accounts, statement of responsibilities, governance statement and remuneration report were received at the start of the audit fieldwork. We made some suggestions to enhance their overall presentation.

Wider scope audit - key messages

We set out below our key messages in respect of each of the dimensions of public sector audit, along with our overall assessment of each of these in terms of red / amber / green, building on our assessment and recommendations from the 2016/17 audit. We have made four recommendations for management as a result of our work.

The Annual Accounts enables the IJB to demonstrate its accountability for the resources at its disposal, and its overall performance in the application of those resources during the year. They also enable the IJB to demonstrate openness and transparency in its governance and remuneration arrangements.

Financial Statements Preparation 2017/18

Compliance with requirements

The Local Authority Accounts (Scotland) Regulations 2014 (the Regulations) set out the statutory requirements on the IJB in respect to the annual accounts, their availability for public inspection and the consideration and signing by the IJB or a committee with an audit or governance remit.

The IJB complied with the relevant requirements. In particular, the unaudited annual accounts were considered by the audit committee on 25 June, prior to their submission to us and in advance of the deadline of 31 August.

Opinions on matters prescribed by the Accounts Commission

Management Commentary: Required by Regulation 8(2)(a) of the Local Authority Accounts (Scotland) Regulations 2014, under statutory guidance included in Scottish Government Local Government Finance Circular 5/2015. Audit Scotland requires us to read the management commentary and express an opinion on whether the information given is consistent with the financial statements and whether it has been prepared in accordance with the statutory guidance.

We read the management commentary and compared the content against the information in the financial statements and against the statutory requirements. We concluded that the management commentary met the requirements placed on the IJB.

Remuneration Report: Required by Regulation 8(2)(d) of the Local Authority Accounts (Scotland) Regulations 2014. Auditors are required by the Code to audit the disclosures of remuneration and pension benefit, pay bands, and exit packages and express a separate opinion within their independent auditor's report on whether they have been properly prepared in accordance with the Regulations.

Similar to 2016/17, and in accordance with common practice and interpretation, the IJB has included the Chief Finance Officer in the remuneration report, along with the Chief Officer. The remuneration report reflects the change to the Chief Finance Officer role during 2017/18. No material amendments were required to the draft remuneration report.

Annual Governance Statement: Required by Regulation 8(2)(c) of the Local Authority Accounts (Scotland) Regulations 2014. Auditors are required by the Code to report as to whether the statement is consistent with the financial statements and has been prepared in accordance with the Delivering Good Governance in Local Government: Framework (2016)

We reviewed the Annual Governance Statement within the financial statements against the required guidance. We were satisfied that it met the requirements and was consistent with both the governance framework and key findings from relevant audit activity.

Section 3 of this report sets out additional procedures we have undertaken in respect to the Governance and Transparency wider scope audit dimension.

Impact on audit opinion - unqualified opinion on prescribed matters

Other matters

We have not identified any circumstances to notify the Controller of Audit that a statutory report may be required under the Local Government (Scotland) Act 1973. We did not receive any objections to the 2017/18 annual accounts from members of the public.

Audit differences

There are no unadjusted or adjusted audit differences arising from our audit.

Significant risk - risk of fraud in income and expenditure recognition: ISA (UK) 240 requires us to make a rebuttable presumption that the fraud risk from income recognition is a significant risk. In the public sector, we extend that to consider the risk of material misstatements by manipulation of expenditure.

Our overall approach

As set out in our Annual Audit Plan, given the nature of funding to the IJB from the Council or NHS body, we rebutted the assumed fraud risk in respect of the income. For expenditure we associated the risk to the assurance over the existence and occurrence of expenditure incurred by the IJB in commissioning services from the Council and NHS Forth Valley.

What did we do in response to the significant risk?

- We challenged management on how the IJB gains assurance over the expenditure it incurs and the basis of payments it makes to its partner bodies to deliver commissioned services. Management took this on board and ensured that the information presented to the IJB stated clearly the source of information provided by the IJB partners. Reports to the IJB at the year end also made clear that the year end outturn represented the approval by the IJB of the final expenditure incurred in commissioning services from the Council and NHS Forth Valley.
- As part of the year end process, the IJB obtained confirmation statements from the senior finance professional at NHS Forth Valley and Falkirk Council of the spend of their respective bodies on delivering services, and hence their request for payment from the IJB to cover those costs. We obtained a copy of those confirmations and agreed to the source.
- We obtained independent confirmation from the appointed auditor at both Falkirk Council and NHS Forth Valley of the income and expenditure transactions recorded at their respective audit clients. The confirmations agreed the income and expenditure amounts transacted in the year.

What are our conclusions?

Our testing has not identified any material misstatements relating to revenue and expenditure recognition. We did not identify any areas of significant estimation or judgement as part of our audit work in these areas.



Significant risk – misstatement due to fraud or error: As identified in ISA 240, management is in a unique position to perpetrate fraud in its financial reporting because of its ability to manipulate accounting records directly or indirectly by overriding controls that otherwise appear to be operating effectively.

Evaluate the business rationale for any significant unusual transactions	We did not identify any significant unusual transactions outside the normal course of business.

What are our conclusions?	

We are have not identified any material weaknesses in the design and implementation of controls around journal processing. We did not identify any instances of evidence of management override of controls.

There was no disagreement during the course of the audit over any accounting treatment or disclosure. We encountered no significant difficulties in the audit.

Financial management is concerned with financial capacity, sound budgetary processes and whether the control environment and internal controls are operating effectively.

2017/18 financial statements outturn

In our audit plan we highlighted financial management as an audit focus area. The in-year financial reporting highlighted significant budget pressures and the need for ongoing recovery action. At the yearend, the IJB reported a surplus on the provision of services of £1.65 million, as set out below.

Elements of financial management, and our assessment of the IJB's arrangements

Is it clear why budgets have changed during the year, including how income and expenditure have changed since the budget was set at the beginning of the year?

How accurate is financial forecasting?

In June 2017 it was highlighted to the Board that the IJB faced a financial risk in respect of in scope NHS budgets of around £1.5 million. This increased during the year to around £2 million. This was due to both recurring financial pressures and a number of savings included in the 2017/18 budget whose delivery was rated as high risk. The most significant cost pressures facing the Partnership in 2017/18 was in respect of prescribing.

Reports by the Chief Finance Officer considered that achieving financial balance on the NHS side of the budget was unlikely. Efforts were made during the year to address the financial risks, through a financial recovery group, the risk did not reduce but some of the financial pressures changed.

In February 2018 the IJB agreed that the next stage in the budget management process would be to formally agree a cost sharing model for 2017/18. The one year agreement recognised that the Partnership is in a transitional phase with significant structural change anticipated in 2018/19 and 2019/20. It was not until April 2018 that a risk sharing agreement was reached which set out that each Partner would take responsibility for their share of the overspend. At the year end the overspend on budget delegated to NHS Forth Valley was £1.59 million. It was agreed that the general reserves carried forward of £0.21 million would be applied to the overspend and NHS Forth Valley provided additional funding of £1.38 million. The underspend on the budget delegated to Falkirk Council was £0.3 million.

Recommendation 1

Are standing financial regulations comprehensive, current and promoted within the body?

Are there suitably qualified and experienced officials leading the body's finance team?

Financial regulations have been established for the IJB, and these are kept up to date.

In accordance with statutory requirements, the IJB appointed a Chief Finance Officer (CFO). The CFO is employed by Falkirk Council. We are satisfied therefore that the Board has made arrangements for the proper administration of its financial affairs.

	Financial sustainability looks forward to the medium and longer term to consider whether the body is planning effectively to continue to deliver its services or the way in which they should be delivered.

In 2016/17 we concluded that achieving financial sustainability continued to represent a significant challenge for the IJB. While it carried forward reserves into 2017/18, a number of existing budget pressures were known at the time the budget was approved. We also reported that structural change in the upcoming years in how the Partnership operates was needed to meet the budget pressures. Consequently, given the identified financial pressures, and the work required to address these matters, we identified in our Annual Audit Plan this was an audit focus area for the year.

Element	s of financial sustainability, and our assessment of the IJB's arrangements
	We considered whether:
	financial balance has or will be achieved?
	have any short-term financial challenges been identified and addressed through a financial recovery plan?
	How appropriate are the arrangements put in place to address any identified funding gaps?
	2017/18 represented the second consecutive year of non-recurring funding being provided by NHS Forth Valley to meet financial pressures. This represents an increased financial risk to the IJB. In management's view this reflects the ongoing transitional phase of the IJB and that operational management of NHS services had still not transferred to the IJB during 2017/18.
	The IJB has identified that in order to meet increasing demand, in a continually financial constrained environment, will require service delivery changes. Over the period 2016/17 to 2018/19 required savings amount to £11.579 million, £4.289 million of which is required in 2018/19 (excluding Set Aside). This is split between Adult Social Care (£2.615m) and NHS Forth Valley (£1.674m).
	Work only commenced in the summer of 2018 to develop a medium term financial plan, with the intention of reporting back to the Board in the autumn. A key element of the plan will be the identification of sustainable savings through both service change and efficiency.
	The IJB has recognised through its Directions a requirement for the Partners to work with the IJB to support preparation of a medium term financial strategy covering the delegated functions of the IJB.
	Recommendation 2
	Has a reserves strategy been put in place and how does the current level of reserves match that strategy?
	The IJB has the power to hold reserves. There are two main types of reserves which are relevant to the IJB; earmarked reserves and general reserves. A reserves policy and strategy for $2017/18$ was reviewed by the IJB in February 2017. At that time it was agreed to set the maximum level of general reserves at £1.5 million, approximately 0.75% of the budget. However the strategy also stated that general reserves would not be available to the IJB for the foreseeable future. It was agreed that the strategy be reviewed on an annual basis. The reserves strategy is supplemented by the risk sharing agreement between the IJB and its partners, which outlines the approach to use of underspends and how to address overspends as they occur.
	During 2017/18 reserves increased to £6.49 million; £0.3 million represents general reserves and £6.2 million represents earmarked reserves for specific purposes.

Governance and transparency is concerned with the effectiveness of scrutiny and governance arrangements, leadership and decision-making and transparent reporting of financial and performance information. Despite the IJB becoming operational on 1 April 2016 it has not been possible for the Partners to reach agreement regarding the transfer of NHS in-scope services, The pace of integration requires significant improvement. While progress continues to be made, the governance framework requires continued improvement. Plans are established to move the risk management arrangements forward during 2018/19. Internal audit concluded that while reliance can be placed on the IJB's governance arrangements and systems of internal controls, significant progress is required if the IJB is to achieve its strategic objectives and reach organisational maturity.

Governance and transparency

The Board and officers of the IJB are responsible for establishing robust governance arrangements. This includes ensuring effective systems of internal control, including arrangements to safeguard public money, and compliance with applicable laws and regulations.

Is the governance framework sound and are the governance arrangements effective?
Is the Governance Assurance Statement complete and does it reflect key findings from audit, scrutiny and inspection?
Internal audit's opinion for the year concluded that "reliance can be placed on the IJBs governance arrangements and systems of internal controls for 2017/18, noting that significant progress will be required in 2018/19 if the IJB is to achieve its strategic objectives and reach organisational maturity." In particular, the report noted a number of ongoing areas of challenge the IJB is facing around its governance arrangements and partnership working, which require continuing improvement to allow the IJB to move towards its strategic objectives.
We reviewed the Annual Governance Statement within the financial statements against the required guidance. While the IJB acknowledges the required governance development areas, they consider that the internal control environment provides reasonable and objective assurance that significant risks would be identified and mitigated. We were satisfied that it met the requirements and was consistent with both the governance framework and key findings from relevant audit activity. This was consistent with the findings of the IJB's internal audit report for the year.



Value for money is concerned with using resources effectively and continually improving services.			
Green	In response to the need to measure performance and progress against the IJB's Strategic Plan, we have concluded that the IJB has identified local improvement goals to measure its performance which are appropriate to the stated national goals. In addition sources of data and information have been identified and reported to the Board.		
	The IJB produced its annual performance report in line with the timeline requirements of the Act.		

Monitoring of performance and achievement of better outcomes for the resources available is key to the demonstration of value for money. Integration joint boards are required under the legislation to prepare an annual performance report by 31 July.

The Board receives a performance report bi-monthly, which focuses on performance indicators, with comparison to available 2015/16 baseline data. The IJB has also prepared a strategy map, which links local IJB Strategic Plan outcomes to national health and wellbeing outcomes, national core indicators and ministerial strategic group integration indicators.

The IJB considered its report for 2017/18 at its meeting on 1 June 2018, which set out how the IJB performed during the year, in particular against local indicators established and benchmarked in 2015/16. Management has noted that while the IJB is demonstrating improvement across a number of indicators, challenges remain across some, with achievement of the emergency department four hour waiting standard dropping 6% year on year.

During 2018/19 work is ongoing to further develop performance reporting, with a performance reporting timetable for the year to be agreed before the end of 2018.

Audit Scotland national performance audit

During the year, management supported completion of an auditor information request which is forming part of the key evidence for Audit Scotland's second Health and Social Care Integration report, along with other evidence such as auditors' annual audit reports and the audited accounts.

The overall aim of this audit is to examine the impact public bodies are having as they work together to integrate health and social care services in line with the Public Bodies (Joint Working) (Scotland) Act 2014.

In particular, the audit will consider the following questions:

- What impact is integration having and what are the barriers and enablers to this change?
- How effectively are integration authorities planning sustainable, preventative and community based services to improve outcomes for local people?
- How effectively are integration authorities (IAs), NHS boards and councils implementing the reform of health and social care integration?
- How effectively is the Scottish Government supporting the integration of health and social care and evaluating its impact?

The report is currently scheduled to publish in November 2018.

Audit Quality

International Standard on Quality Control (UK and Ireland) 1 (ISQC1) requires that a system of quality control is established, as part of financial audit procedures, to provide reasonable assurance that professional standards and regulatory and legal requirements are being complied with and that the independent auditor's report or opinion is appropriate in the circumstances.
