2.1. Day Services

- FVRH have confirmed to JME that work is in progress to install a Changing Places facility agreed by Cathie Cowan. Changing Place toilet will also be installed at Carronbank as part of the refurbishment. Forth Valley College has also made their facility open to the public.
- There has been some redirecting of resources from Bainsford for service users allowing staff to be more creative with care plans allowing service users to be out in the community.

3. STANDING ITEMS

3.1. The inspection report has now been published formally. PC noted how disappointing the downgrade of the service was as there has been a considerable amount of work undertaken as a result of the Homecare Review Group.

PC highlighted that this will have an impact on staff. The Care Inspectorate and service users were happy with the quality of care being delivered. The downgrade in service was due to the percentage of continuing of care being delivered to service users. TU's
