1. INTRODUCTION

1.1 The purpose of this report is to propose a timetable of meetings of the Falkirk Integration Joint Board (IJB) for 2020.

3. PROPOSED MEETING DATES

- 3.1. The IJB Board meeting dates have followed a pattern of meeting on the first Friday of the month at 9.30am, incorporating a recess in July and August. There are alternative meetings for business and Board development.
- 3.2. In reviewing the actual pattern of meetings over the past 3 years, there have been special meetings convened in March and November to mainly accommodate the Council budget setting meetings. These special meetings have been in addition to the agreed set business meetings.
- 3.3. In setting these special meetings, it has been increasingly difficult to accommodate diaries. It also creates additional demands on the Board members. It is therefore proposed to make changes to the meeting cycle to better plan for these known requirements.

- 3.5. The draft forward planner for the Board is attached at Appendix 1. This aims to map out the work of the Board to ensure that all statutory deadlines are met and that reports are considered at an appropriate stage in the financial year. This will be subject to change to reflect emerging priorities and issues.
- 3.6 The Audit Committee approved its programme of meetings and indicative work plan at its meeting on 23 September 2019, however since then new dates are in the process of being identified for June and December. The Clinical and Care Governance Committee approved its programme of meetings on 7 November 2019. The IJB programme of meetings for 2020 is set out in Appendix 2.
- 3.7 The draft Board development programme will be developed, utilising feedback from members and the information in the indicative work plans. The Board may also wish to consider how the involvement of the HSCP Leadership Team and the Strategic Planning Group could be incorporated.
- 3.8 In line with existing arrangements it is proposed that venues continue to be hosted on a rotational basis between the Health Board and Council. Venues will be confirmed once the Board has considered the proposed meeting dates.
