LB54. Applications for Non Minor Variations of Premises Licences

The Board considered a report by the Clerk to the Licensing Board providing details of applications made in terms of section 30 of the Licensing (Scotland) Act 2005 for the non minor variation to the premises licence, namely (1) Maddiston Mini Market, Main Road, Maddiston; (2) Star Inn, 150 Grahams Road, Falkirk; (3) Co-op, Carron Centre, Ronades Road, Carron, and (4) Laing's, 114-116 Main Street, Bainsford.

Maddiston Mini Market, Main Road, Maddiston

The Board heard from the applicant in respect of the application and in clarification of questions raised by members.

Decision

The Board granted the following variations to the current licence, namely:-

- (1) to change the description of the premises to include hot food service counter;
- (2) the addition of hot food to go to be added to the list of any other activities, and
- (3) to amend the layout plan to show the hot food service counter.

Star Inn, 150 Grahams Road, Falkirk

The Board heard from the applicant's agent in respect of the application and in clarification of questions raised by members.

The Board agreed to an adjournment. The board adjourned at 10.20 am and reconvened at 10.40 am.

Decision

The Board granted the following variations to the current licence, namely:-

- (1) to amend the specific condition to "There must be no live amplified music except on Fridays and Saturdays until 10.30 pm and on Sundays until 7.30 pm between 19 December 2019 and 23 June 2020".
- (2) increase the approved on-sales operating hours as follows:

Sunday 1100 hrs until 12 Midnight

(3) increase the approved off-sales operating hours as follows:

Sunday 1100 hrs until 2200 hrs

Co-op, Carron Centre, Ronades Road, Carron

The committee heard that the additional paperwork has been requested from the applicant and this will be provided for the next Licensing Board on 12 February 2020.

Decision

The Board agreed to continue the application to the next meeting of the Licensing Board to allow the applicant an opportunity to submit further information requested by the Board.

Laing's, 114-116 Main Street, Bainsford

The Board heard from the applicant in respect of the application and in clarification of questions raised by members.

Decision

The Board granted the variation to the current licence, to increase the approved off-sales operating hours to Monday to Sunday 1000 hrs until 2100 hrs.
