1. BACKGROUND / PURPOSE OF REPORT

- 1.1 The purpose of this report is to seek a decision by the Committee on the response by the Council to the appeal which has been submitted by the applicant.
- 1.2 This application is subject to an appeal to The Scottish Government Planning and Environmental Appeals Division (DPEA) on grounds that the application was not determined within statutory timescales and is therefore considered as a deemed refusal of planning permission. The initial response by the Council to the DPEA explained the reasons why the determination date was not met and that the application is to be considered by the Planning Committee, seeking an indication of the decision the Committee would have been minded to make.
- 1.3 The purpose of reporting the application to the Planning Committee is to seek agreement on the planning authorities response to the DPEA in respect of the appeal in accordance with the requirements of Regulation 4 of The Town and Country Planning (Appeals) (Scotland) Regulations 2013. Once agreed this will be submitted to the DPEA. The deadline for submissions was 6 December 2019, however this meeting is the first one available for Members to consider matters. As the response will be outside the statutory period, the Reporter is not obliged to take it into account, but in practice late responses by the planning authorities are generally taken into account.

- 1.4 It should be noted that an accompanied site inspection was undertaken by the Reporter on 8 January 2020. This was also attended by a number of objectors, representatives of Falkirk Council and applicant. No discussions on the merits or otherwise of the proposal took place.
- 1.5 The application site comprises of a waste transfer facility at the former Craigend Brickworks at the north side of Boxton Road, north of Standburn. The use of the site as a waste transfer station is approved under the terms of planning permission P/08/0086/FUL detailed in section 3 of this report.
- 1.6 The application proposes the removal of condition 7 of planning permission P/08/0086/FUL which restricts the import of materials to the site to inert construction waste materials only. This condition reflected the extent of development proposed by the applicant at that time. Consequently, no details of any other materials had been included in the application. A copy of planning permission P/08/0086/FUL is appended to this report.
- 1.7 The application is supported by a statement of case that the condition does not meet the tests of Circular 4/1998 "The Use of Conditions in Planning Permissions".
- 1.8 The applicant has also submitted supporting statements confirming that there is no increase in the number of vehicle movements or tonnage of material to be recycled in addition to that approved under the terms of planning permission P/08/0086/FUL.
- 1.9 The applicant has confirmed that no asbestos containing materials would be imported to, and processed at, the application site. The applicant does not consider that the proposal constitutes Environmental Impact Assessment (EIA) development.

2. REASON FOR COMMITTEE CONSIDERATION

- 2.1 Prior to the appeal against non-determination to the DPEA the application was referred to Committee by Councillor Hughes for the following reasons.
 - significant possibility of harm being caused to the land, significant possibility of harm being caused to the water environment through pollution; significant possibility of long term risk to human health and the environment posed by contamination of the land, and that the proposal could have the likely effect of decreasing the amount of open space, reducing the value of biodiversity. A Strategic Environmental Assessment (Scotland) Act 2005 should be carried out. (Note: SEA applies to development planning, so it is assumed this was intended as a reference to Environmental Impact Assessment under the Town and Country Planning (Environmental Impact Assessment) (Scotland) Regulations 2017.
- 2.2 The application was also called in by Councillor McLuckie to allow consideration by committee give the high number (849) of representations received.
- 2.3 As stated at paragraph 1.3, this meeting of the Planning Committee is the first one available following the submission of the appeal.

3. SITE HISTORY

- 3.1 A planning application (F/98/0014) for the use of land for the exploration and production of methane gas at land adjacent to the application site utilising the application site access road was granted on 31 March 1998.
- 3.2 A planning application (P/08/0086/FUL) for the formation of a waste recycling facility to recycle inert construction waste was granted on 22 May 2009.
- 3.3 A planning application (P/13/0438/PPP) for the conversion of and alteration to a derelict building to form a dwellinghouse was refused on 18 November 2013.

4. CONSULTATIONS

- 4.1 Falkirk Council's Roads Development Unit have not objected to the proposal. It is noted that no additional traffic movements are proposed. Additional traffic movements could not be supported without further details being submitted or further assessment being undertaken.
- 4.2 Falkirk Council's Environmental Protection Unit have advised that contamination can be addressed by condition. Air quality and construction noise informatives are also advised.
- 4.3 The Scottish Environment Protection Agency (SEPA) have raised no objection. SEPA have clarified their range of powers with respect to controlling any potential environmental impacts. See sections 7c.29 – 7c.30 of this report.
- 4.4 The Coal Authority advise that the proposal raises no issues relating to risk from historic mining activities.

5. COMMUNITY COUNCIL

- 5.1 Objections have been received from Maddiston Community Council, within whose area the site lies, and also from Avonbridge and Standburn Community Council, Shieldhill and California Community Council and Reddingmuirhead and Wallacestone Community Council. The salient issues are summarised below as follows:-
- 5.2 The proposal would increase the numbers of HGV vehicles on the road network. The road network cannot accommodate any increase in the number of HGV vehicles using the network.
- 5.3 Condition 7 of planning permission P/08/0086/FUL was imposed to ensure that the environmental amenity of the area was safeguarded. The proposal would be detrimental to the environmental amenity of the area.
- 5.4 The recycling facility would operate excessive hours.
- 5.5 The proposal would result in unacceptable excessive odours in the area.
- 5.6 The proposal constitutes poor waste handling practices.

- 5.7 The applicant's business is to transport and process human and toxic waste. The site is not suitably located to import and process such materials.
- 5.8 The proposal would introduce hazardous waste to the site.
- 5.9 Whilst SEPA are the responsible waste regulatory authority, the Council has a duty of care to the community.
- 5.10 It is noted that in granting planning permission P/08/0086/FUL only the importing of inert construction waste was considered appropriate.
- 5.11 The applicant states that the condition is no longer lawful. However, the condition must have been appropriate at that time and should still be considered appropriate. It is noted that the condition was not challenged at the time planning permission P/08/0086/FUL was approved.
- 5.12 The site has naturalised over the years and therefore the proposal would have a significant detrimental impact on wildlife and habitat.
- 5.13 The amenity and health of the users of the adjacent Falkirk Core Footpath would be compromised. The proposal would constitute a risk to health generally in the area and beyond, particularly to children.
- 5.14 The deletion of the condition would undermine public confidence in the planning regime.
- 5.15 The condition is sound in terms of paragraph 55 of Scottish Planning Policy.
- 5.16 It is not appropriate that the applicant be allowed to self-police the site.

6. PUBLIC REPRESENTATION

- 6.1 In the course of the application, 849 objections were submitted. The salient issues, in addition to issues raised by Community Councils detailed in section 5 of this report, are summarised below:-
- 6.2 The drainage infrastructure is not suitable to accommodate the proposal.
- 6.3 The treatment of human and hazardous waste would cause pollution at the site and have a significant detrimental impact on the water network in the area.
- 6.4 The proposal would result in excessive noise in the area.
- 6.5 The proposal would reduce property values in the area.
- 6.6 The proposal would result in a vermin nuisance in the area.
- 6.7 The proposal would be detrimental to trees in the area.
- 6.8 The proposal would compound problems encountered from existing waste/industrial sites in the area.
- 6.9 The proposal would not accord with the "Review of the Storage and Spreading of Sewage Sludge on Land in Scotland (The Sewage Review) Final Recommendations".

- 6.10 The applicant has failed to accord with conditions of planning permission P/08/0086/FUL.
- 6.11 A footpath formed adjacent to the site is not fit for purpose.
- 6.12 It is noted that objections received included a petition carrying 44 signatories from the 93rd Braes Scout Group raising concerns in terms of the impact on health of transporting and processing human waste.

7. DETAILED APPRAISAL

- 7a.1 The application is not considered to constitute EIA development and therefore does not require an environmental impact assessment to be carried out. This is because the proposal does not fall within any Class of Schedule 1 or 2 of the Town and Country Planning (Environmental Impact Assessment) (Scotland) Regulations 2017.
- 7a.2 Proposals included in Schedule 1 of the Regulations always require an EIA. Paragraph 5 of Schedule 1 refers to installations for the processing and transformation of asbestos and products containing asbestos. As stated at paragraph 1.9 of this report, the applicant's agent has confirmed that no asbestos will be treated at the site. It is therefore considered that paragraph 5 is not applicable.
- 7a.3 Proposals included in Schedule 2 require an EIA where they are likely to have significant effects on the environment. Column 1 of Schedule 2 at paragraph 11(b) refers to installations for the disposal of waste. As the proposal relates to a waste transfer facility rather than an installation for the disposal of waste on the site, it is considered that paragraph 11(b) does not therefore apply.
- 7a.4 The Scottish Government guidance on section 42 applications in Circular 3/2013 "Development Management Procedures states that:
- In determining a section 42 application, authorities may consider only the issue of the conditions to be attached to any resulting permission.
 - If it is considered that planning permission should be granted subject to the same conditions as the previous permission, the Section 42 application should be refused.
- 7a.5 Under section 25 of the Town and Country Planning (Scotland) Act 1997, as amended, the determination of planning applications for local and major developments shall be made in accordance with the Development Plan unless material considerations indicate otherwise.

Accordingly,

7b The Development Plan

The Falkirk Local Development Plan was adopted on 16 July 2015. It includes a number of supplementary guidance documents which also have statutory status as part of the Development Plan. Any policy considerations in terms of the Falkirk Local Development Plan would relate to of the principle of the use. The site has the benefit of planning permission as a waste transfer facility as detailed in paragraph 3.2.

Therefore the policy considerations in respect of the Development Plan are not relevant to the determination of this application.

7c Material Considerations

- 7c.1 The material considerations to be assessed are responses to consultation, assessment of public representations, planning permission P/08/0086/FUL, Scottish Planning Policy, Circular 4/1998 "The Use of Conditions in Planning Permissions" and Circular 3/2013 "Development Management Procedures", Condition of the Site in Relation to Coal Mining Legacy, Planning Advice Note 51 "Planning, Environmental Protection and Regulation", the role of SEPA and the appeal against non determination.

Consultation Responses

- 7c.2 Falkirk Council's Roads Development Unit's comments are noted. However, it is noted that no vehicle movements are proposed in addition to those approved under the terms of planning permission P/08/0086/FUL.
- 7c.3 The comments of Falkirk Council's Environmental Protection Unit (EPU) are noted. EPU has advised that a condition be attached requiring the submission of a contaminated land assessment prior to commencement of development. The proposed development has however been implemented and the principle of development is established. It would be appropriate however that an informative be attached to advise the applicant to notify the Planning Authority if contamination is encountered at any time during operation of the site.
- 7c.4 It is noted that SEPA have not objected to the proposal. The proposal would require to be controlled by SEPA either by means of a waste management licence or under Pollution Prevention and Control (PPC) Regulations.

Assessment of Public Representations

- 7c.5 Concerns raised in terms of the potential impacts of waste transfer on the transport network, odours, noise, public health, wildlife and habitat are noted. However, the application is not made to consider the principle of development and consequently whether the land use of the site is appropriate. The principle of the land use is established under the terms of planning permission P/08/0086/FUL detailed in Section 2 of this report. The application is made solely to consider whether the conditions, and in particular condition 7 of the planning permission are still appropriate.
- 7c.6 The applicant has not provided details of any proposed materials to be imported to the site should condition 7 be deleted. The applicant states that the planning authority is not the regulatory authority and such detail is not a material consideration to what is proposed. For clarity, there is no evidence to support the view that the applicant intends to import human, toxic or hazardous waste to the site.
- 7c.7 SEPA are the regulatory body in terms of the control of materials which can be imported and treated at the application site *and any potential environmental impact*. . The applicant would not be self-policing the site. The role of SEPA is detailed in paragraphs 7c.29 and 7c.30.
- 7c.8 The Sewage Review is a European initiative which to date has not been implemented. Should it be implemented, SEPA would be responsible for additional controls currently under the Environmental Protection regime.

- 7c.9 Paragraph 55 of Scottish Planning Policy refers to the initiative for Planning Authorities to consider the views and experience of communities in the preparation of Development Plans. Paragraph 55 does not refer to the Development Management process.
- 7c.10 Planning permission P/08/0086/FUL has been implemented. Conditions requiring to be met prior to commencement of development were complied with. All other conditions are operational conditions.

Planning Permission P/08/0056/FUL

- 7c.11 For clarity, condition 7 of the planning permission was considered appropriate at the time of determination as it was only the treatment of inert construction waste proposed. It is not the case that other types of material were considered inappropriate, but as it was proposed to solely import inert construction material, no other type of materials were assessed.
- 7c.12 The site is not currently operational and the waste management licence issued by SEPA was surrendered on 22 April 2014.
- 7c.13 Previously installed wheel washing equipment has been removed from the site and chain link perimeter fencing is no longer in place, although the fence posts remain. It is considered that there has been a temporary discontinuation but not an abandonment of use.
- 7c.14 In relation to the matter of abandonment, planning case law has established four main considerations to be taken into account: the physical condition of the land/building; the length of time not in use; whether there has been any other use; and evidence of the owner's intentions. There is evidence of some vandalism (graffiti) on buildings on site, and although perimeter fencing is not in place, the site is secured by a locked entrance gate. There is no evidence that the condition of the site or buildings within it have deteriorated to the extent that it could be considered as abandoned. The site has not been operational for a number of years, however this does not in itself point towards the use being abandoned. There has been no other use of the site and there is no evidence to suggest any intention to use it as anything other than a waste recycling facility: These factors again indicate that there has been a temporary discontinuance rather than any abandonment of use.

Scottish Planning Policy

- 7c.13 In terms of "Planning for Zero Waste" paragraph 188 of Scottish Planning Policy (SPP) prescribes that "In determining applications for new installations, authorities should determine whether proposed developments would constitute appropriate use of land, leaving the regulation of permitted installations to SEPA.
- 7c.14 Under the terms of SPP it is clear that Scottish Government prescribe that SEPA are the regulating body for the operation of waste transfer facilities such as the application site, and that the Planning Authority should restrict consideration to the appropriateness of the land use. In this case the principle of the land use is established under the terms of the implemented planning permission P/08/0086/FUL, and is not a relevant issue in this application.

Circular 4/1998 “The Use of Conditions in Planning Permissions”

7c.15 Circular 4/1998 sets out six tests for planning conditions. Conditions must meet all six tests. The tests are:-

- Necessary
- Relevant to Planning
- Relevant to development permitted
- Enforceable
- Precise
- Reasonable in all other aspects

7c.16 Since the adoption of the SPP in 2014 and the prescribed clarity of regulatory authority, condition 7 does not now meet the terms of the Circular as the consideration of type of material falls to the regulatory regime of SEPA and is not relevant to planning.

7c.17 Furthermore, paragraph 13 of the Circular, relating to need for conditions, prescribes that in cases where an applicant has made application to develop without compliance with a condition under Section 42 of the Town and Country Planning (Scotland) Act 1997 as amended, “a condition should not be retained unless there are sound and clear-cut reasons for doing so”.

7c.18 Under the terms of the Circular, condition 7 is considered to regulate matters outwith the scope of planning control as it falls within the remit of SEPA and there are no sound or clear-cut reasons why it should be retained.

Circular 3/2013 “Development Management Procedures”

7c.19 The effect of granting planning permission for a Section 42 application is such that a new and separate permission exists for the development or with different or no conditions attached. The previous planning permission remains unaltered.

7c.20 In determining a Section 42 application, authorities may consider only the issue of the conditions to be attached to any resulting permission.

7c.21 If it is considered that planning permission should be granted subject to the same conditions as the previous permission, the Section 42 application should be refused.

7c.22 Planning authorities should attach to the new permission all of those conditions from the previous permission, where it is considered they remain relevant and should apply.

7c.23 For clarity, notwithstanding condition 7, it is considered that conditions of planning permission P/08/0056/FUL were met and confirmed in writing as required. There is no evidence of any breach of the planning permission whilst the site was operational. Amendments to or deletion of conditions are now considered appropriate. The decision of the Supreme Court in London Borough of Lambeth v Secretary of State of Housing, Communities and Local Government and others (2019) UKSC 33 confirms that a section 42 decision can grant permission relating to a development already carried out. In those circumstances, the Supreme Court confirmed that it is not appropriate to refer to a time limit for commencement.

Condition of the Site in Relation to Coal Mining Legacy

- 7c.25 The application site falls within or is partially within the Development High Risk Area as defined by the Coal Authority. It is recognised that flexibility and discretion are necessary parts of the planning system and as such there may be exemptions to the requirement for a desk based Coal Mining Risk Assessment within the Development High Risk Area.
- 7c.26 Exemption can be on the grounds of the type of application or the nature of development. Only one of these needs to be met to exempt the need for a desk based Coal Mining Risk Assessment and also the consequential need for the Council to consult the Coal Authority. This proposal is considered to fall into one of these exempt groups.
- 7c.27 Where planning permission is to be granted, an appropriate informative note appears on the Decision Notice.

Planning Advice Note 51 “Planning, Environmental Protection and Regulation”

- 7c.28 PAN51 describes SEPA’s duties with respect to pollution control. It is described that SEPA’s pollution control measures shall be “exercisable for the purpose of preventing or minimising, or remedying or mitigating the effects of pollution of the environment”. The Pollution Prevention and Control Act 1999 and the Pollution Prevention and Control (Scotland) Regulations 2000 form the basis of SEPA’s licensing powers for industrial activities.

Comments from SEPA About Their Role

- 7c.29 SEPA have the powers to control the type of materials which can be imported and processed at the site, and also the amount of any such materials within the scope of the planning permission.
- 7c.30 Under the terms of a waste management licence, or under the terms of Pollution Prevention and Control Regulations, SEPA have appropriate powers to safeguard the application site in terms of potential environmental impacts including protection of the water environment, dust control, odour control, litter, vermin control and discharge of materials onto the public road network.

7d Conclusion

- 7d.1 This is a section 42 application which relates to an established Waste Transfer facility which is considered to be temporarily discontinued. The issue to be decided is the conditions to be attached to the permission.
- 7d.2 Condition 7 of the planning permission seeks to regulate the type of material which can be imported to the application site for recycling. It is noted that the restriction on material type detailed in condition 7 was considered appropriate when the Council granted planning permission P/08/0086/FUL in May 2009 as it reflected the range of materials specified in the application that was submitted at the time and no other material type had therefore been assessed.
- 7d.3 Scottish Planning Policy makes it clear that SEPA is the regulating authority with respect to the type of material which can be imported and recycled at the site. Accordingly, the condition is now considered unacceptable under the terms of

Circular 4/1998 – The Use of Conditions in Planning Permissions as detailed in sections 7c.15-7c.18 of this report.

- 7d.4 SEPA have the power and regulatory authority to control the impacts of any materials under the terms of a waste management licence or under Pollution Prevention and Control (PPC) Regulations.
- 7d.5 It is for the Planning Authority to consider whether the use of land is appropriate. In this case the use of the land as a waste recycling facility was considered and approved under the terms of planning permission P/08/0086/FUL and this has been implemented. The use of the application site as a waste recycling facility is approved by planning permission P/08/0086/FUL and remains extant albeit the use has been temporarily discontinued.
- 7d.6 It is the sole duty of SEPA to control the type of material which can be imported and recycled at the site.
- 7d.7 In seeking to control the type of material which can be imported or recycled at the site, condition 7 is no longer appropriate and is considered to be unacceptable. Permission should therefore be granted without condition 7 of planning permission P/08/0086/FUL and with conditions considered to now be appropriate.

8. RECOMMENDATION

8.1 It is therefore recommended that the Planning Committee:-

- a. **instruct the Director of Development Services to advise DPEA that this report constitute the Council's note of matters which should be taken into account in determining the planning application.**
- b. **indicate to DPEA that it would have been minded to grant planning permission if it had been in a position to determine this application, subject to the following condition(s):-**
 - 1. **The development hereby approved shall comply with all drawings approved under the terms of planning permission P/08/0086/FUL and forming part of this permission and any other submitted details which have been approved in writing by this Planning Authority unless a variation is required by a condition or a non-material variation has been agreed in writing by Falkirk Council as Planning Authority.**
 - 2. **The proposed development shall not be brought back into use until such times as the wheel washing equipment has been installed and is in operation. Thereafter, the wheel washing equipment shall be kept operational at all times when the site is in operation.**
 - 3. **The development shall not be operational at any time the wheel washing equipment is not in operation, whether for maintenance, repair or any other reason.**
 - 4. **The development shall not be brought back into use until such times as perimeter fencing and gates, details of which shall have been agreed in writing by Falkirk Council Planning Authority, have been fully installed.**

Reason(s):-

1. To ensure that the development is carried out to the satisfaction and approval of the Planning Authority.
- 2-3. To safeguard the interests of the users of the highway.
- 4 To safeguard the environmental amenity of the area.

Informative(s):-

1. In the event that unexpected contamination is encountered, all work on the affected part of the site shall cease. The developer shall notify the Planning Authority immediately, carry out a contaminated land assessment and undertake any necessary remediation works. Work shall not recommence without the prior written approval of the Planning Authority.
2. The applicant shall ensure that noisy work which is audible at the site boundary shall **ONLY** be conducted between the following hours:

Deviation from these hours of work is not permitted unless in emergency circumstances and with the prior approval of the Environmental Protection Unit.

3. The applicant is advised that care should be taken to minimise any air emissions / suppress dust created during operations. The Institute of Air Quality Management (IAQM) provides dust management guidance (<http://iaqm.co.uk/guidance/>) during the construction phase. Odour and dust issues arising from site operation should be minimised and managed via the appropriate SEPA Waste Management Licence.

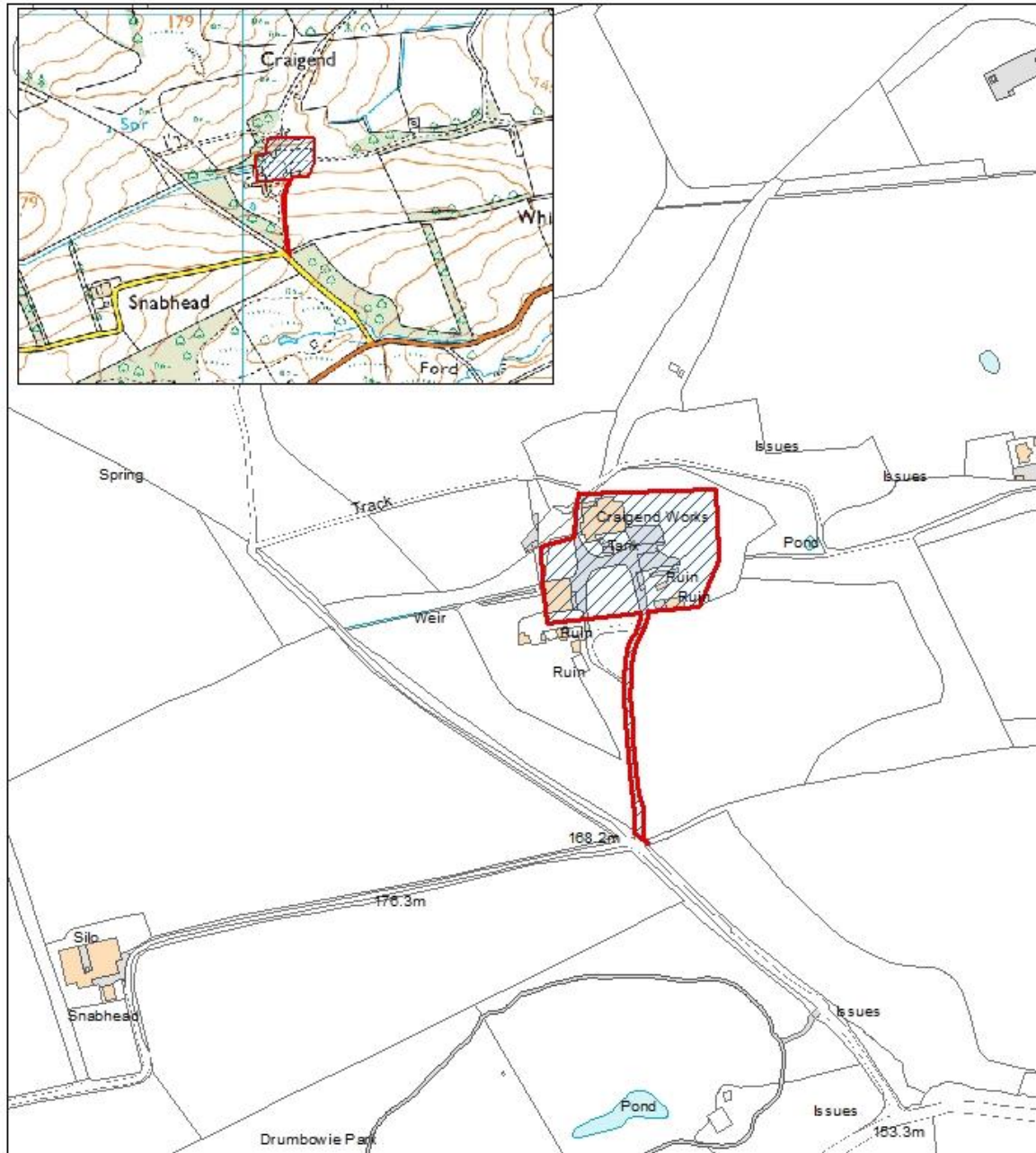

1. The development to which this permission relates must be begun within five years of the date of this permission.
2. All vehicles exiting the site shall use the wheel washing equipment.
3. The proposed development shall not be brought into use until such times as the wheel washing equipment has been installed and is in operation. Thereafter, the wheel washing equipment shall be kept operational at all times when the site is in operation.
4. The proposed development shall not be operational at any time the wheel washing equipment is not in operation, whether for maintenance, repair or any other reason.
5. Prior to the commencement of any work on site in respect of the development, the new footpath link detailed on drawing number 81082/00003, hereby approved, shall be completed with the written approval of the Planning Authority.
6. Prior to the development being brought into use, the perimeter fence shall be completely erected using green coloured materials, or painted green, the shade to be approved in writing by this Planning Authority.

7. The proposed development shall be operated to process, recycle and treat inert construction waste materials only. No other materials shall be processed at the site without the written approval of the Planning Authority.

9. Prior to the recycling facility being brought into operation the site access road shall be widened to a width of 7.3 metres for a distance of 15 metres from its junction with the C53 Boxton Road.

Prior to the commencement of work on site the junction of the B825 Linlithgow to Avonbridge Road and the C53 Boxton Road shall be widened at the applicants expense to a width of 6.5 metres to a minimum distance of 20 metres back from the junction. The survey shall include a statement of measures to be taken to maintain and repair road verges which sustain damage arising from the intrusion of vehicles.
