Summary of Scrutiny Activity – Early Learning and Childcare

Title: Summary of Scrutiny Activity – Early Learning and Childcare
Meeting: Education, Children and Young People Executive

1. Purpose of Report

1.1 This report provides an overview of the performance of early learning and childcare settings that were inspected by Care Inspectorate between August 2020 and September 2021.

2. Recommendation

2.1 The Education, Children and Young People Executive is asked to note the evaluation given to each establishment.

3. Background

3.1 Early Learning and Childcare settings are subject to external scrutiny through inspection by two national bodies: Education Scotland (Her Majesty’s Inspectorate) and Care Inspectorate. The outcome of inspection activity is summarised in reports giving evaluative information and gradings using the 6-point evaluation scale.

3.2 In March 2020, Education Scotland suspended its inspection activity. Education Scotland officers engaged with local authorities and individual settings in support of continuous improvement activity.

3.3 In Falkirk, Education Scotland colleagues supported the delivery of the ELC Quality Associates Programme for senior leaders in the Early learning and Childcare sector. reports provide an overall evaluation of the quality of educational establishments.

3.4 Between April 2020 and June 2021, Care Inspectorate continued to engage in scrutiny work of ELC settings. The focus of this scrutiny work was centred on settings’ work during the pandemic. Care Inspectorate devised a quality indicator for this purpose: Key Question 5: How good is the quality of care and support during the COVID-19 pandemic?

3.5 Scrutiny activity on Key Question 5 took place as follows:

- All settings were required to complete the self-evaluation toolkit on Key Question to support dialogue with Care Inspectors during regular telephone calls.
- A sample of settings across Scotland were asked to submit their completed Key Question 5 self-evaluation for evaluation. Eight settings in Falkirk were sampled as part of this process. All eight of Falkirk settings were given positive feedback with identified areas of effective practice.

3.6 Unannounced 'virtual' inspections were carried out between January 2021 and March 2021 with these moving to a blended model of on-site and virtual inspection activity from April 2021. Three Falkirk settings were inspected as part of this process. Overall evaluations were awarded as follows:

3.7 Care Inspectorate also resumed the previous model of unannounced themed inspections in August 2021. Rannoch ELC Centre so far has been the only setting inspected under this model. Evaluations are as follows:

- Quality of Care & Support Good
- Quality of Environment Adequate

3.8 In addition, and within the same timeframe, Care Inspectorate has been carrying out test inspections of its new Quality Framework. These inspections are also unannounced. Head of Muir is the only Falkirk ELC setting to have participated in this test. No benchmarked evaluations have been awarded during the testing period. Positive evaluative feedback was provided by inspectors, which is helpful in support of continuous improvement.

4. Considerations

4.1 This report provides an overview of the performance of early learning and childcare settings as judged by Care Inspectorate between August 2020 and September 2021. Full reports are available:

4.2 Across Falkirk establishments that were inspected during this period, almost all have been graded as good or better across the range of quality indicators.

- 4.3 Reports from settings where an evaluation with any grade of satisfactory or below will be taken to Scrutiny Committee. Improvement will be monitored closely by central officers and an action plan submitted to Care Inspectorate.
