### **1. Purpose of Report**

- 1.1 This report updates Council on activities related to RIPSA over the past 3 years. The last report was to the Executive on 14<sup>th</sup> May 2019 seeking approval of minor changes to the Council's RIPSA Policy.

### **2. Background**

- 2.1 In limited circumstances, it may be necessary for Falkirk Council employees, in the course of their duties, to make observations of a person in a covert manner (ie without that person's knowledge), or to instruct third parties to do so on the Council's behalf. By their nature, actions of this sort are potentially intrusive and may give rise to legal challenge. The Regulation of Investigatory Powers (Scotland) Act 2000 (known as RIPSA) was introduced to make sure that such surveillance was properly regulated, to ensure compliance with Human Rights legislation. The Council has a detailed [RIPSA policy](#) in place.
- 2.2 The lawful conduct of surveillance under RIPSA requires standard forms to be completed and authorised by relevant officers within the Council. There have been no authorisations since 2018.

### **3. IPCO Inspection**

- 3.1 On 18<sup>th</sup> March 2021, the Council received an inspection from the Investigatory Powers Commissioner's Office (**IPCO**) on the Council's use and governance of RIPSA. Such inspections take place every 3 years. Following a fuller inspection in 2018, this was a "light touch" inspection, conducted remotely over Teams, with the Chief Governance Officer and the Information Governance Manager.
- 3.2 The inspection report was received by the Chief Executive on 6<sup>th</sup> April 2021. In summary:
- The inspector was satisfied with the remote inspection and does not require a physical inspection.
  - At the last inspection in 2018, the Council was subject to 3 recommendations and the inspector was satisfied that these could now be discharged. These related to an update of the RIPSA policy, to annual reporting to elected members on use (or non-use) of RIPSA powers and

guidance being provided to authorising officers on the considerations necessary when dealing with RIPSA applications.

- The inspector highlighted that the use of social media and the internet for surveillance purposes (even purposes falling outwith the RIPSA regime) should be appropriately overseen and audited within all public authorities.
- The inspector stressed the importance of staff training on RIPSA, even if the powers are little-used. There are plans to look to undertake joint training with Clackmannanshire Council for authorising officers, along with officers most likely to undertake surveillance activities.
- The inspector reminded the Council of its obligation to ensure that any surveillance material recovered under RIPSA was kept for no longer than necessary in line with data protection requirements.

### **1. Introduction and Purpose of Report**

- 1.1 Falkirk Council's Contract Standing Orders are in place to ensure that uniform procurement and contracting procedures are laid down for use throughout the Council. All contracts let by or on behalf of the Council are subject to obligations on the relevant Chief Officer to seek Best Value for the Council and to be able to demonstrate fairness and transparency in the procedure followed.
- 1.2 The purpose of this report is to advise Council of decisions taken and contracts awarded since the last Information Bulletin (14 December 2022), in line with paragraph 6.5 of Contract Standing Orders.
- 1.3 Appendix 1 sets out decisions taken to award contracts and to vary or extend contracts in line with the requirements of paragraphs 6.2(i), 6.2(ii) and 15 of Contract Standing Orders.
- 1.4 Appendix 2 sets out decisions taken in respect of contracts awarded through the Public Contracts Scotland Quick Quote facility in line with the requirements of paragraph 8.4 of Contract Standing Orders. Use of the Quick Quote facility is available for contracts for goods and services with an estimated value of below £50,000 and contracts for works with an estimated value of up to £250,000.
- 1.5 This report supports the Financial Sustainability enabler within the Council Plan.
