4. Planning, Place, and the Wellbeing Economy

Place, planning, and wellbeing economy covers a wide range of activities and policies relating to economic development, built environment and climate change. This report set out COSLA's current position and priority workstreams for Members consideration. The report asked Members to consider the interconnected nature of the policies and how placed based working and wellbeing economy are fundamental approaches to achieving a number of Board agreed priorities.

Irene Beautyman from the Improvement Service presented the Board with a short presentation to give Members further information on the work of a Place based working.

Members welcomed the report and requested that in addition could an infographic be created to aid in understanding of the themes within the report. Officers agreed to work with Irene to bring informative diagrams to Members.

Members shared and discussed various examples of the effect and complexity of place had on their communities.

The Board:

- Noted the current place, planning, and wellbeing economy priority areas and their strategic context;
- ii. Commented on the matters discussed in the report, informed the development of the new COSLA Board Plan and the work with stakeholders.

5. Biodiversity Policy

Globally there are two challenges on climate change and biodiversity loss. The implications of these crises on human health and economic wellbeing are profound and require a coordinated response locally and globally. This paper provided an opportunity for the Board to discuss the role which Local Government could play in bringing together work on climate change and biodiversity at the local and national level, with the aim of halting biodiversity loss by 2030 and restoring it by 2045.

Board Members commented that work on biodiversity should cross Local Authority borders and include input from key stakeholders to ensure that resources are best used to fit needs. Members raised that more funding would be beneficial to aid in Local Authority work on this policy area.

The Board:

- i. Noted the current position on biodiversity policy and its strategic context;
- ii. Commented on the matters discussed in the report, to inform the development of the new COSLA Board Plan and our work with stakeholders.

Items for Discussion and Decision

6. The Environment and Economy Board Plan

This paper provided an opportunity for Members to agree, with any changes, the Environment and Economy Board Plan.

The Board was informed that the Board Plan reflected the discussions held at the previous meeting of the Board (7th October 2022) on the introductory items and the overall shape of the document. It was also said that the Board that the Board Plan remained a live document that could be edited at anytime to best fit the needs and priorities of the Environment and Economy Board. A number of points on the Board Plan were clarified and it was suggested that further information on the operation of the RAG indicators would be helpful for the next meeting.

The Board:

- i. Discussed the proposal to identify key workstreams for additional scrutiny as set out in paragraphs 3 and 4;
- ii. Noted the links to priorities of the draft COSLA Plan 2022-2027;
- iii. Agreed, with any changes, the Environment and Economy Board Plan;
- iv. Noted that the Plan can be revised at any time if desired by the Board.

7. International Climate Policy and COP 27

The report provided an update on the 27th session of the Conference of Parties (COP27) to the United Nations Framework for the Convention on Climate Change (UNFCCC), held November 6th-18th in Sharm Sheikh, Egypt.

Board Members discussed the importance for Local Authorities to be recognised and represented as stakeholders at conferences such as COP 27.

Members also stressed that work on targeting Climate Change must include the flexibilities of approach so that it would work for all 32 Local Authorities.

The Board:

- i. Continued to support ambitious global climate action and international processes for climate change and biological diversity;
- ii. Supported the work of the global Local Government constituency, calling for stronger recognition for local and subnational governments in international agreements and in official decisions;
- iii. Reaffirmed shared ambition to combat the clear interlinked challenges of climate change and biodiversity loss, highlighting the need for Local Government to be sufficiently empowered to respond

8. Climate Intelligence Service

This paper provided more information on the development of a climate intelligence service for Local Government. It sought the Board's approval that COSLA continued to engage in the development if the proposal.

Board Members welcomed the report. The collection and use of data was discussed by Members, and the need to avoid duplication. Members raised that work in this area needed to be remain usable, sustainable and run alongside work on climate change for all Local Authorities. Members commented that funding in this area would be key for this work.

The Board was informed that future papers to the Board and Leader would be brought in due course as the proposal developed.

The Board:

- i. Noted the development of the proposal for a climate intelligence service;
- ii. Agreed further work should take place and provided comments which COSLA should take into account.

Public Session

1. Welcome and Apologies

Cllr Kelly welcomed Board Members to this meeting of the Health and Social Care Board.

Cllr Kelly thanked Peter Burke, whom had been the Carers Representative on the Health and Social Care Board for the previous term and the start of the new term, for all his work with the Health and Social Care Board. The Board also thanked Peter for his work, and all wished him well in his retirement.

Apologies were noted separately for the minute.

2. Quality Improvement Framework for Trauma Informed Organisations – Dr Laura James, National Improvement Lead for Trauma, Improvement Service

A presentation was provided by Dr Laura James, the National Improvement Lead for Trauma from the Improvement Service. The presentation was titled "Creating Trauma-Informed Change: What, Why, and How", based on the ongoing joint work of COSLA, the Improvement Service, Local Government, and NHS Scotland on the National Trauma Training Programme.

Members were aware of the ongoing work to maintain a trauma informed and responsive workforce and services across Scotland, with the Board welcoming the presentation and updated provided by Dr Laura James.

Members raised that staff who are trained in trauma-informed working would also be at risk of their work having an effect on their mental health, so would require enhanced support from supervisors and work packages. The hope with the framework that was outlined would be that it's implemented across entire organisations.

The impact of the current cost of living crisis is an area that would need to be considered and the impact it would have. Dr Laura James confirmed that work will be done with stakeholders to ensure that a financial burden is not add to Local Authorities when implementing this training.

The Board noted the update provided by Dr Laura James and thanked her for her presentation.

Private Session

3. Minutes of the Last Meeting and Matters Arising

Board Members agreed the minute of the previous meeting as an accurate record.

There were no matters arising brought to the Board.

4. Health and Social Care Update Paper and Board Workplan

This report presented written and verbal updates on developments which did not require a stand-alone report but should be brought to the Board's attention. This also related to the Board Workplan taken as item 04A.

Eddie Follan provided a verbal to the Board, highlighting that since the last meeting of the Board had been a busy period for the Team. Focus had been placed on current system pressures across the Health and Social Care space, with the Beds announcement on the 11th of January being picked up with Scottish Government colleagues.

Also raised were the areas found within the Workplan highlighted in red, the following updates were provided:

- National Care Home Contract negotiations around areas such as energy, food, sustainability had been difficult, and a report will be taken to COSLA Leaders in March.
- The move from analogue to digital telecare the team hoped that a tender would be ready to be released by the end of January.
- Work with Public Health Scotland (PHS) Officers have gone back to PHS who are to review resourcing within the team.

Board Members discussed issues around rurality and switching from analogue to digital and were assured that each Local Authority has its own agreed plans to best suit the needs of their rural communities.

It was also raised by Members that barriers to the accessibility of IT services should be captured, Officers confirmed that work with Social Work and Scottish Government to ensure that mitigations are taken to ensure there is accessibility for all.

Officers provided an update that no changes thus far had been made to non-residential charging, with work being conducted on what the implications would be if charges were to be removed.

The Board:

i. Noted progress and discussed any emerging issues from the written update provided in this paper.

5. Independent Review of Inspection, Scrutiny, and Regulation

This report provided details on the independent review and asked Members to consider and agree COSLA's response to a call for evidence (Appendix A) and offered positions that Officers could present in their attendance as members of the Practitioner and Stakeholder Panel.

Jennifer Rezendes, from Social Work Scotland joined to provide further information and was available to answer questions the Board had. Members provided Officers with comments for further consideration in this area of work.

The Board:

- Considered and agreed COSLA's response to call for evidence, and the Independent Review; and
- ii. Agreed the position outlined in paragraphs 10 to 12.

6. Data Strategy for Health and Social Care

The refreshed digital health and care strategy, <u>Care in the Digital Age</u>, published in October 2021, made a commitment to develop Scotland's first dedicated data strategy for health and social care. Following a period of consultation from May to August 2022 work has been progressing to develop a draft Data Strategy for Health and Social Care.

This paper set out the current position on the development of this data strategy.

A verbal update was provided by Ruth Griffith, that positive outcomes over the past 10 days, an update was provided on areas that Board Members needed to note.

COSLA Officers assured that all data sharing would be compliant with GDPR legislation.

The Board:

- i. Noted the progress made to date on this draft strategy;
- ii. Commented on the attached draft Data Strategy for Health and Social Care; and
- iii. Agreed that the final draft will be circulated to Board Members for approval.

7. Self-Directed Support Improvement Plan

In 2010, COSLA and Scottish Government jointly published the Self-directed Support Strategy 2010-2020, this was followed by an Implementation Plan for 2019-2020. Given the previous plan has now concluded, officers have engaged with Scottish Government and other key stakeholders to map and develop the next iteration.

This paper provided an update on the development of Self-directed Support Improvement Plan for 2023-2027 and asked for Board Members input and agreement on the overarching outcomes proposed for the plan.

Members welcomed this report, particularly the work on improvement on staff skills and support. Members were supportive of engagement with external stakeholders to encourage the sharing of knowledge and reduce the likelihood of the duplication work. Members also requested that further feedback should be brought back on the difficulties in accessing SDS.

The Board:

- i. Noted the update on SDS Improvement Plan; and
- ii. To agree the position in paragraphs 14 and 15.

8. Suicide Prevention Strategy Implementation and Governance Update

Following the publication of Creating Hope Together <u>Strategy</u> and <u>Action Plan</u> in September 2022, COSLA and Scottish Government officials had been working with stakeholders to develop the governance and delivery infrastructure which would support their implementation. This paper set out the current position.

Members asked about data collection and sharing between stakeholders working in this space could be improved to support. With Members sharing their willingness to pick up work in this area. Member also received clarification on how the Lived Experience panel had been composed and panellists are selected.

Members commented that staff supported in this work, however due to ongoing pressures, implementation had been difficult. Officers commented that local action plans would aid in this area.

The Board:

- Noted the progress towards implementation and delivery of Creating Hope Together; and
- ii. Agreed the approach set out to support delivery and governance.

9. Mental Health Strategy

Following the agreement of COSLA's Children and Young People Board, and discussions at the Health and Social Care Board, COSLA sought to agree with Scottish Government that the incoming Mental Health and Wellbeing Strategy would be a joint COSLA/ Scottish Government strategy. To date these discussions had not been successful and on the 13th of January 2023 the Scottish Government shared a first draft of a Mental Health and Wellbeing Strategy for stakeholder comment.

Members provided comments for Officers to note in their work on the Mental Health Strategy, such as reducing mental health interventions; further investigation in groups within the community at higher risk (in particular children and young people); and the stigma faced by those who work within Mental Health.

Members also expressed their disappointment that Scottish Government did not collaborate in writing this paper. Officers assured Members that they will push for further information that the Board requested.

The Board:

- i. Provided their views on the draft Mental Health and Wellbeing Strategy at Appendix A, particularly indicating whether they were supportive of the high-level outcomes.
- ii. Agreed that COSLA responds to the ask for stakeholder comment on the Mental Health and Wellbeing strategy, including the points at paragraph 10 and informed by the views of the Board and wider Local Government stakeholders.
- iii. Agreed the Health and Social Care Spokesperson sign off the final submission on the Board's behalf.
- iv. Agreed the revised position on the approach to partnership work around the strategy detailed at paragraph 13/14.

Recess called at 12.25pm

Reconvened at 12.30pm

10. Planning with People Updated Guidance

In 2021 Scottish Government and COSLA jointly published community engagement guidance called Planning with People. The guidance included a commitment to undertake a review of Planning with People to ensure alignment with recommendations from the Independent Review of Adult Social Care and gather feedback from users of the guidance.

Integration Authorities, Health Boards and Local Authorities have since provided feedback on the Planning with People guidance. This paper provided Members with an overview of the development and contents of an updated version of Planning with People.

Members raised that focus should be place on certain cohorts within the communities to ensure their needs are met within the updated Guidance.

The Board:

- i. Noted the process of updating the Planning with People guidance; and
- ii. Agreed the proposed COSLA position set out in paragraphs 15 and 16.

11. National Care Service

This report updated the Board on key National Care Service press, public affairs and parliamentary engagement since the previous meeting on 4th November 2022. The report also updated on key decisions taken, including:

- Leaders' agreement to carry forward plans to seek specialist and expert external legal input in relation to the National Care Service Bill's implications for Local Government.
- Leaders' endorsement of a COSLA response to a stakeholder document circulated by the Scottish Government's Mental Health Directorate on the

- inclusion of services for mental health, neurodiverse conditions, and dementia within the National Care Service. (Appendix A).
- Leaders' agreement to call on the Scottish Government to pause current plans for structural change required to set up the National Care Service and redirect funding allocated within the Scottish Budget into social care and preventative services through Local Government.

Members welcomed this report.

The Board:

- i. Noted the decisions taken by Leaders; and
- ii. Provide any views on National Care Service developments and COSLA's press, public affairs, and parliamentary engagement work.

12. National Care Home Contract

The National Care Home Contract rates are negotiated annually between Local Government, care home providers, and Trade Unions with operational management of the contract sitting with Scottish Excel.

This report updated the Board on the 2023/24 NCHC fee negotiations to date, significant financial challenges and risks facing both the sector as well as Local Government which are impacting on the negotiating group's ability to meaningfully progress next year's fee negotiations.

Members were invited to note the update provided in this report and agree to recommend to COSLA Leaders that Officers should continue to work in partnership with the sector representatives to address challenges in relation to sustainability of the sector.

Members asked if any consideration had been given to conducting a best value review of care home commissioning. Officers commented that this would need to be conducted on a local level in the first instance but a national analysis could then be fed back to the Board, in collaboration with Scotland Excel.

Further points raised were on mitigation plans for services that were struggling in the current environment. Officers informed the Board that they would engage with Scottish Government and the sector if failures were to happen within services. Rurality was also an area that was raised to be investigated and impacts of loss of services for rural communities.

Concerns were also raised on funding and the allocation of any funding. Officers provided the update that they were looking at ethical commissioning through a joint working group with Scottish Government. Any updates would be brough back to the Board.

The Board:

i. Noted the update provided in the report; and

ii. Agreed to recommend to COSLA Leaders that Officers should continue to work in partnership with the sector representatives to address challenges in relation to sustainability of the sector.

13. Any Other Competent Business

No other additional competent points of business were noted.

14. Date of next meeting: 10th March 2023

Peter Burke thanked the Board for all the work conducted over his time on the Health and Social Care Board. Peter also wished Members and COSLA Officers all the best in their future endeavours.

12. Education Update- National Discussion, ACEL data and School Census 2022

This paper provided Board Members with an update on the progress of the national discussion on the future vision on Scottish education, which is being co-convened by the Scottish Government and COSLA.

Officers highlighted following further engagement with the Cabinet Secretary and facilitators Professor Campbell and Harris will provide a further update at the March Board meeting.

In terms of school staff numbers, Cllr Buchanan highlighted a Leaders meeting had taken place earlier in the morning and Officers and Spokespeople will continue to work with the Scottish Government on the concerns raised. Leaders had highlighted the importance of focusing on the outcomes and the narrowing the attainment gap as opposed to measuring inputs and outputs. Board Members were in agreement that improving attainment requires support not only from teachers and involved a range of services across Local Government who support children and young people.

Board Members welcomed the update from Cllr Buchanan and echoed concerns raised by Leaders.

- ii. Provided views on the ACEL data, the school census and subsequent correspondence with the Cabinet Secretary.

13. School Meal Debt- Good Practice and Principles

At the meeting of the Children and Young People Board in November 2022, Members agreed that COSLA officers should work with Local Government professional associations to develop a set of good practice principles in relation to the management of school meal debt. This report provided members with a draft of good practice principles for their agreement.

Board Members welcomed the principles, and emphasised the need to ensure it was clear that approaches to school meal debt, including any decisions about writing off debt, remain at the discretion of each local authority. In addition, Members commented that it would be important to prevent additional pressure on staff. Officers agreed with these points and noted that wording would be amended to ensure these points were reflected clearly within the principles document.

Board Members:

i. Agreed the draft good practice principles attached as Appendix 1.

14. Foster and Kinship Care Allowances

This report provided Members with an update on discussions with Scottish Government on the Scottish Recommended Allowance for foster and kinship carers, and with The Fostering Network on the figures they believe should be used as a minimum for foster care allowance.

Board Members highlighted concerns as there had been limited progress due to limited resources and funding not being made available by Scottish Government to meet a Scottish Recommended Allowance.

Board Members:

- Agreed COSLA works with Scottish Government to ascertain whether the rates outlined in The Fostering Network report are more accurate than the Scottish Government's Recommended Allowance
- ii. Agreed COSLA continues to lobby Scottish Government for full funding to deliver on their commitment to a Scottish Recommended Allowance, or if the work detailed in (i) shows that the allowance rate should be higher than this, funding should be sought to deliver this.
- iii. Agreed COSLA officers continue to emphasise the need for coherence of approach to improving outcomes for care experienced children and young people.

15. Unaccompanied Asylum Seeking Children

This paper provided Members with an overview and update on current growing pressures on local authorities regarding the arrival and mandated placement of unaccompanied asylum-seeking children.

Board Members welcomed the update and highlighted concerns over pressures on placements. It was also noted education colleagues are seeking support for expectations of young people over the age of sixteen.

Board Members:

- i. Noted the update on the number of UASC arriving in the UK and Scotland;
- ii. Noted the establishment of a national UASC Taskforce by the UK Government and the associated workstreams that are to be considered; and
- iii. Noted the recommendation to COSLA Leaders to consider the establishing of a short life working group to consider the viability of a Regional Intake Unit in Scotland.

16. Any Other Competent Business

No comments were raised.
