DECLARATIONS
OF INTEREST:

In connection with agenda item CL87, Councillor Kenna stated that she knew the applicant but that the nature of the relationship was not a close one and did not fall within paragraph 5.13 of the Code. She did not consider, therefore, that it gave rise to any declarable interest, standing the terms of the Code of Conduct.

In connection with agenda item CL82, Councillor Waddell stated that he had knowledge of the applicant from a contractual relationship many years ago. While he did not consider that the relationship was one which gave rise to a declarable interest, he nevertheless advised that, in the interests of public perception he would take no part in the item of business.

- (b) that in the event of any further renewal application being submitted, the Director of Development Services will be authorised to grant it only where no further breach of the licence has occurred and no convictions or fixed penalty notices incurred and then only for a period of six months (with subsequent applications reverting to the standard period of one year) which failing, the application will require to be determined by Committee.
