#### FC92. ORDER OF BUSINESS

In terms of Standing Order 15.2(i), Provost Reid varied the order of business from that detailed on the agenda for the meeting. The following items have been recorded in the order that they were taken at the meeting.

#### FC93. URGENT ITEM – APPOINTMENT TO EXTERNAL ORGANISTAIONS

Provost Reid advised that, in terms of Standing Order 9.1, he had **AGREED** to accept an urgent item relating to the membership of the COSLA Convention and COSLA Community Well-being and Safety Executive Group having regard to the special circumstances, viz, forthcoming meetings of COSLA and the desireability of ensuring Falkirk Council representation thereat. This item would be considered following the Report on the Appointment to Central Scotland Joint Fire and Rescue Board and to External Organisations.

## FC96. REGULATION OF DISPLAY OF ELECTION POSTERS

There was submitted Report (circulated) dated 22 February 2010 by the Director of Development Services (a) advising that local authorities, in addition to their specific duties in terms of election law, are also involved in election preparation in their respective capacities as Roads and Planning authorities particularly in relation to display of election material by or on behalf of candidates and/or the political parties they represent; (b) summarising the relevant parts of both The Town and Country Planning (Control of Advertisements)(Scotland) Regulations 1984 and the Roads (Scotland) Act 1984 which deal with the display of election posters; (c) outlining the options available with regard to the display of election posters on Council properties, and (d) attaching as an Appendix to the Report, a copy of the proposed guidelines for the display of election posters on street furniture.

Councillor C Martin, seconded by Councillor Patrick moved that:-

"Council agrees to amend the guidelines on display of election campaign publicity materials to prohibit display of such material on any Council property, including lighting columns, traffic sign poles and street furniture."

By way of an Amendment, Councillor Alexander, seconded by Councillor Coleman moved that:-

"Council notes with surprise that despite the fact turn out at elections is declining New Labour wish to abolish one of the high profile campaigning tools available to local political parties.

Council believes this is due to the haemorrhaging of active members, as reported in the national press, matched by the decline in electoral fortunes of New Labour, and the refusal of the few remaining activists to work for two discredited MP's at the centre of the expenses scandal.

Council therefore reiterates its commitment to encourage as many people as possible to exercise their democratic right to campaign within the political process and believes that all legitimate means of campaigning be allowed including the display of election posters on lamposts and to adopt the guidelines attached as an Appendix to the Report."

On a division 17 Members voted for the Motion and 13 voted for the Amendment.

Accordingly, **AGREED** to amend the guidelines on display of election campaign publicity materials to prohibit display of such material on any Council property, including lighting columns, traffic sign poles and street furniture.

# FC97. AMENDMENT TO POLLING SCHEME - CHANGES TO POLLING PLACES FOR UK PARLIAMENTARY ELECTION 2010

There was submitted Report (circulated) dated 15 February 2010 by the Returning Officer (a) advising that Section 18 of the Representation of the People Act 1983, as amended by the Electoral Administration Act 2006, requires local authorities to keep under review polling districts and polling places; (b) alerting Members to the requirement to review two polling places to be used for the UK Parliamentary Election which will be held in Spring/Summer 2010, and (c) detailing the proposed polling places to be used, namely Tryst Community Centre and Larbert Village Primary School.

# **NOTED** the Report.

**AGREED** to adjust the polling scheme as detailed within the Report and to publicise the changes, with immediate implementation, for polling places at the UK Parliamentary Election in Spring/Summer 2010.

# FC98. APPOINTMENT TO CENTRAL SCOTLAND JOINT FIRE AND RESCUE BOARD AND TO EXTERNAL ORGANISATIONS

There was submitted (circulated) (a) Extract of Minute of Meeting of the Economic Strategy and Development Committee held on 23 February 2010, and (b) Report by the Director of Community Services submitted to the said meeting reporting on the final outcomes of the Action Plan and demonstrating how, with the adoption of the Updated My Future's in Falkirk initiative, its activities will be sustained.

Councillor Mahoney, seconded by Councillor Lemetti, moved the recommendations contained in the Report to the Economic Strategy and Development Committee.

By way of an Amendment and in supplement to the terms of the motion, Councillor Oliver, seconded by Councillor Coleman, moved that:-

"in addition, Committee instructs Officers to prepare an options appraisal to address the lack of progress on the Denny Town Centre Regeneration Project."
