Primary 3 pupils at Easter Carmuirs Primary have

taken on the challenge of organising and creating a calendar as part of their enterprise topic. The pupils decided to create a calendar which would feature every class in the school to celebrate and commemorate the school's Golden Anniversary which took place in March. The pupils set up a company called 'Golden 50' and designed a logo for the company. Each pupil applied for a specific team, listing special skills and qualities. A lot of discussion, teamwork, decision-making and hard work was involved before the final product was ready. The class contacted and were visited by John Watt from Falkirk Council Printworks to discuss the many printing options including size, colour, different ways to bind the book

and the costs associated. This link provided opportunities for the pupils to see how their activity related to the local community, broadening their



perceptions about business and partnerships. The

pupils worked collaboratively to make sure each class had a memorable photograph which corresponded appropriately to the month and were very creative and adventurous when it came to taking the photographs. Printworks allowed some pupils to visit the premises to see the printing job taking place and brought the finished copies back to school.

Many areas of the curriculum were fully incorporated in this enterprising task including literacy, maths, ICT, citizenship and health. The calendar was sold at the school's Golden Anniversary concert and 60s open day and was very popular with many buying multiple copies. The class made an astonishing profit of £157 and are going to spend this money on something to remind us of

our celebrations of the school's 50<sup>th</sup> birthday and the fun we all had during this event.

During the Easter Holidays the Active Schools team coordinated two weeks of free physical activity and sport for children from nursery up to P7. The activities ran at a number of venues across the Falkirk Council area and covered a huge range of sports and physical activity.

At Stenhousemuir Sports Centre the activities included Circus Skills, Mini Olympics, Martial Arts and Dance. These activities were very well attended and were supported by local club coaches and Community Sports Leaders from Larbert High.

There were also sessions at the Grange Centre in Brightons where the activities on offer included Netball and Street Dance. There was Basketball led by Falkirk Fury Head Coach John Bunyan and a Table Tennis Festival with displays from Scottish Junior players. A favourite and highlight of the week was the Street Running session delivered by PE teacher Jennifer Dougall. Luckily for the children the sun was shining and they enjoyed a great outdoor session using the contours of the natural environment and surrounding benches, posts, steps and anything else they could find around the Centre as the course for their Street Running. All of this combined to produce five fantastic days of fun at the Grange Centre.

At Falkirk High, Active Schools made full use of the facilities with almost thirty different activity sessions happening in the second week of the holidays. Highlights included the three day Water Polo competition and Champions League competitions for P3-4 and P5-7 which ran for the whole week. Each day of the Champions League had a theme including Crazy Hair Day, Fancy Dress Day and the Finals Day on the Friday.

In Denny the activities were split between the Sports Centre and Denny High, with activities such as Cheerleading lead by coaches from Falkirk Fusion Cheerleading Club, Ultimate Frisbee and a three day Dodgeball League taking place at Denny Sports Centre and Water Polo sessions taking place at Denny High.


# **Active Schools Dance Stars**

### 1. INTRODUCTION

- 1.1 Sixteen companies notified their interest to tender for the supply of Pesticides as part of a framework agreement to Falkirk Council. This tender was conducted electronically via the Public Contracts Scotland secure "Post Box" facility.
- 1.2 The framework is for an initial period of two years from 1<sup>st</sup> July 2011 to 30<sup>th</sup> June 2013 with an option, if deemed appropriate, to extend for a further period of twelve months from 1<sup>st</sup> July 2013 to 30<sup>th</sup> June 2014.
- 1.3 Expenditure over the full term of the contract, including extension, is estimated to be £100,000.

#### 2. TENDERS RECEIVED

- 2.1 Four tenders were received by the due date of Wednesday 4th May 2011.
- 2.2 The checked tendered prices ranged from £32,136 to £38,358 per annum.
- 2.3 Following evaluation all tenders, as detailed at Appendix 1 were selected onto the framework as offering best value for the Council. It is estimated that by contracting with these 4 suppliers savings in the region of £5,000 per annum will be realised.
- 2.4 The funding for this project is contained within the Supplies and Services budget heading.

#### 3. CONSULTATION

3.1 In accordance with Standing Order 6.2(ii) the approval of the Acting Director of Law and Administration to enter into this framework agreement was sought and received.

#### 1.0 Introduction

1.1 The tender was advertised on the Scottish Procurement Portal as an Open Tender and companies with rating experience were invited to tender for the appointment of a Rating Specialist to Falkirk Council, for the 2010 Rating Revaluation.

#### 2.0 Tenders Received

- 2.1 Six tenders were received by the due date of 21 April 2011 and opened in accordance with Standing Order 11.2 relating to contracts.
- 2.2 The companies were requested to tender on the basis of initially answering 5 set questions. In addition, providing a % fee quote in respect of anticipated rateable value savings for the 2010 Rating Revaluation, also providing a figure of previous rateable value savings achieved for a Council in the 2005 Rating Revaluation together with the numbers of associated appeals
- 2.3 Following evaluation of all tenders, two companies were de-selected on the grounds of failing to score a pre-set total of 75. The remaining 4 companies were subsequently considered and automatically proceeded for consideration in terms of the award criteria.
- 2.4 The fee quotes for the 2010 Rating Revaluation of the compliant tenders ranged from 3.75% to 8.45% and quoted rateable value savings (adjusted pro-rata) ranged between £0.37 million and £8.4 million.
- 2.5 Based on the scoring mechanism set out within the pricing schedule, James Barr Ltd received the highest score. Their fee quote was 4.75% of Rateable Value savings in the 2010 Rating Revaluation and it is estimated that the approximate value of this contract will be worth less than £37,500.
- 2.6 The funding for this project will be apportioned from the revenue budget of each Service benefitting, from a rateable value saving in respect of their property portfolio.
