## P25. CHANGE OF USE FROM OPEN SPACE/LANDSCAPE AREA TO FORM VEHICULAR ACCESS AND PARKING AREA IN ASSOCIATION WITH COMMERCIAL GARAGE/TAXI BUSINESS INCLUDING DROPPED KERB AT LAND TO THE WEST OF 6 MILLER CRESCENT, LITTLE CARRIDEN, BO'NESS FOR MR AND MRS G MCBAIN – P/13/0163/FUL

With reference to Minute of Meeting of the Planning Committee held on 29 May 2013 (Paragraph P20 refers), Committee gave further consideration to Report (circulated) dated 21 May 2013 by the Director of Development Services on an application for full planning permission for the change of use from open space/landscaped area to form vehicular access and parking area at 6 Miller Crescent, Little Carriden, Bo'ness.

# P26. LANDSCAPE RESTORATION OF QUARRY VOID, COMPRISING PLANTING AND EARTHWORKS RESTORATION AND UPGRADING OF SOUTHERN SECTION OF SITE ACCESS ROAD LEADING TO THE A803 AT COWDENHILL QUARRY, CONEYPARK CRESCENT, BANKNOCK, BONNYBRIDGE FK4 1TX FOR AGGREGATE INDUSTRIES UK LTD – P/12/0380/FUL

# P27. CONSULTATION IN RESPECT OF APPLICATION 12/00729/FUL (NORTH LANARKSHIRE REFERENCE NUMBER) - EXTRACTION OF 350,000 TONNES PER ANNUM OF HARD ROCK OVER A 21 YEAR PERIOD AND ASSOCIATED LANDSCAPE, EARTHWORKS AND ACCESS ROAD UPDGRADE AT TOMFYNE FARM, BANTON, NORTH LANARKSHIRE G65 0RJ FOR AGGREGATE INDUSTRIES UK LTD

With reference to Minute of Meeting of the Planning Committee held on 29 May 2013 (Paragraph P18 refers), Committee gave further consideration to Report (circulated) dated 21 May 2013 by the Director of Development Services on a cross-boundary development between North Lanarkshire Council and Falkirk Council. The application to North Lanarkshire Council by Aggregate Industries Ltd is in respect of extraction of 350,000 tonnes per annum of hard rock over a 21 year period and associated landscape, earthworks and access road upgrade at Tomfyne Farm, Banton. North Lanarkshire Council have written to Falkirk Council seeking comments on the proposed development.
