AGREED to GRANT a Taxi Driver Licence subject to the standard conditions.

CL30. APPLICATION FOR THE RENEWAL OF A TAXI DRIVER LICENCE

The applicant, Mr McC, entered the meeting and was accompanied by a fellow taxi driver, Mr McK.

There was submitted Report (circulated) dated 29 May 2013 by the Chief Governance Officer on an application for the renewal of a taxi driver licence continued from an earlier meeting of the Committee on 13 March 2013. The report provided an update on Mr McC's actions to address previously identified health concerns. Attached to the report as an appendix was the report to the earlier Committee.

Mr McK, speaking for Mr McC, gave a full and frank overview of Mr McC's current status and requested the Committee to understand his position when determining the application.

Questions were asked of both Mr McC and Mr McK by Members of the Committee.

AGREED to **RENEW** the taxi driver licence for Mr McC, for a period of 6 months, on the basis that, should Mr McC apply to renew his licence again, he will be expected to provide further reports on the status of his continued rehabilitation including full reports from Signpost or an equivalent organisation, and a more comprehensive medical statement.

CL31. APPLICATION FOR THE GRANT OF AN ADDITIONAL TAXI OPERATOR LICENCE

The applicant, Mr F, entered the meeting.

There was submitted Report (circulated) dated 28 May 2013 by the Chief Governance Officer on an application for the grant of an additional Taxi Operator Licence (a) advising of the background to the application; (b) detailing the consultations undertaken and the responses received, and (c) presenting details of the vehicle to be operated.
