CL137. APOLOGIES

Apologies for absence were intimated on behalf of Baillie Joan Paterson and Councillor Paul Garner.

CL138. DECLARATIONS OF INTEREST

No declarations were intimated.

CL139. MINUTE

Decision

The minute of the meeting of the Civic Licensing Committee held on 10 February 2016 was approved.

CL140. LIST OF APPLICATIONS GRANTED UNDER DELEGATED POWERS IN JANUARY 2016 AND NOTIFICATIONS OF PUBLIC PROCESSIONS PENDING

The committee considered a report by the Chief Governance Officer detailing (a) applications granted under delegated powers between 1 January and 31 January 2016 in terms of the Civic Government (Scotland) Act 1982, and (b) notifications of pending public processions.

Decision

The committee noted the report.

CL141. CIVIC LICENSING ENFORCEMENT – JANUARY 2016

The committee considered a report by the Chief Governance Officer giving an overview of enforcement action taken with regard to Civic Licensing activities during January 2016.

Decision

The committee noted the report.

Councillor Hughes joined the meeting during consideration of the previous item.

CL142. EXCLUSION OF PUBLIC

RESOLVED in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, to exclude from the meeting the press and public for the following items of business on the ground that they would involve the likely disclosure of exempt information as defined in Paragraph 6 of Part 1 of Schedule 7A to the said Act.

CL143. LICENSING OF HOUSES IN MULTIPLE OCCUPATION

The committee considered a report by the Chief Governance Officer providing members with an update on the rationale and requirements that underpin the licensing of Houses in Multiple Occupation (HMOs) along with details of the current licensed HMO's in the Falkirk Council area, set out in Appendix 1 to the report.

Decision

The committee noted the report.

CL144. APPLICATION FOR THE GRANT OF A NEW SKIN PIERCING AND TATTOOING LICENCE

The applicant, Ms C, entered the meeting and was accompanied by her mother, Mrs C.

The committee considered a report by the Chief Governance Officer on an application for the grant of a new skin piercing and tattooing licence (a) advising of the background to the application; (b) outlining the licence conditions; (c) detailing the consultations undertaken and responses received, and (d) summarising the experience and training of the proposed tattooist.

Decision

The committee agreed to grant the skin piercing and tattooing licence for a period of one year subject to the standard conditions.

CL145. APPLICATIONS FOR THE GRANT OF 3 NEW PRIVATE HIRE CAR OPERATOR LICENCES

Ms B and Ms M, the two directors of the applicant company, entered the meeting.

The committee considered a report by the Chief Governance Officer on applications received for the grant of 3 private hire car operator licences (a) advising of the background to the applications, and (b) summarising the consultations undertaken and responses received.

Decision

The committee agreed to grant 3 private hire car operator licences for a period of one year, subject to the standard conditions.

CL146. APPLICATION FOR THE GRANT OF A NEW LATE HOURS CATERING LICENCE

Ms A, entered the meeting.

The committee considered a report by the Chief Governance Officer on an application received for the grant of a late hours catering licence (a) advising on the application; (b) referring to the recent amendments made to the policy and conditions applicable to late hours catering licences as it relates to Falkirk Town Centre, and (c) detailing the consultations undertaken and the responses received.

Ms A spoke in support of the application.

Questions were then asked by members of the committee.

Decision

The committee agreed to grant the late hours catering licence for a period of three years, subject to the standard conditions.

CL147. APPLICATION FOR THE VARIATION OF LATE HOURS CATERING LICENCE NUMBER 252

Ms D, Director and Mr D, the day to day manager of the applicant company, entered the meeting.

The committee considered a report by the Chief Governance Officer on an application received for the variation of late hours catering licence No.252 (a) advising on the application; (b) referring to the recent amendments made to the policy and conditions applicable to late hours catering licences as it relates to Falkirk Town Centre, and (c) detailing the consultations undertaken and the responses received.

Decision

The committee agreed to grant the variation of late hours catering licence No.252.

CL148. SUSPENSION HEARING IN RELATION TO TAXI DRIVER LICENCE NO. 344

Mr D, licenceholder, entered the meeting.

The committee considered a report by the Chief Governance Officer (a) detailing the standard of fitness level required for licensed taxi drivers; (b) summarising the medical condition of the licenceholder, and (c) the background and outcome of an independent medical analysis which that licenceholder had recently undertaken.

Mr D was heard in relation to his medical condition.

Questions were asked of the licenceholder by members of the committee.

Mr D was invited to sum up.

Thereafter, the committee agreed to a short adjournment.

The committee adjourned at 10.10 a.m. and reconvened at 10.20 a.m. with all members present as per the sederunt.

Decision

The committee agreed to suspend the taxi driver licence for the unexpired portion of the duration of the licence, in terms of the Civic Government (Scotland) Act 1982, Schedule 1 paragraph 11(2)(v) on the ground of public safety.

CL149. SUSPENSION HEARING IN RELATION TO TAXI DRIVER LICENCE NO. 2033

Mr M, licenceholder, entered the meeting.

The committee considered a report by the Chief Governance Officer advising that the licenceholder had omitted to disclose two convictions at the time of submitting his original taxi driver licence application.

Mr M was heard in relation to the reason for these omissions.

Questions were asked of the licenceholder by members of the committee.

Mr M was invited to sum up.

Decision

The committee agreed to take no further action.

CL150. APPLICATION FOR THE RENEWAL OF A SECOND HAND DEALER LICENCE (USED VEHICLES)

Mr M, agent, and 4 employees of the applicant company, entered the meeting. Mr Whittle, Development Management Co-ordinator, Falkirk Council also entered the meeting.

The committee considered a report by the Chief Governance Officer on an application for the renewal of a second hand dealer licence (used vehicles) (a) advising of the background to the application; (b) summarising the consultations undertaken and the responses received, and (c) confirming that a letter of objection had been received in respect of the renewal application.

The Licensing Co-ordinator advised that the objectors, Mr & Mrs H, were unable to attend this meeting.

The agent, Mr M, advised that he had no preliminary points to make on the competency of the letter of objection.

The Licensing Co-ordinator referred to a submission from the applicant company in response to the letter of objection. The committee agreed that both the letter of objection and the submission be circulated.

Mr M was heard in support of his client's application and in relation to concerns raised in the objection and the action taken to address specific issues.

Questions were then asked by members of the committee.

Mr Whittle was then heard in relation to specific planning issues referred to in the letter of objection.

Decision

The committee agreed to grant the renewal of the second hand dealer licence (used vehicles) for a period of 3 years, subject to the standard conditions.

CL151. APPLICATION FOR THE GRANT OF A NEW TAXI OPERATOR LICENCE

Mr S, applicant, entered the meeting.

One objector, Mr D entered the meeting accompanied by his agent, Mr S and Ms B, Interpreter. Mr S, agent, advised that the other objector, Mr N, would not be attending as he was currently out of the country.

The committee considered a report by the Chief Governance Officer on an application for the grant of a new taxi operator licence (a) advising on the background to the application; (b) summarising the consultations undertaken and responses received; (c) detailed the applicant's record; (d) confirming that two letters of objection had been received in respect of the application, and (e) referring to the meeting of the Civic Licensing Committee held on 13 January 2016 when the applicant had requested a continuation, due to him being unable to attend due to illness. Mr S, agent, referred to the meeting on 13 January 2016 and sought clarification on whether medical evidence had been submitted by the applicant confirming that he had attended his GP.

The Licensing Co-ordinator advised that a letter had been received from the applicant's GP confirming that Mr S, had attended a GP appointment on 13 January 2016.

The letters of objection were circulated to members. The applicant had also submitted two letters of support, and with the agreement of the objectors' agent, these were also circulated to members.

Mr S, agent, was heard in relation to his clients' objections to the application.

No questions were asked of the agent by the applicant or members of the committee.

The applicant, Mr S, was then heard in support of his application and in response to issues raised in the letters of objection.

Questions were asked of the applicant by Mr S, agent and by members of the committee.

Both parties were invited to sum up.

Thereafter, the committee agreed to a short adjournment.

The committee adjourned at 12.10 p.m. and reconvened at 12.20 p.m. with all members present as per the sederunt

Decision

The committee agreed to grant the new taxi operator licence for a period of one year, subject to the standard conditions.

CL152. SUSPENSION HEARING IN RELATION TO TAXI DRIVER LICENCE NO. 1889

Mr S, the licenceholder, entered the meeting. One complainant, Mr D entered the meeting accompanied by his agent, Mr S and Ms B, Interpreter. Mr S, agent, advised that he was also representing another complainant, Mr N, but that he would not be attending as he was currently out of the country. Four other complainers also entered the meeting, namely, Mr S S, Mr H P, Mr J S, and Mr K S.

Members were advised of the background to the complaint which relates to two letters of complaint submitted to the licensing section, alleging that the taxi driver is not a fit and proper person to be the holder of a taxi driver licence. Six taxi drivers and one private hire car driver had also made complaints against the licenceholder, and each had attended the licensing offices and submitted individual statements.

The two letters of complaint, witness statements and two letters of support submitted on behalf of the licenceholder, were circulated to members of the committee.

Mr S, agent, was heard in relation to his clients' letters of complaint.

Mr H P, on behalf of the other 3 complainants in attendance, was heard in relation to their complaints.

The licenceholder, Mr S, was then heard in response to the issues and concerns raised in the complaints.

Questions were asked of the licenceholder by Mr S, agent and by members of the committee.

Both parties were invited to sum up.

Thereafter, the committee agreed to a short adjournment.

The committee adjourned at 12.55 p.m. and reconvened at 1.05 p.m. with all members present as per the sederunt

Decision

The committee agreed to take no further action.

1. INTRODUCTION

1.1 The Licensing Enforcement Officer undertook various aspects of enforcement in February 2016. Details of these are outlined in the following sections of the report.

2. TAXI/ PRIVATE HIRE CAR CHECKS

- 2.1 The Licensing Enforcement Officer routinely carries out spot checks of taxis and private hire car vehicles to ensure compliance with licence conditions.
- 2.2 The checks take place at various taxi ranks and other places within the district. The checks consist of a range of items including the following:-
 - Id badge/ Taxi-Private Hire Licence
 - DVLA driving licence
 - Plates displayed
 - Tariff Sheet
 - Fire Extinguisher
 - First Aid Kit
 - Taximeter seal
 - No commercial adverts displayed on the vehicle
 - No smoking signs displayed
 - Taxi roof sign
 - Condition of vehicle
 - Wheelchair vehicle ramps
- 2.3 In February 2016, 32 taxis were inspected by the Licensing Enforcement Officer. The majority of these checks were found to be in order with the exception of the following matters:-

Taxi Operator 046 – was found not to be carrying a tariff sheet. This is a breach of taxi licence condition number 21.

Taxi Operator 117 – the meter was found to be running 6 minutes fast. This is a breach of taxi licence condition number 32.

Taxi Operator 135 – the operator name sticker was not being displayed on the vehicle. This is a breach of taxi licence condition number 13.

Taxi Driver 1046 – the driver was not carrying his taxi driver licence. This is a breach of taxi driver licence condition number 2.

The operators and driver were written to and requested to attend the licensing offices and provide evidence that the matters detailed have been attended to. They have now fully complied.

3. CIVIC LICENSING ENFORCEMENT CHECKS

- 3.1 During February 2016, the Licensing Enforcement Officer undertook 18 civic licensing compliance checks and enquiries.
- 3.2 The compliance checks/enquiries involved the following civic activities:-
 - Second Hand Dealers five routine checks of licensed premises were carried out to ensure that the licence holder details were correct, that the licence was being properly displayed and that the register of sales was being kept up to date. All were found to be in order. One enquiry was also carried out and an application form issued to a used car dealer.
 - Late Hours Catering five routine checks of licensed premises were carried out which established that there had been a change of day to day manger for one of the premises and a variation form for a licence was subsequently issued. The other checks were all found to be in order. One enquiry also carried out with premises which established that they were now closing at 11pm and did not therefore require to be licensed.
 - Street Trader one routine check of a licensed street trader (ice cream van) was carried out to ensure that the licence holder details were correct. All was found to be in order.
 - Window Cleaner one check of a window cleaner carried out which established that he did not hold a licence to operate in this Council area. An application form was issued.
 - Skin Piercing one routine check of licensed premises was carried out to ensure that the licence holder details were correct and that the licence and notices were being properly displayed. All was found to be in order.
 - Booking Office one check carried out to ensure licence holder details were correct, that the licence was being properly displayed and that the booking register was being kept up to date. All was found to be in order.
 - Public Entertainment one enquiry carried out and an application form issued to premises operating as a laser zone.
 - Knife Dealer one routine check of licensed premises carried out to ensure that the licence holder details were correct, that the licence and appropriate notices were being displayed and that the register of sales was being kept up to date. The premises were found to be fully compliant.

- 3.3 These checks consist of a range of items including the following:-
 - Licence type
 - Licence holder details
 - Day to day manager details (if applicable)
 - Id badge/ Licence
 - Register check (if applicable)
 - Vehicle details (if applicable)
 - Occupants details
- 3.4 In addition to the above, the Licensing Enforcement Officer carried out six knowledge tests involving eight candidates, two of whom required their answers to be written down for them. 5 site notice checks were also carried out.

4. CIVIC LICENSING COMPLAINTS

A complaint was received from a male motorist regarding a private hire car driver who had been on a slip road entering the M9 motorway from the Lathallan roundabout when it is alleged that the private hire car driver pulled across without any warning, causing him to almost drive onto the verge. The private hire car driver was subsequently traced and interviewed and confirmed that he had been the driver on the date in question, but that he had no recollection of any such incident. However, he accepted that his vehicle details had been provided and wished his apologies to be passed on to the complainer.

A complaint was received from a female motorist who claimed that as she had turned into Walker Drive, Dennyloanhead, from the main road she had been made to stop at a road calming measure due to an oncoming taxi being driven fast and failing to give way to her as she had the right of way. She also alleged that as the taxi driver was going past her he had sworn at her. The taxi driver was subsequently traced and interviewed and stated that there was no way he had been driving fast due to the nature of the road and that he had almost been through the road calming measure when the complainer had turned in from the main road. He was also adamant that he had not sworn at her.

A complaint was received from a male person about a taxi driver who had parked near to a pedestrian crossing area close to the entrance to supermarket premises in Camelon. The taxi driver was traced and interviewed and claimed that he had only parked in this manner as he had purchased some heavy wooden items from the shop. He accepted that he should not have parked as close to the pedestrian crossing area and stated that he would not park in such a manner again.

The complainants were advised of the outcome of their complaints and were satisfied with the course of action undertaken.

5. **RECOMMENDATION**

5.1 It is recommended that Members note the contents of this report.

1. APPLICATIONS FOR THE GRANT OF A NEW TAXI DRIVER LICENCE

- 1.1 Ms Kerry Paris submitted an application for a new taxi driver on 4 December 2015. Her application must be considered before 3 June 2016. The applicant sat the knowledge test on 7 January 2016 and attained 34%. She sat the test on 21 January and attained 68%. The applicant was invited to sit the test on 4 February and attained 73%. The applicant was afforded a fourth opportunity by officers to sit and pass the knowledge test on 18 February, however she attained 72%
- 1.2 It is the view of officers that the applicant has little prospect of passing the knowledge test and would recommend that the Committee consider refusing the application on the basis that the applicant has not sat and passed the knowledge test.
- 1.3 Mr Russell McCallum submitted an application for a new taxi driver licence on 14 December 2015. His application must be considered before 14 June 2016. The applicant was invited to attend for the test on 7 January 2016 and failed to attend and did not advise that he was unavailable. The applicant was invited to sit the test on 21 January 2016 and attained 16%. Further tests were arranged for 4 and 18 February and the applicant failed to attend and did not advise that he was unavailable.
- 1.4 It is the view of officers that the applicant has little prospect of passing the knowledge test and would recommend that the Committee consider refusing the application on the basis that the applicant has not sat and passed the knowledge test.
- 1.5 The applicants have not been invited to sit a medical as yet.
- 1.6 Ms Paris and Mr McCallum were both notified of their failures and opportunities to attend and that the matter will be considered by the Committee. The letter explained that they could submit a letter in support of their applications which would form part of the report. No letters have been received.

2. **RECOMMENDATION**

It is recommended that Members consider the terms of the report.

The options available to the Members are:-

2.1

- (a) to refuse to grant the TAXI DRIVER licences in terms of the Civic Government (Scotland) Act 1982, Section 13 (5) on the grounds that the applicants, having failed to pass the knowledge test, have failed to satisfy the Authority that they had adequate knowledge of the area to which the licence relates and the layout of roads in the area; or
- (b) if Members are satisfied that there are other relevant circumstances that warrant a departure from policy, to instruct officers to arrange for the applicants to undertake a medical; and should they fail the medical to remit the matter back to Committee for consideration; should the applicant pass the medical, to authorise the Chief Governance Officer to grant the TAXI DRIVER licences.
