FC30. OPENING REMARKS

Councillor Alexander expressed concern about the proposed closure of HM Revenue and Customs Offices in both Falkirk and Grangemouth. These concerns were shared by Council.

The Chief Executive advised of her intention to discuss any response to the proposals with the Group Leaders during the recess period to ensure that Council's views were appropriately communicated.

FC33. QUESTIONS

Question by Councillor D Alexander

"FC8 Falkirk Community Stadium Limited Shareholders Update

Bullet point 4 of the agreement in the report approved unanimously at the full Council meeting at Wednesday 30 April 2008 was to press FCSL for information on the developer's proposals and to bring the report therein to the June meeting of Council and further agrees to monitor progress by regular briefings to Members.

I am aware from the press statement issued by FCSL that the report has not yet been concluded hence the reason why it is not on the agenda for today.

However, I would be grateful if you could advise me if there have been briefings for any Members of Falkirk Council on the proposals being considered by FCSL to stakeholders groups that make up the company".

Response by Provost Reid

"FCSL have held 2 shareholder briefings since the last meeting".

FC34. ORDER OF BUSINESS

In terms of Standing Order 15.2(i), Provost Reid advised of variations to the order of business from that detailed on the agenda for the meeting. The following items have been recorded in the order that they were taken at the meeting.

FC35. NOTICES OF MOTION

Councillor Gow, seconded by Councillor C MacDonald, moved that:-

In order to ensure the proper and timely dispatch of Council business, Council hereby agrees to replace section 31 of the Standing Orders relating to Meetings with the following and that with immediate effect:

31. CLOSE OF BUSINESS

- 31.1 Meetings of Council will generally start at 10.30a.m. (unless the Provost specifies an earlier or later time) and will last for no longer than 3 hours unless a motion to continue the meeting for a further specified period has been moved, seconded and voted upon without discussion, provided that no meeting will continue beyond 5p.m. on that same day (subject to the terms of section 31.2 below) unless a motion to continue the meeting beyond that time for a further specified period has been moved, seconded and voted upon without discussion.
- 31.2 If, at 5 p.m. or such later time as Council shall have agreed, business remains on the agenda to be transacted, it shall be dealt with in the following manner:
 - 31.2.1 Any motion or amendment which has been formally moved and seconded will be put to the vote by the Provost.
 - 31.2.2 Any reports or motions then remaining on the agenda will be considered by the Provost in order. It will be available for a motion and amendment to be moved and seconded on each item but without discussion (provided that the Provost may allow discussion on such an item where in his/her view such discussion is necessary for the proper consideration of the item). Each item will then be put to the vote by the Provost. Items not moved and seconded will fall from the agenda.
 - 31.2.3 There will be no right of reply available to the mover of any motion under this Standing Order.
- 31.3 Nothing in this Standing Order will prejudice the power of the Provost, at his/her discretion, to adjourn temporarily any meeting for a brief period. The time elapsed during any such adjournment will be disregarded for the purpose of

calculating the period of 3 hours referred to in Standing Order 31.1 but will not have the effect of extending the 5p.m. closure term specified therein.

By way of an Amendment, Councillor Alexander, seconded by Councillor Coleman moved:-

"The notice of motion moved by the Leader of the Council is both demeaning to the Provost and a gross interference in the role of Falkirk's first citizen.

The motion is also an attack on the ability of opposition groups to be heard and therefore an affront to democracy.

The problem with meetings overrunning has been a matter of poor management from the Administration and the confrontational and immature attitude adopted towards opposition groups and members."

Council therefore resolves to:-

- Retain the Standing Orders of the Council in their current format as the best means of ensuring balanced debate and equal opportunities as well as demonstrating respect for the Provost of Falkirk Council;
- End the intolerance demonstrated against opposition groups with the petty amendments to opposition motions that often results in amendments being approved that mean the same as the original motion; and
- Open proper dialogue between all groups prior to the finalisation of the Council agenda. This could be achieved with the Provost chairing a meeting of group leaders to investigate areas of agreement and to seek compromise where there is little between the groups. Thus areas of common consensus can be reached and therefore reducing the time spent in chambers by all members."

In terms of Standing Order 21.4(i) a vote was taken by way of a roll call there being 30 Members present, with Members voting as undernoted.

For the Motion (16) – Provost Reid and Depute Provost Black; Councillors Blackwood, Buchanan, Fry, Goldie, Gow, Lemetti, C MacDonald, Mahoney, C Martin, CR Martin, McLuckie, McNeill, Nicol and Nimmo.

For the Amendment (14) – Councillors Alexander, Carleschi, Coleman, J Constable, H Constable, Hughes, Jackson, Kenna, A MacDonald, McNally, Meiklejohn, Oliver, Spears and Thomson.

Accordingly, **RESOLVED** in terms of the Motion.

FC36. ANNUAL ACCOUNTS 2007/08

There was submitted Report (circulated) dated 9 June 2008 by the Director of Finance advising of the submission of the Council's Unaudited Annual Accounts for the financial year ended 31 March 2008 to the Controller of Audit as required in terms of the Local Government (Scotland) Act 1973 and the Local Authority Accounts (Scotland) Regulations 1995

NOTED the formal submission of the Unaudited Annual Accounts to the Controller of Audit by the 30 June 2008 deadline.

FC37. CONTRACTS FOR THE PROVISION OF WASTE MANAGEMENT SERVICES

There was submitted Joint Report (circulated) dated 25 June 2008 by the Directors of Development Services and Corporate and Commercial Services (a) advising that Falkirk Council, as lead Authority for the purchasing consortium of Falkirk, Stirling and Clackmannanshire Councils, had invited three tenders for the provision of waste management services for all three Council areas; and (b) providing information on the tender evaluation exercise together with officers' recommendations in respect of the award to the contract.

AGREED, in respect of Falkirk Council only and in accordance with Standing Order 6.2(iv), to accept the tender submitted by Avondale Environmental Ltd, Polmont, in the sum of £20,096,500 for the five years of the contract from 15 August 2008 to 14 August 2013 with an option to extend this contract by a further two, one year extensions.

NOTED the positive impact that residual waste treatment will have in achieving future waste diversion targets.

FC38. REFERRAL FROM SPECIAL HOUSING AND SOCIAL SERVICES COMMITTEE - 24 JUNE 2008 - HOUSING ALLOCATIONS REVIEW UPDATE

With reference to Minute of Special Meeting of the Housing and Social Services Committee held on 24 June 2008 (Paragraph HSS30 refers), there was submitted (a) Extract of Minute of the said meeting; and (b) Report (circulated) dated 14 June 2008 by the Director of Corporate and Commercial Services considered at the said meeting.

Councillor Goldie seconded by Councillor McNeill moved the recommendations as agreed at the Special Meeting of the Housing and Social Services held on 24 June 2008.

By way of an amendment Councillor McNally, seconded by Councillor Meiklejohn moved that:-

"Council believes that it is important to get the allocation system right and that the current process does not allow members adequate opportunity to scrutinise the proposals that have come forward from the officer only working group.

Council believes that there should have been a seminar in advance of the publication to discuss these proposals which, contrary to the claims by the convener of the Housing and Social Work Committee, have never been discussed with Members.

Council also believes that elected members are the democratic voice of the people and to refuse access to the working group for elected members is a breach of the principle of public representation.

However, as the Administration has decided upon the course of minimum scrutiny and minimum Member involvement the following changes should be made forthwith.

Council agrees to develop a choice based Housing Allocations System that is transparent and fair, the current proposed system fails both criteria.

The proposals as they are, fail to:-

- deal with the categorisation of multi priority applications thus being inherently unfair
- provide an easily understood system of allocation for elderly and infirm applicants in particular
- flexible enough to deal with applicants who fall between stools in the manner that Social Management Points category were established to deal with
- pass the test of scrutiny both in terms of the lack of opportunity for Member input into the policy determination phase and the ability to scrutinise the implementation of the policy if adopted
- reduce the number of successful homeless applicants to below the figures achieved in the months before the interim arrangements currently in place arose

Council therefore agrees to:-

- 1. Develop a "Choice Based" allocations system that has as its core, fairness. To achieve this Council agrees to allocate points for each priority classification within the individual Category Groups thus giving some transparency within the system. Applicants will be invited to apply for void properties with the property being allocated to the applicant with the highest number of priority points from within the Category Group. Where there is more than one applicant with the same number of points the property will be allocated to the applicant who has waited the longest.
- 2. Develop a simplified method of advertising and registration that ensures all of our applicants have access to lists and therefore equal opportunity to void properties.
- 3. Remove the draconian penalties for refusal as there must be a reason for refusing an allocation an individual has applied for. Applicants should therefore be allowed a maximum of two refusals before they are suspended from the waiting list for a period of six months.
- 4. Officers to bring forward a financial incentive package to people with under occupancy points to encourage them to move into properties more suited to their family compliment, thus freeing up larger family homes.
- 5. All medical applications must be dealt with by the Community Medicine Specialist to ensure consistency of award."

Following a short adjournment to consider the terms of the motion and amendment, the matter under consideration was put to the vote when 16 Members voted for the Motion and 14 for the Amendment.

Accordingly, AGREED:-

- (i) the draft allocations policy for consultation as set out in Appendix 2 to the Report:
- (ii) to extend the interim arrangements as set out in Section 9 of the Report;

- (iii) to note that during the summer recess, further development work would be carried out as detailed in Section 8 of the Report; and
- (iv) to note the proposal to bring a report on the consultation outcome to a future meeting of the Housing and Social Services Committee.

FC39. EXECUTION OF DEEDS

There was submitted Report (circulated) dated 10 June 2008 by the Acting Director of Law and Administration Services advising of the deeds which had been signed and sealed on behalf of the Council since its last meeting.

NOTED the signing and sealing by the Acting Director of Law and Administration Services of the Deeds as detailed in the Appendix to the Report.

FC40. DELEGATION OF POWERS TO DETERMINE URGENT ISSUES DURING THE SUMMER RECESS

There was submitted Report (circulated) dated 25 May by the Acting Director of Law and Administration proposing that Chief Officers of the Council be given delegated powers to determine urgent items of business which would normally be determined by Council or Committee for the period of the summer recess.

AGREED:-

- (1) to delegate power to Chief Officials, in consultation with the Convener and Depute Convener of the appropriate Committee, to determine urgent items of business during the summer recess (from 25 June 2008 to 11 August 2008) provided that:-
 - (a) any such decision is required to secure the proper delivery of Council Services and to comply with the Council's statutory duties;
 - (b) any such decision does not involve expenditure of Council monies outwith the approved Revenue Budget and Capital Programme;
 - (c) any such decision does not involve an increase in the permanent establishment of the particular Service;
 - (d) any such decision involves no dispute as to legality, propriety or the proper interpretation of Council policy as affecting the decision; and
- (2) that a report be submitted to the first meeting of the Policy and Resources Committee after the recess, detailing decisions made under these powers.

FC41. APPOINTMENT TO OUTSIDE BODIES

There was submitted Report (circulated) dated 9 June 2008 by the Acting Director of Law and Administration advising of (a) an application for appointment to the vacant position on Cornton Vale Prison Visiting Committee; and (b) seeking a nomination to join the Argyll, Loch Lomond and Forth Valley Development Partnership.

AGREED:-

- (1) to approve the appointment of Ms Julie Reilly to Cornton Vale Prison Visiting Committee; and
- (2) to nominate Councillor Mahoney as the Falkirk Council representative on the Argyll, Loch Lomond and Forth Valley Development Partnership.

FC42. SINGLE OUTCOME AGREEMENT

There was submitted Report (circulated) dated 11 June 2008 by the Chief Executive providing a copy of the Single Outcome Agreement (SOA) between the Falkirk Council Area Community Planning Partnership and the Scottish Government for approval.

NOTED the contents of the report and the work that has been undertaken to date in developing the Single Outcome Agreement for the Falkirk Council area.

AGREED to approve the Single Outcome Agreement for the Falkirk Council Area Community Planning Partnership

In terms of Standing Order 31.1 it was **AGREED** to continue the meeting beyond the 3 hour limit, following a short adjournment for lunch. The meeting adjourned at 1.30 pm and re-convened at 2.10 pm with all Members present per the sederunt.

FC43. EXCLUSION OF PUBLIC

RESOLVED in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, to exclude from the meeting the press and public for the following item of business on the grounds that it would involve the likely disclosure of exempt information as defined in Paragraphs 11 & 12 of Part 1 of Schedule 7A of the said Act.

FC44. EQUAL PAY, SINGLE STATUS AND CRAFT PAY AND CONDITIONS UPDATE

With reference to her earlier Declaration of Interest, Councillor Gow left the meeting at this point.

There was submitted Report (circulated) dated 12 June 2008 by the Director of Corporate and Commercial Services providing an update in respect of the following issues:-

- (i) pay settlements to specific groups of employees in respect of Equal Pay;
- (ii) implementation of the Single Status proposals; and
- (iii) discussions with trade unions at a local level with regard to pay and conditions for craft workers.

Councillor Nimmo, seconded by Councillor C MacDonald, moved the recommendations as contained within the Report.

By way of an amendment, Councillor Alexander, seconded by Councillor Coleman moved:-

"Council notes the report from the Director of Corporate and Commercial Services and believes that there is insufficient information to allow a balanced decision to be made.

In particular, Council notes the inconsistency between previous legal advice and recommendations contained within the report.

Council therefore agrees to the following:-

- 1. agrees to set up a Working Group made of the Group Leaders and their deputies to review the entire Single Status issue;
- 2. the Working Group have access to all evidence including independent legal advice on the matter and have the authority to seek additional independent legal advice over and above that already received; and
- 3. the Working Group will report back to the next scheduled meeting of the Council."

In terms of Standing Order 21.4 (i) a vote was taken by roll call, there being 29 Members present, with Members voting as undernoted:-

For the Motion (15) - Provost Reid and Depute Provost Black; Councillors Blackwood, Buchanan, Fry, Goldie, Lemetti, C MacDonald, Mahoney, C Martin, CR Martin, McLuckie, McNeill, Nicol and Nimmo.

For the Amendment (14) Councillors Alexander, Carleschi, Coleman, H Constable, J Constable, Hughes, Jackson, Kenna, A MacDonald, McNally, Meiklejohn, Oliver, Spears and Thomson.

Accordingly, **AGREED**:-

- (1) to grant the Chief Executive delegated authority to commence negotiations in respect of settlement of outstanding Tribunal claims within a £4m framework and report back to Members on any agreement reached to seek final approval;
- (2) to delegate authority to the Chief Executive in consultation with Group Leaders, to continue negotiations with Trades Unions on the Single Status proposals outlined in Section 3 of the Report, with a view to reaching a collective agreement on this matter, which may incur additional costs and report back to Members with details of any agreement reached, and
- (3) to note the on-going discussions with the Craft Trades Unions and to request a further report where necessary to outline progress.

Members of the press and public were re-admitted to the meeting.

Councillor Gow re-entered the meeting.

FC45. TOWN CENTRES STRATEGY: BO'NESS HARBOUR AND FORESHORE INITIATIVE

With reference to Minute of Meeting of Falkirk Council held on 30 April 2008, Paragraph FC7 refers), there was submitted Report (circulated) by the Director of Community Services (a) outlining the method and outcome of the consultation exercise undertaken with the Bo'ness Community on the Bo'ness Harbour and Foreshore Initiative; (b) detailing the content of the feedback, and (c) providing an updated perspective on the proposed development.

Councillor C Martin, seconded by Councillor Lemetti moved the recommendations as contained within the Report.

By way of an amendment Councillor J Constable, seconded by Councillor H Constable moved:-

"Council rejects the recommendation in this report.

Council instructs that Officers offer ING the opportunity of fresh negotiations based on a development ensuring the delivery of the harbour regeneration project.

Council at the same time instructs officers to contact the other original bidders to determine any remaining interest they may have and prepare an advertisement for publications in which statutory notification of such potential re-tendering of the development is required.

That a negotiating team comprising appropriate officers, local councillors, the Leader of the Council, and appropriate Conveners be established to receive replies from all interested bodies and assess these prior to their being brought back through the committee process".

In terms of Standing Order 21.4(i) a vote was taken by way of a roll call there being 30 Members present, with Members voting as undernoted.

For the Motion (15) – Provost Reid and Depute Provost Black; Councillors Blackwood, Buchanan, Fry, Goldie, Gow, Lemetti, C MacDonald, Mahoney, C Martin, CR Martin, McLuckie, McNeill, and Nimmo.

For the Amendment (15) – Councillors Alexander, Carleschi, Coleman, J Constable, H Constable, Hughes, Jackson, Kenna, A MacDonald, McNally, Meiklejohn, Nicol, Oliver, Spears and Thomson.

There being an equality of votes and in terms of Standing Order 21.6 the Provost used his casting vote in favour of the Motion.

Accordingly, **NOTED** the extent and outcome of the consultation on the proposed rephasing of the Bo'ness Initiative and the comments supplied in response to the views of the community as set out in the Report.

AGREED that, having considered the outcome of the consultation, the revised phasing of the Initiative should proceed and that the Director of Community Services be

authorised to work with ING RED UK (Bo'ness) Ltd, with ING RE BV as guarantor, to progress and deliver the regeneration masterplan and finalise a Development Agreement on the terms set out in the original Policy and Resources Committee Report of 11 March 2008.

FC46. FALKIRK GATEWAY

There was submitted Report (circulated) dated 19 June 2008 by the Director of Community Services (a) providing an update on progress made in regard to the Falkirk Gateway development; and (b) seeking agreement for the Council to make a contribution towards meeting increased infrastructure costs associated with the project, repayable by the developers, subject to levels of return from subsequent phases of the scheme.

AGREED:-

- (1) to authorise a phased contribution, up to a maximum of £500,000 towards the increased costs of the site servicing and infrastructure at Falkirk Gateway following Phase 1 drawdown; and
- (2) to note that the contribution will be subject to open book verifications of such costs being properly incurred by the developer, Macdonald Estates and the conclusion of the necessary legal agreements in satisfactory terms.

FC47. AUDIT OF BEST VALUE AND COMMUNITY PLANNING - AUDIT SCOTLAND REPORT, MAY 2008

There was submitted Report (circulated) dated 5 June 2008 by the Chief Executive (a) advising of the findings contained within the report recently published by Audit Scotland on the Audit of Best Value and Community Planning within Falkirk Council; and (b) detailing the improvement actions which the auditors have recommended the Council consider in progressing its approach to Best Value.

AGREED:-

- (1) to welcome the publication of the Audit Scotland report, Audit of Best Value and Community Planning for Falkirk Council;
- (2) the findings of the report, including the areas for improvements;
- (3) that a response be sent to the Accounts Commission recognising the positive nature of the report and the Council's agreement of its findings along with a copy of the existing Improvement Plan as detailed in Appendix 1 of the report;
- (4) to update the current Improvement Plan to make reference to the specific actions as noted in paragraph 3.10 of the report; and
- (5) that the new Plan be monitored through regular reports to Best Value and Audit Forum with six monthly progress reports being submitted to the Policy and Resources Committee.

FC48. SCOTTISH HISTORIC ENVIRONMENT POLICY (SHEP) ON HISTORIC BATTLEFIELDS: CONSULTATION RESPONSE

There was submitted Report (circulated) dated 16 June 2008 by the Director of Development Services providing information on a public consultation launched by Historic Scotland on 30 April 2008, entitled "Scottish Historic Environment Policy on Historic Battlefields."

AGREED to approve the response to the Scottish Historic Environment Policy (SHEP) on Historic Battlefields as detailed in the Appendix to the report.

FC49. REFERRAL FROM ENVIRONMENT AND HERITAGE COMMITTEE – 10 JUNE 2008 - FALKIRK COUNCIL LOCAL PLAN HILLEND FARM, SLAMANNAN RESPONSE TO REPRESENTATIONS

With reference to Minute of Meeting of the Environment and Heritage Committee held on 10 June 2008 (Paragraph EH15 refers), there was submitted (a) Extract of Minute of Meeting of the said Committee (circulated); and (b) Report (circulated) dated 28 May 2008 by the Director of Development Services considered at the said meeting.

AGREED:-

- (1) to accept Local Plan objections 098/169 (Persimmon Homes) and 0105/185 (Mr John Kelly) and to approve the responses to those objections as detailed in Appendix 2 of the Report;
- (2) to approve the proposed pre-inquiry modifications as detailed in Appendix 2 of the Report, and to advertise these modifications to allow the opportunity for further representations; and
- (3) that should objections remain unresolved and be considered at the Local Plan Inquiry, the responses and proposed pre-inquiry modifications form the basis of the Council's position at the Inquiry.

The meeting adjourned for a short break at 5.00 p.m. and reconvened at 5.10 p.m. with all Members present per the sederunt.

FC50. COMMITTEE STRUCTURES

With reference to the Minute of Meeting of Falkirk Council held on 5 December 2007 (Paragraph FC59 refers), there was submitted Report (circulated) dated 23 June 2008 by the Chief Executive summarising the discussions which had taken place at the Working Group reviewing Service and Committee Structures.

Councillor Gow, seconded by Councillor C MacDonald moved as follows:

"This Council agrees that more investigative work be undertaken by the Structures Working Group into the disparities of workloads of the committees. Standing Orders to be revised to allow Scrutiny Committees to respond directly to consultation papers etc within their remit to take decisions on issues that do not change or materially alter

Council policy or involve additional resources or changes to the establishment. Council agrees to establish a separate Audit Committee a report to be brought to Council on the role, remit and constitution of this Committee. Council to retain the current Best Value and Audit Committee to scrutinise service performance etc.

Council agrees that Scrutiny Committees continue with 12 elected members but that they start at 9.30 am. Council also agrees that Committees utilise Standing Orders to invite representatives from other organisations to attend Committee as they think appropriate to answer questions and offer expert opinion.

Council agrees that the interim arrangements for Housing Services and Roads have been successful therefore Housing Services be permanently moved to Corporate and Commercial Services and the contractor part of the Roads function be permanently moved to Development Services. In addition the job descriptions of the relevant Directors be re-designed.

Council to receive a further report on the implementation of these changes together with any other Service structure or associated issues to be brought back to a future meeting of Council.

Council agrees to provide a commitment to the Trade Unions on all employee relation issues as detailed in paragraphs 3.15 to 3.17 to the Chief Executive's report."

By way of an amendment, Councillor Alexander, seconded by Councillor Coleman moved:-

Committees

"Restructure our scrutiny committees from five to four based, as closely as possible on the remits of the department.

These would be:-

- 1. Education Committee (dealing only with Educational matters)
- 2. Community Committee (dealing with such as Economic Development & Tourism and Leisure)
- 3. Housing, Health and Social Services
- 4. The Strategic Committee dealing with the remainder of Community Health and Safety and Environment and Heritage Committee.

(These are suggestions in terms of names and responsibilities and therefore subject to amendment following consultation with officers or alternative suggestions on such as names by members)

Committees be encouraged to include within their membership appointed outside representatives in order to take forward the community planning agenda.

Council also agrees that all Committees and Council meetings should generally commence at the same time to avoid confusion and agrees to start all meetings at 10 am thus allowing those from outlying areas an opportunity to arrive using public transport if required.

Scrutiny Committees be given delegated powers to approve consultation responses unless there is a division in which case the matter can be called into full Council. The Best Value and Audit Forum be restructured to separate Best Value and Audit. The Best Value Forum continue to meet in private to discuss the intricate Best Value agenda. The audit section become a sub committee of Policy and Resources mirroring the membership of the Policy and Resources Committee and meeting twice or three times per year as required.

Council agrees that scrutiny committees must have access to all information pertaining to their Services and agrees that included within this process must be scrutiny of the relevant Performance Indicators and Service Plans.

Structures

The current temporary structures for the Housing Department are not providing the results members had hoped for. Council agrees that these have to change and proposes that a dedicated and qualified Head of Service be appointed as part of the Corporate and Commercial Services' department and calls for this post to be reactivated and advertised."

On a division 16 Members voted for the Motion and 14 for the Amendment.

Council notes that under the previous SNP/Independent Administration income from Tourism rose by over 6% a year due in the main to the development of the My Future's in Falkirk economic development strategy and the ability to develop major projects such as the Helix and the MOD.

Council therefore calls for:

- 1. A commitment from the Administration that it will in the future seek to take advantage of opportunities that come the way of local government such as the Events Scotland fund.
- 2. Will bring forward to the relevant scrutiny committee a strategy paper for the maximisation of tourism potential around the national Year of the Homecoming strategy by no later than the next cycle of committee meetings.

Council welcomes the recent growth in visitor numbers to a number of key tourist sites across Falkirk district. We reaffirm our commitment – highlighted within our corporate plan – to work with partners to grow tourism further by ensuring:

- the promotion of the area's unique heritage and culture;
- maintaining and developing high profile national events;
- developing high-quality visitor attractions;
- and engaging with our communities in their local heritage and culture.

We also reaffirm our commitment to build on our success attracting external and government funding to support these initiatives, where appropriate.

On a division 14 Members voted for the Motion and 16 for the Amendment.

Accordingly, **RESOLVED** in terms of the Amendment.

Councillor Fry entered the meeting during consideration of the foregoing item of business.

(b) Discontinued Bus Services

Councillor Oliver, seconded by Councillor Hughes moved that:-

In order to meet the terms of the authority's Equal Opportunities policies to say nothing of our stated goals and values Council agrees to the following.

1. To bring forward a detailed financial report committing the Council to the reinstatement of all bus services discontinued where the bus passenger criteria was not met but where the usage was greater or equal to the usage of the recently reinstated last bus to Slamannan.

By way of an Amendment Councillor Mahoney seconded by Councillor McLuckie moved that:-

Council reaffirms its commitment to work with communities across Falkirk district to improve services for local people, within the financial constraints placed on it by the SNP Government.

On a division 14 Members voted for the Motion and 17 for the Amendment.

Accordingly, **RESOLVED** in terms of the Amendment.

(c) Office Accommodation

Councillor Coleman, seconded by Councillor Alexander moved that:-

The Johnston Press have become synonymous with Falkirk and as such are a key employer within the town.

Council notes with disappointment the snubbing of the company at the Falkirk Stadium and believes that positive action is required to keep the company HQ in the Falkirk area.

Council also notes the shortage of modern office accommodation within the Falkirk area and therefore believes that the dithering by the current Labour/Tory/Independent coalition before finally implementing the terms of the Strategic Property Review concluded by the previous SNP/Independent Administration was a grave error of judgement.

Council also notes the delay in bringing forward details of the Henry Boot proposals for Westfield which, we believe, contains proposals for office space within the first phase as another contributing factor in the failure of the Administration to find alternative accommodation for the Johnston Press HQ.

Council therefore instructs the appropriate Community Service staff to bring forward a report to the first available Economic Development Committee outlining the steps taken to date to assist Johnston Press relocate and the options open to Falkirk Council to assist and avenues currently being investigated.

By way of an amendment Councillor C Martin seconded by Councillor Lemetti moved that:-

Council applauds the tremendous work being done by the Economic Development section within Falkirk Council in continuing to attract new jobs to the area working in partnership with Scottish Enterprise and the Private Sector. Council confirms its good links with Johnston Press, meeting regularly with its staff and engaging on joint projects such as the business awards.

Council dismisses the SNP motion for its short sightedness and lack of knowledge on the matter of Johnston Press relocation.

Council fully supports the recent implementation of the Business Property Strategy that will be more flexible in order to take account of market conditions and their effects on the council.

On a division 14 Members voted for the Motion and 17 for the Amendment.

(d) Falkirk Rugby Club

Falkirk Council congratulates Falkirk Rugby Club for their achievements on and off the pitch over the past few years.

In particular Falkirk Council welcomes the club's youth development work with youngsters which often sees over 150 local kids taking part in club sessions during the week.

The Council also welcomes the recent award of £200,000 from the Sportscotland for the upgrade of existing facilities and the provision of new facilities at Sunnyside.

We view this as an opportunity to establish a mutually beneficial partnership with the club similar to those established with Stenhousemuir and Falkirk Football Clubs.

Council therefore agrees to open up discussions between the club and authority with a view to a Council contribution to the programme and report back to the appropriate committee in due course.

By way of an Amendment Councillor Waddell seconded by Councillor C Martin moved that:-

Falkirk Council congratulates Falkirk Rugby Club for their achievements on and off the pitch over the past few years.

In particular Falkirk Council welcomes the club's youth development work with youngsters which often sees over 150 local kids taking part in club sessions during the week.

The Council also welcomes the recent award of £200,00 from the Sport Scotland for the upgrade of existing facilities and the provision of new facilities at Sunnyside.

Council dismisses part of the SNP motion in particular paragraphs 4 and 5 as being out of date, given that the contents of the motion are already being implemented.

Council applauds the tremendous work being undertaken by the Community Services within Falkirk Council in their ongoing partnerships with various sporting organisations including SRU, Falkirk and Grangemouth Rugby Clubs. Council confirms its continued links with SRU, in particular the work of the Sports Development Officers specific to Rugby and the two Modern Apprentices who assist in delivering coaching programmes around the district. Council also notes the proposals from SRU to appoint a further 2 Modern Apprentices to the Rugby Programme.

Each Member, therefore, participated in the discussion and decision.

FC61. FALKIRK COMMUNITY STADIUM LTD – STRATEGIC REVIEW

There was submitted Report (circulated) dated 16 September 2008 by the Chief Executive advising Members of the outcome of a strategic review by Falkirk Community Stadium Ltd (FCSL) of its operations. The report set out the key findings of the review together with a proposed response by Falkirk Council.

Broadly, the review had concluded that, the company should be reorganised in a commercially attractive and tax efficient manner. It was therefore proposed to split

FCSL into (initially) three companies with the assets and activities allocated to Falkirk Council and Falkirk Football and Athletic Club (FFAC).

Councillor Gow, seconded by Councillor C MacDonald moved the recommendations in the Report.

By way of an amendment, Councillor Alexander, seconded by Councillor Coleman, moved that:-

- 1. Council re-affirms the strategic objectives of the stadium development as outlined in section 2.3 of the report, including the commitment to complete the stadium development
- 2. Council agrees the restructuring of the current Joint Venture Company into three separate companies as outlined in section 7.1 of the Council report, as the first stage of the re-invigoration of the partnership between Falkirk Council and Falkirk Football Club that has delivered so much so far.
- 3. Council believes that this can best be achieved with the following mission statement and actions:
 - i. The establishment of an all party and dual partner Working Group to take forward the development of the stadium company with, in principle, Henry Boot as the preferred developer, subject to compliance with the Council's statutory obligations
 - ii. The original clause contained in the joint venture agreement between Falkirk Council and FCSL offered the option of the remaining 29 acres should this be required to achieve the strategic objectives of the project. Council believes, in principle, that although FCSL is being dismantled the principle of using the whole 70 acre site for the achievement of the strategic objectives, including the completion of the stadium itself, is one Falkirk Council wishes to endorse.
 - Objectives of the restructuring proposals are to recognise the respective investments made by the joint venture partners and the repayment of outstanding debt to Falkirk Council. However, if there is any surplus profits from the development of the 70 acre site it would be the Council's intention to reinvest it in the strategic objective, including the completion of the stadium.
 - iv. That Falkirk Council will become fully engaged in the partnership to achieve all strategic objectives including the construction of the East Stand.
 - v. These actions and conditions may alter in the future on the basis of agreement between both partners.
- 4. Officers will report back progress on the objectives above to Council on a regular basis.

Following discussion there was an adjournment to consider the terms of the Motion and Amendment. Council thereafter re-assembled with all Members present, per the sederunt.

In terms of Standing Order 21.4 (i) a vote was taken by way of a roll call, there being 30 Members present, with Members voting as undernoted:-

1. INTRODUCTION

1.1 Members will be aware that Post Office Ltd published plans on 19 August 2008 outlining the future of the Post Office Network in Linlithgow and Falkirk East Parliamentary Constituency. This report notes the proposal to close Grangepans post office in Bo'ness and sets out a proposed response to this.

2. THE PLANS

- 2.1 The following post offices are covered by the plans recently published:
 - Avonbridge;
 - Bo'ness;
 - California;
 - Charlotte Dundas Court;
 - Grangemouth;
 - Grangepans;
 - Limerigg;
 - Maddiston;
 - Maidenpark;
 - Newtown;
 - Slamannan; and
 - Whitecross
- 2.2 Post Office Ltd has proposed that Grangepans is to close. The closing date for responses to the proposal is 23 September 2008.

3. NETWORK CHANGE PROGRAMME

- 3.1 The criteria that Post Office Ltd use to assess each post office are as follows and this covers the whole of the UK:
- 3.2 Nationally
 - 99% of the total UK population within 3 miles, 90% within 1 mile;

- 95% of total urban populations within 1 mile (urban classed as settlement more than 10,000);
- 95% of total rural population within 3 miles (rural is classified as settlement less than 10,000);
- 99% of urban deprived within 1 mile (15% of UK postcode districts); and
- Proportionality, such that no group or area plan should be more adversely impacted than any other (hard to do as announcements made on rolling programme but split should be 50/50 urban / rural).

3.3 Local factors

- Availability of parking and public transport (to and from post office);
- Local demographics (age/disability/car ownership/income); and
- Impact on local economies.
- Once plans are published, there is a six week period during which the public and the Council can respond to these proposals. As part of this process we have already put the proposals on the Council web-site. Experience from the previous consultation exercise would suggest that account is taken of the volume and number of representations made regarding each post office. It is therefore important that where local people feel strongly about any closure plans, they make their feelings known to Post Office Ltd. However, Members should be aware that generally, if a post office is retained, an alternate post office branch is nominated for closure.

4. CURRENT SITUATION

- 4.1 Prior to the plan being announced, Postwatch estimated that, if there was an even distribution of closures across the UK, 17.5% of post offices would close in every area. That would equate to approximately 5 post offices in the constituency of Falkirk and 3 in Falkirk East. As Members will recall, 7 post offices were closed in the Falkirk constituency, while only one post office is identified for closure in this round.
- 4.2 The Post Office Ltd has provided Branch Access Reports on the post office proposed for closure and the post offices that they anticipate local residents would use if this post office is closed. This access report is attached as Appendix 1.
- 4.3 The following paragraphs note some of the points the Council will make when presenting the case for the retention for Grangepans post office.

Grangepans

4.4 Grangepans post office is situated within Bo'ness. The post office is open 38 hours per week and is within a small convenience store. Post Office Ltd has suggested that there are two alternative post offices, the first post office is 0.7 miles away in Bo'ness Town Centre and the second is 0.9 miles away is in Newtown in Bo'ness. Post Office Ltd has provided information on the bus services from the bus stop 110 yards from Grangepans post office to Bo'ness post office. A half hourly bus service runs between these two post offices this has been confirmed by the Transport Planning Unit. There are plans to develop and enhance Bo'ness town centre over the next few years and the population of Bo'ness is expected to increase significantly.

- 4.5 According to the 2006 estimates of population, there are 9,250 people living within 1 mile of Grangepans post office. Of these 16.3% are aged above 65 years. This compares to the Falkirk Council and the Scottish average of 15.8% and16.4% respectively. 18.6 % of those living within a one mile radius of Grangepans post office are claiming State Pension, this compares to 18.3% of the population of Falkirk Council and the Scottish average of 19%.
- 4.6 The table below contains information from the census on the percentage of the population living within one mile of Grangepans post office with poor health. It is assumed that these individuals would find it more difficult to travel even short distances to access services.

4.7 The one mile radius catchment of the Grangepans post office consists of sixteen datazones or part datazones, one of which is in the worst 15% in Scotland. Of the datazones within one mile of the Grangepans post office, access to a post office is above the Falkirk average (2.1 minutes) and the Scottish average (2.2 minutes) in three datazones. Public transport travel time to a Post Office is also above the Falkirk average (6.7 minutes) in four datazones and the Scottish average (8.2 minutes) in two datazones. Closing the Grangepans post office will undoubtedly make these access measures significantly worse. An analysis carried out by the Council shows that there are currently 135 households within the Falkirk Council area outwith a 3 mile radius of Grangepans post office and it would be expected that Grangepans would be the first choice post office. If Grangepans were to close, an additional 101 households will now be outwith a 3 mile radius of a Post Office.

5. WAY FORWARD

- 5.1 The Council recognises the important social function that post offices provide. In our communities, the post office can also be the main village or local shop. These post offices are used by older people, people with young children and those with mobility problems, for a whole variety of transactions, not just economic, but social.
- 5.2 The 6 week consultation process began on 19 August 2008. At the time of writing, analysis on each of the post offices has only just begun. Officers are continuing to develop a case for retention for Grangepans to supplement the information contained in section 3. This will be presented to Post Office Ltd by 23 September 2008, the closing date for submissions.

5.3 Council Officers have written to Community Council in Bo'ness and Blackness alerting them to the potential closure, with information about how they can respond to these.

The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher level.

1. INTRODUCTION

1.1 This report reviews the current policy and seeks approval to amend the criteria for the provision of on street parking bays for people with a disability.

2. BACKGROUND

- 2.1 People with a disability can apply to the Council for a blue badge under the Blue Badge Scheme. The scheme is a national arrangement of parking concessions for people with severe walking difficulties who travel either as drivers or passengers of a motor vehicle. The scheme also applies to registered blind people and people with very severe upper limb disabilities who regularly drive a vehicle but cannot turn a steering wheel by hand.
- 2.2 Falkirk Council currently provides on-street parking spaces in residential areas, enforceable by virtue of a Traffic Regulation Order, for people with a disability who are in receipt of a Blue Badge, meet the Council's criteria and, due to parking congestion, have difficulty parking near their homes.
- 2.3 There are approximately 7500 Blue Badge holders in the Falkirk Council Area. Falkirk Council receive 150 or so disabled parking bay applications each year, at least half of which meet current criteria and require the promotion of a Traffic Regulation Order.
- 2.4 In order to provide disabled parking spaces on the road, Falkirk Council, as Roads Authority, employs powers conferred on it under Sections 32(1) and 35(1) of the Road Traffic Regulation Act 1984. The Roads (Scotland) Act 1984 defines a road as any thoroughfare over which there is public right of passage. Occasionally, applications for disabled bays are received for locations that do not meet the above definition. Under these circumstances the Roads Authority cannot provide disabled spaces and will direct the applicant to either Housing Services within the Council, a housing agency or a sheltered housing operator whoever manages the proposed location and can provide and enforce a disabled bay using whatever powers they have over the location.
- 2.5 The Disability Discrimination Act 2005 does not require Local Authorities to specifically provide residential parking bays for people with a disability. The act places a general duty on public authorities to actively look at ways of ensuring disabled people are treated equally and one of Falkirk Council's main goals is to reduce disadvantage and inequality in all its forms. On-street disabled persons' parking places helps to address these concerns.

- 2.6 From a sample of other Scottish Councils, it appears that most provide disabled bay markings. Approximately, half of these Councils make their bays enforceable by the promotion of a Traffic Regulation Order while the remainder use advisory markings only.
- 2.7 Falkirk Council's current policy governing the provision of on-street parking spaces for disabled people was ratified by Central Regional Council and dates back to 1991. The criteria currently used to determine applications are:
 - The applicant must be resident at the address where the marking is to be provided.
 - The vehicle must normally be kept at this address.
 - The applicant must be in receipt of the Mobility Component of Disability Living Allowance (DLA) at the higher rate or be eligible for it except on the grounds of age.
 - There must be a persistent difficulty in parking at the location.
 - Applications must be subject to road safety criteria, in terms of ensuring any disabled persons' parking bay does not, for instance, restrict visibility at a junction or be placed in such a manner as to cause congestion or obstruction.
 - The Policy and Resource Committee meeting of September 2005 added a further criterion to be assessed during the application process. This additional step required all applicants to be assessed by a physiotherapist.
- 2.8 In addition, Members, at the September 2005 Committee meeting, also tasked officers with reviewing the current policy and reporting the findings back. During the initial review of the policy in 2006, Jackie Baillie MSP consulted throughout Scotland on disabled parking places with a view to introducing a Bill to the Scottish Parliament. It was felt prudent to delay the review of the Council's policy until the Bill was introduced to Parliament and report to members at that time.
- 2.9 The Bill has taken longer to be introduced to Parliament than anticipated. On 2 June 2008, Jackie Baillie MSP introduced a Members Bill to the Scottish Parliament entitled 'The Disabled Persons' Parking (Scotland) Bill'. The aim of the Bill is to make disabled persons' parking places legally enforceable, preventing the misuse of such parking places by those not entitled to use them. In its current form, the Bill would make all disabled persons' parking places legally enforceable. All disabled bays maintained by Development Services, both on street and off, are covered by a Traffic Regulation Order and are therefore already legally enforceable. The Bill would also place a duty on local authorities, who have made Traffic Regulation Orders in respect of disabled parking places, to keep the provision of those parking bays under continual review. In addition, it also makes reference to the local authority enforcement of disabled spaces in private car parks such as retail parks and supermarket car parks.
- 2.10 The Bill is currently at the first of three stages with no formal timescale available for completing all the stages. The first stage is due to be completed by November 2008 and, if the Bill follows similar timescales for other Bills, completion could be Spring 2009.

- 2.11 It is recognised that, following completion of the Bill's progress through the Scottish Parliament, significant changes may be required by the Council in the way it manages disabled persons' parking spaces. However, there are two specific issues which can usefully be addressed now. These are:
 - The requirement to assess the level of disability of all applicants by a physiotherapist.
 - The way that the level of disability is assessed for children.
- 2.12 Currently, all applicants for a disabled bay must be assessed by a physiotherapist to determine their levels of disability as part of the application procedure. The current assessment is intended to determine whether the applicant would be eligible for the Mobility Component of DLA at the higher rate. However, in order to obtain a blue badge, some applicants have already demonstrated that they are in receipt of the Mobility Component of DLA at the higher rate. These applicants for Disabled Persons' Bays therefore need not be referred to the physiotherapist since they can show that they already receive the Mobility Component of DLA at the higher rate. It is therefore proposed that only those applicants who hold a Blue Badge but are not in receipt of DLA at the higher rate because of their age (over 65) be assessed by a physiotherapist.
- 2.13 There are problems assessing children by mainstream physiotherapists. Consequently, it is proposed that only child applicants who hold a Blue Badge but are not in receipt of DLA at the higher rate because of their age (under 3) be assessed by a paediatric therapist.

3 CONCLUSIONS

- 3.1 In light of Falkirk Council's goals and the success that this policy has had in enhancing the circumstances of disabled people it is concluded that Falkirk Council continue to provide help for disabled people in the form of enforceable residential disabled parking bays.
- 3.2 The Disabled Persons' Parking (Scotland) Bill, in its current form, will have implications for the Council in the provision and/or enforcement of disabled persons' parking spaces, both on-street and off-street. The Bill may change the way the Council is required to manage disabled persons parking and a further report will come to this Committee following the passage of the Bill through Parliament.
- 3.3 In the meantime, recognising that future changes may be required as a consequence of the Bill, it is concluded that Falkirk Council continues to provide disabled persons' parking bays to holders of a Blue Badge subject to the criteria generally as paragraph 2.7 with changes to the physiotherapist assessment requirement as follows:
 - Applicants not eligible for DLA at the higher rate on grounds of age to be assessed by a physiotherapist or paediatric therapist, as applicable, depending on their age.

4. **RECOMMENDATIONS**

Members are asked to;

- 4.1 agree the continued provision of enforceable residential parking bays;
- 4.2 agree the continued use of the criteria set out in paragraph 2.7, as amended by 4.3 and 4.4, be used in the assessment of this provision;
- 4.3 agree and recommend to Policy and Resources Policy Committee, that only those applicants over the age of 65, not in receipt of the Mobility Component of DLA at the higher level, will be assessed by a physiotherapist. The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher level;
- 4.4 agree and recommend to Policy and Resources Policy Committee, that applications relating to disabled children under the age of 3 will require assessment by a paediatric therapist. The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher level;
- 4.5 note that a future report will come to members following the passage of The Disabled Persons' Parking (Scotland) Bill through the Scottish Parliament.

1. INTRODUCTION

- 1.1 The current legislative framework governing how local authorities must handle school closure proposals is set out in both primary legislation (The Education (Scotland) Act 1980) and secondary legislation (the Education (Publication and Consultation Etc.) (Scotland) Regulations 1981). This is supported by Ministerial Guidance on school closure proposals which was last published in 2004.
- 1.2 The Scottish Government are currently consulting on proposals to update and consolidate this legislative framework, and the proposal document is attached as Appendix 1.
- 1.3 These proposals focus on school closures, particularly in rural areas, but it should be noted that the legislation to be updated also includes that relating to rezoning a school's catchment area, provision of a new school, changing the site of a school and all other kinds of proposal detailed in the 1981 Regulations.
- 1.4 The consultation period ends on 19 September 2008. Members are asked to consider the proposed detailed response from Falkirk Council which is attached as Appendix 2.

2. SUMMARY OF CONSULTATION RESPONSE

- 2.1 The consolidation and update of the legislative framework is welcomed and this is reflected in our proposed response. We do however present a number of suggestions and concerns, the main ones being:
 - that, whilst safeguarding of rural schools is very important, a revised approach to school closures should also encompass schools that are not classified as rural;
 - with regard to the proposal that there will be a requirement for local authorities to prepare an Educational Benefits Statement when proposing a school closure, we suggest that this should not be considered in isolation, but set within the context of a Strategic Business Case that also considers the community, financial and resourcing issues;
 - that HMIE should consider the Educational Benefits Statement as part of this Strategic Business Case;
 - that the proposed approach to consulting on school closures and other matters will lead to a consultation period that will become too lengthy;

- that if referral of school closures to Ministers on the basis of high occupancy (80% or above) is to continue, then clear guidance is required on the calculation of school capacity.
- 2.2 Details of how the Scottish Government's eight categories of urban/rural classification apply to Falkirk Council's primary school are attached at Appendix 3.

3. RECOMMENDATIONS

- 3.1 With regard to the consultation on Scottish Government proposals to update legislation relating to school consultation procedures, Education and Leisure Committee are asked to:
 - (i) agree the response outlined in paragraph 2.1 and detailed in Appendix 2; and
 - (ii) agree to refer to Policy and Resources Committee for approval prior to submission.

SAFEGUARDING OUR RURAL SCHOOLS AND IMPROVING SCHOOL CONSULTATION PROCEDURES

PROPOSALS FOR CHANGES TO LEGISLATION

A Consultation Response From Falkirk Council

Falkirk Council welcome the Scottish Government's proposal to update and consolidate the primary and secondary legislation and supporting guidance framework relating to proposed school closures, rezonings and other major changes affecting schools.

Whilst we agree that it is important to highlight the importance of rural schools as a community asset, we do feel that the consultation document over-emphasises this and the broader framework proposed for preparing the case for and consulting on school closures should also apply to schools in the non-rural setting. We also feel that separately dealing with Educational Benefits and Community Impact would miss the opportunity to legislate in a way that ensures local authorities prepare an overall Strategic Business Case for any proposed closure that also encompasses financial and resourcing implications.

We also have some concerns that the proposed framework unnecessarily extends the timescales required for a consultation on school closures and other matters. Such consultations create anxiety amongst parents in particular, and it is important that they are resolved as quickly as possible, ensuring that all stakeholders can be fully consulted.

The outcome required from new legislation is an effective process for consultation that does not take too long, balanced against the need for a full and open consultation.

Our response to the specific questions asked in this consultation are as follows:

RURAL SCHOOL CLOSURES (SECTION 3)

Q1: Do you support the proposal to require local authorities to have regard to certain matters before they can respond to consultation on the closure of a rural school?

- Yes, it makes sense to legislate for a consistent and transparent approach to school closures. However, yhy focus this approach at rural schools only when there are lots of closures and mergers within the non-rural setting affecting many stakeholders?

Q2: Do you agree with the four matters we propose requiring that authorities should have regard to before proposing a rural school closure? These are:

- Alternatives to a closure of the school
- Likely overall impact of the school's closure on the communities which it serves
- Likely impact of closure specifically on the community's subsequent use of the school's building and grounds
- Likely impact that new travel to school patterns would have on pupils and other school users and the environment
- We agree that the 4 criteria suggested are relevant, however, we feel that they would also be important considerations in the proposed closure of a non-rural school.

- The assessment of impact on the community would be very difficult to gauge, and even with the results of the consultation this could be very subjective. As it would be impossible for any Authority to fully answer this question at this early stage it should not be incumbent on them to do so.

Q3: Do you agree that it is not appropriate to set up a rural schools fund?

Yes we agree that it would not be appropriate.

Q4: Do you agree with the proposed definition of "rural schools"?

- Yes. This definition successfully classifies the Falkirk Council schools currently considered "rural".

AN EDUCATIONAL BENEFIT STATEMENT (SECTION 4)

Q5: Do you support requiring local authorities to publish a statement setting out the educational benefit of the school closure proposal?

- Yes. However, this is one element of the overall business case for any proposed closure rather than a completely separate matter.
- We feel that the prescribed elements for a school closure proposal should include an Educational Benefit Statement and the four criteria specified in Section 3, together with the financial and resourcing reasons for proposing closure.
- Together, these six elements would form a Strategic Business Case that encompasses and considers all important issues.

Q6: Do you agree that it should be left to the authority as to how it sets out an educational benefit statement?

- We feel that there should be an agreed template for an overall Strategic Business Case for any school closure. The educational benefits element should be one of the 6 integral parts of this.
- It should be up to each local authority to complete each of these 6 elements, but, given the radical changes being proposed, an example or guidance on what local authorities should include or exclude in such a business case would be welcomed to ensure a consistent approach across Scotland based on best practice.
- HMIE are in an ideal position to provide advice on addressing the educational benefits of a school closure.

<u>TIGHTENING THE REGULATIONS FOR ALL SCHOOL CONSULTATIONS</u> (SECTION 4)

Q7: Do you agree that HMIE's views should be sought in all cases?

- No. It makes sense that HMIE scrutinise the educational benefits of any proposed school closure during the consultation process and they should be asked to comment within the context of the overall Strategic Business Case.
- However, HMIE would add little value to other statutory consultations on issues such as rezoning, so their involvement across the board would be unnecessary.
- The suggestion in paragraph 63 implies that local authorities should provide HMIE with an interim report showing the feedback from the consultation, to enable HMIE to respond. We feel that this is completely unnecessary as HMIE should be consulted on the Strategic Business Case. We also feel that this would add unnecessary time delays to the whole process (see also response to Question 8 below).

Q8: Do you support the proposed changes to the way consultations should be conducted? These are:

• Introducing a requirement that a consultation paper should be published containing certain information;

- At Falkirk Council we already do this and report this fully to Council.
- Any new regulations should align "certain information" with the considerations specified in Section 3 and Section 4, which we have earlier suggested is encompassed within an overall Strategic Business Case.

• Establishing a mechanism for addressing allegations of factual inaccuracies in a consultation paper;

- This would ensure transparency, but legislation should be carefully worded to exclude matters of subjective, financial or statistical interpretation.
- It should only be the material facts that fall into this mechanism.

• Extending the list of people who must be consulted;

- Other local authorities should only be consulted where a cross-border agreement exists to accommodate pupils from their area at an affected school.
- There should be no statutory obligation to consult staff on the reasons for a proposed closure. It should only be the parties affected by Education delivery. Staff would be consulted by management as part of the normal internal processes for these matters.

Updating the way consultations are publicised;

- There should be no obligation to publicise the consultation in areas other than the school catchment. Some school rolls include pupils from a range of areas on placing requests and they should not define the area for publicising a consultation.
- For example, if an school proposed for closure or rezoning had a pupil who lived in Fife, we should not be obliged to publicise the consultation in the Fife press.

• Updating how people respond to a consultation;

- The proposed approach is consistent with our current consultation process.

• Extending the minimum consultation period to 6 weeks of term time;

- We feel that 4 weeks is sufficient but agree that no consultation should take place during the summer holidays.
- Consultations on school closures create anxiety amongst parents and it is important that they are resolved as quickly as possible.
- We feel that extending the consultation period to 6 weeks, particularly excluding all school breaks, would result in a process that takes too long.

- Introducing a requirement that the authority publish a consultation report, 28 days before the final decision is taken.
- We do not agree with this. We feel that it will introduce a further delay in the decision making process when combined with committee cycles, extending the period between the consultation starting and a decision being made to at least 10 weeks, and probably 4 to 6 months in practice when combined with a council's decision making structures.
- For school closures and major catchment reviews this can be planned for, but for smaller matters such a lengthy consultation process may lead to operational problems.

Q9: Do you agree that Ministers should take a power to issue "statutory guidance" to which authorities would have to have regard?

- Yes. Clear and binding guidance would be useful in establishing procedures and ensuring a consistent approach nationally.
- Non-statutory guidance is open to interpretation and omission. This will inevitably create doubt, confusion and inconsistency. (ie. guidance on calculation of school capacity)

A REFERRAL SYSTEM (SECTION 5)

Q10: Are you content with the present system of referral of closure cases to Ministers?

- No. Our main concern with the current system is that referral on the basis of occupancy levels relies on a definition of school capacity that is different for every authority. A more standardised approach would be preferable if occupancy levels continue to trigger referral to Ministers. As there is no national standard for calculating school capacity, this would need to be urgently addressed to reinforce this referral method.
- The distance criteria would not apply to Falkirk schools, so other, more rural authorities are in a better position to comment here.

Q11: If not, what changes would you wish to see made, and why?

- If the 80% rule is still to apply, then clear guidance on the calculation of a school's capacity and occupancy should be given to ensure a standard of approach by all authorities.

Q12: Do you agree with the proposal to place the responsibility on authorities to satisfy themselves regarding the provision of denominational education?

- Yes.

If so, do you agree with the proposal to continue to allow referral to Ministers if the church or denominational body has an objection?

- Yes, but we feel that such objections should only be made when the church/denominational body has an issue with the consultation process itself. (The consultation process itself should allow the view of churches/denominational bodies and other interested parties/organisations to be fully considered and appraised if it has been properly conducted.)

Q13: Do you agree with our proposal that in future only school closure cases should be referable to Ministers?

- Yes.

1. PURPOSE OF REPORT

1.1 The purpose of this report it to submit a revised Scheme of Delegation in line with the decisions agreed by Council in June 2008 and the Housing and Social Services Committee in September 2008.

2. BACKGROUND

2.1 At the meeting of Falkirk Council on 25 June 2008, Members agreed the following:

"Standing Orders to be revised to allow Scrutiny Committees to respond directly to consultation papers etc within their remit to take decisions on issues that do not change or materially alter Council policy or involve additional resources or changes to the establishment."

2.2 On 2 September 2008 the Housing and Social Services Committee, on consideration of a report prepared by the Director of Corporate and Neighbourhood Services on "The Registration of Private Landlords", approved the recommendation that "decisions other than the refusal of applications for registration and revocation of any such registration which will be reserved to the Civic Licensing Committee, will be taken by officers." The Committee agreed that this decision be referred to Council for approval in respect of the amendments to the Council's Scheme of Delegation, to reflect the delegation of decision making power.

3. SCHEME OF DELEGATION

- 3.1 There are three additions required to the Scheme of Delegation which are:
 - Policy & Resources Committee; revise paragraph 9 insert text to read: "which materially alter existing Council policy or involve additional resources or changes to the establishment" (Appendix 1)
 - Powers of Scrutiny Committees insert new paragraphs to become paragraphs 2 and 3, namely:-
 - Paragraph 2 The Scrutiny Committees will authorise appropriate responses to consultation documents submitted to the Council in accordance with the remit of each Scrutiny Committee.
 - Paragraph 3 Scrutiny Committees will decide upon any matter within their remit providing that the decision does not change or materially alter any Council policy, or involve additional resources, or changes to the establishment. (Appendix 2)

• **Civic Licensing Committee** – revise paragraph 1 by inserting the text highlighted below and insert new paragraph 3, namely:-

Paragraph 1 - To discharge the Council's regulatory and enforcement functions, in accordance with Council policy with the exception of those matters delegated to the Director of Development Services and listed in paragraph 2 and to the Director of Corporate and Neighbourhood Services as listed in paragraph 3 hereunder and so far as not delegated to any other Committee or officer which relate (but not exclusively) to:

(i) the functions of the Council in relation to all licensing matters under the Civic Government (Scotland) Act 1982 and all other Acts covering personal or other licences, certificates and permits (excluding all matters dealt with by the Licensing Board), including licences and permits in respect of cinemas and theatres, betting, gaming and lotteries, taxis, charitable collections, animal boarding establishments, riding establishments, second-hand dealers, boat hirers, places of public entertainment and the registration of landlords.

Paragraph 3- The Director of Corporate and Neighbourhood Services is authorised to exercise all decisions relating to the registration of private landlords except for the refusal of applications for registration and the revocation of registration which will be reserved to the Civic Licensing Committee. (Appendix 3)

SCHEME OF DELEGATION TO COMMITTEES

POLICY AND RESOURCES COMMITTEE

Terms of Reference

- 1. To be the Council's main instrument of policy, to give strategic policy direction in relation to all the Council's functions and to have overall responsibility for implementing agreed policies and strategies.
- 2. To initiate debate and analysis on substantial policy issues which relate to the Council's functions or have a significant impact on the Council area or its residents.
- 3. To determine such substantial policy issues after debate and analysis by other Council Committees.
- 4. To decide other policies and strategies to meet the Council's overall objectives.
- 5. To set the overall policy framework for other Committees, to refer reports and issues for consideration to those Committees and to receive reports from them.
- 6. To determine all matters relating to capital and revenue financing and borrowing and to recommend to Council an overall financial strategy, the annual revenue and capital budgets and the rate and Council tax to be levied.
- 7. To ensure that the organisational, administrative and management procedures of the Council are such as to make the most efficient contribution to achieving the Council's objectives and to keep these procedures under review in the light of changing circumstances.
- 8. To review the effectiveness of the Council's work and policies and the standard and level of services provided.
- 9. To consider any new policies or changes in policy which materially alter existing Council policy or involve additional resources or changes to the establishment suggested by any other Committee and the effect of these on the policy plans and resources of the Council.
- 10. To be responsible for all matters relating to employees of the Council and their terms and conditions of employment and terms of service.
- 11. To monitor budget performance.
- 12. To set strategies for partnership and influence outside the Council.
- 13. To deal with service delivery and the discharge of all Council functions.

Scrutiny Committee Powers

- 3. The Scrutiny Committees will authorise appropriate responses to consultation documents submitted to the Council in accordance with the remit of each Scrutiny Committee.
- 4. <u>Scrutiny Committees will decide upon any matter within their remit providing that the decision does not change or materially alter any Council policy, or involve additional resources, or changes to the establishment.</u>
- 5. The Scrutiny Committees will develop policy proposals referred to them by the Policy and Resources Committee or by Council, within their own terms of reference. The Scrutiny Committees will:-
 - (i) Receive policy proposals from the Policy and Resources Committee;
 - (ii) Identify the main issues to be addressed;
 - (iii) Identify the primary means by which they should be addressed;
 - (iv) Identify the appropriate financial implications;
 - (v) Report back to the Policy and Resources Committee;
 - (vi) Propose policy objectives to the Policy and Resources Committee;
 - (vii) Review, monitor and make determinations on specific policy and service delivery issues referred to it by the Policy and Resources Committee;
 - (viii) Investigate, monitor, oversee and comment on how Council services are delivered and any other matters where the Council has powers or duties or which affect the Council area or its residents and which have been referred to it by Policy and Resources Committee.
- 6. As part of this process, the Committees may undertake public consultation to influence the development of the policy proposals. They will have the power to agree appropriate mechanisms for this process, such as holding public meetings, setting up focus groups or panels, or inviting persons with particular expertise in areas being considered by Committee to address the Committee or to take part in meetings.
- 7. The Scrutiny Committees:-
- (a) Where a Scrutiny Committee has been granted decision making powers in respect of any item of business and is exercising these powers (i.e., where the committee is not reporting back to Policy and Resources Committee or Council) and where there is a vote (with the exception of those votes on procedural motions defined in Standing Order 24.1) and where at least one quarter of those members present and voting dissent against the decision, the decision will be referred to either a special meeting of the Council or the next scheduled meeting of the Council if, within three working days of the committee meeting, at least one quarter of those present and voting and who dissented intimate in writing to the Director of Law and Administration the desire to follow such a route. If,

after three working days have elapsed there is no such intimation then the matter will be considered to have been settled by the Committee.

- (i) will receive policy development proposals or policy issues within their terms of reference from the Policy and Resources Committee;
- (ii) will consider the proposals or issues and report on them to the Policy and Resources Committee within the timescale set by Policy and Resources;
- (iii) will have those decision making powers specifically delegated to them by Council or by Policy and Resources Committee;
- (iv) will have power to regulate their own proceedings.
- 8. In considering the proposal or issue, the Scrutiny Committee:-
 - (i) will identify the main issues to be addressed, the primary means by which they should be addressed and any financial implications;
 - (ii) may work in partnership with outside bodies in the public, voluntary and private sectors;
 - (iii) may establish working groups, and joint working groups with outside bodies, and consider their reports; and
 - (iv) may consult the public or sections of the public, and establish mechanisms for this purpose.
- 9. In reporting on the proposal or issue, the Committee should comment on it and may propose amendments.
- 10. No member of the Policy and Resources Committee may be a standing Member of a Scrutiny Committee.
- 11. The Scrutiny Committees may not establish Sub-Committees of the Council nor delegate decisions to officers of the Council, unless authorised by Council or the Policy and Resources Committee.
- 12. Without prejudice to any other power, to the extent that any of the respective areas of remit of the Scrutiny Committees cover any of the client functions of the Council's Direct Labour/Service Organisations, each of the Scrutiny Committees so involved will be responsible directly to Council for monitoring and reviewing the performance of the Direct Labour/Service Organisations within the respective terms of reference of the Committees.

CIVIC LICENSING COMMITTEE

Terms of Reference

- 1. To discharge the Council's regulatory and enforcement functions, in accordance with Council policy with the exception of those matters delegated to the Director of Development Services and listed in paragraph 2 and to the Director of Corporate and Neighbourhood Services as listed in paragraph 3 hereunder and so far as not delegated to any other Committee or officer which relate (but not exclusively) to:
 - (i) the functions of the Council in relation to all licensing matters under the Civic Government (Scotland) Act 1982 and all other Acts covering personal or other licences, certificates and permits (excluding all matters dealt with by the Licensing Board), including licences and permits in respect of cinemas and theatres, betting, gaming and lotteries, taxis, charitable collections, animal boarding establishments, riding establishments, second-hand dealers and boat hirers, places of public entertainment and the registration of landlords.
 - (ii) the functions of the Council under the Safety of Sports Grounds Act 1975.
- 2. The Director of Development Services is authorised to determine the following licensing matters:
 - (i) to grant taxi drivers and private hire car drivers licences, and taxi and private hire car operators licences, on advice from the Chief Constable that there are no current and where there are no objections; provided that applications for second or subsequent licences for the same applicant will be referred to the Civic Licensing Committee;
 - (ii) to renew taxi drivers and private hire car drivers licences, and taxi and private hire car operators licences, if there are no new convictions since the Civic Licensing Committee's last consideration of the matter (whether in connection with a grant, renewal or default report);
 - (iii) to grant licences for second-hand dealers, window cleaners and street traders, on advice from the Chief Constable that there are no current convictions, and no objections; provided that applications for second or subsequent licences for the same applicant will be referred to the Civic Licensing Committee;
 - (iv) to renew licences for second hand dealers, window cleaners, street traders, market operators and late hours caterers, if there are no new convictions or adverse information received since the Civic Licensing Committee's last consideration of the matter and the licence sought is the same as the licence previously granted;
 - (v) to grant and renew boat hirers, public entertainment, indoor sports entertainment and houses in multiple occupation licences, subject to no objections;
 - (vi) to grant and renew permits for amusements with prizes machines in premises other than hotel and public houses, where they are outwith the class of premises

- specified in the Council's resolution and there are no objections or adverse comments received;
- (vii) to grant or renew permits to install all-cash amusements with prizes machines in amusement arcades where there are no objections or adverse comments received;
- (viii) to grant and renew licences for pet animals, dangerous wild animals, game dealers, venison dealers, riding establishments, animal boarding establishments, breeding of dogs, methylated/surgical spirits and film exhibitions subject to no objections or adverse comments being received from the Chief Constable, Firemaster or Head of Environmental and Consumer Protection;
- (ix) to determine applications to licence caravan sites where there are no objections or adverse comments received;
- (xi) to determine applications for permission to hold public processions
- (xii) to determine applications for approval of premises under the Marriage (Scotland) Act 2002 and any associated Regulations; and
- (x) to approve applications for the registration of society lotteries in accordance with the Lotteries and Amusements Act 1976 where there are no current convictions and no objections.
- 3) The Director of Corporate and Neighbourhood Services is authorised to exercise all decisions relating to the registration of Private Landlords except for the refusal of applications for registration and the revocation of registration which will be reserved to the Civic Licensing Committee.

Provided that if, for any reason, the Director of Development Services or the Director of Corporate and Neighbourhood Services considers it inappropriate to determine an application under delegated powers, the application will be referred for determination to the Civic Licensing Committee.

1. PURPOSE OF REPORT

1.1 The purpose of this report is to advise Members of:

- (a) the establishment of COSLA's Community Safety Executive Group and to invite Council to nominate a Member to the Group and
- (b) a request to nominate a representative to join the BID (Business Improvement District) Management Group

2. COSLA COMMUNITY SAFETY EXECUTIVE GROUP

- 2.1 COSLA indicated during the summer its intention to establish a new Executive Group to deal with matters relating to community safety. In particular, COSLA intended to establish a mechanism which would integrate the policy development and lobbying activity of the core of local government with Police, Fire and Criminal Justice authorities. It identified a number of issues such as police/fire pension shortfalls and commutations which could have a financial impact on both local and police/fire authorities. The intention is to establish a forum with a strong cohesive voice to address such issues.
- 2.2 Since the summer matters have progressed rapidly. It was felt by COSLA that there were a significant number of current issues in the Executive's work area which demand a single cohesive local government voice if services, resources or both were to be protected and as such there was an urgency in setting up the Group. It was proposed by COSLA that the most practical means of establishing the Group was to set it up quickly as a Pilot and to monitor its progress, making any changes as necessary and then establishing it constitutionally when this work was completed.
- 2.4 To that end the first meeting of the Pilot Group was called recently. The proposed membership is as follows:

- 1 COSLA Spokesperson

- 2 COSLA Vice-Presidents
- 4 Fire Conveners

- 2 Representatives from the Association of Chief Police Officers in Scotland (ACPOS)

3. BUSINESS IMPROVEMENT DISTRICT (BID)

- 3.1 Members will recall the establishment of a BID in Falkirk following the successful ballot announced in May. A BID is a business led initiative within a defined geographical area where businesses work together to invest collectively in local improvements to their business environments. All businesses within the Falkirk BID area will pay a 1% levy on the rateable value of their premises as detailed in the BID Business Plan.
- 3.2 A nomination is now sought from the Council to join the BID Management Group. There are 12 places on the Group with 5 going to the retail sector, 3 to leisure/hospitality interests, 2 to office/financial and one place each to Falkirk Council and Central Scotland Police. The function of the Group is to play a leading role in delivering the BID objectives over the next three years

1. INTRODUCTION

1.1 Falkirk Council, as lead Authority for the purchasing consortium of Falkirk and Clackmannanshire Councils invited eight tenders for the provision of a dry recyclate segregation service for the two Council areas.

1.2 The report provides Members with information on the tenders, the evaluation exercise and officers' recommendations in respect of the award of the contract.

2. CONTRACT DETAILS

- 2.1 Previous reports to the Environment and Heritage Committee have outlined the obligations upon the Council to meet the targets set out in the National Waste Plan and Area Waste Plan in addition to the requirement to stay within annual Landfill Allowances, which are determined by the Scottish Government.
- 2.2 The Council were required to tender for a facility to process the Council's blue bin material; this is to replace the existing arrangement that ends in October 2008 but can be extended for a short time until 10th November. The tender focused upon the immediate need for processing of all co-mingled dry recyclate collected through the Council's current blue bin collection. The tender also allowed for tenderers to state any additional materials that could be accepted within the blue bin currently available to households. The proposed contract period is from 10th November 2008 to 9th November 2013 with the option of two, one year extensions.
- 2.3 As stated in paragraph 1.1 above Falkirk is acting as the lead authority in partnership with Clackmannanshire Council, however, due to variance in locations and the impact this has on price for the respective authorities, each Council will enter into separate contracts.

3. TENDERS RECEIVED

- 3.1 Seven tenders were received by the due date of Thursday 21st August 2008, and opened in accordance with Standing order 12 relating to contracts.
- 3.2 Seven contractors priced for provision of the service. The checked tendered prices ranged from -£192,500 to £220,000 yearly. The initial contract term is five years and therefore corresponds to a total value of -£962,500. If the contract is extended for a further two years the total value will be -£1,347,500, all assuming the best tender is accepted.

4. TENDER EVALUATION

4.1 Following evaluation of all tenders, the lowest tender received from Re-Gen Waste Ltd offered the best overall solution in terms of quality and price to the Council

From the detailed costs mentioned above the total amount payable to the Council will incorporate all costs associated with the processing of all co-mingled dry recyclate material collected by the authority, resulting in a total income to the Council of £962,500 based on the initial five year contract term.

4.2 As a result of the tender exercise the Council are now in position to expand the amount of materials collected within the blue bin. In the coming months all households will be issued with information regarding the expansion of the accepted materials.

This will assist in improving our waste diversion performance.

5. IMPLICATIONS

Financial

5.1 There are no financial implications other than those already mentioned within the body of the report

Legal

5.2 There are no legal implications other than those already mentioned in the body of the report.

Policy

5.3 The acceptance of a tender including the expansion of the materials accepted within the blue bin is in line with the objectives of the Forth Valley Area Waste Plan and the Strategic Outline Case submitted to the Scottish Government.

Personnel

5.4 The current provider may wish to make an application via TUPE for a transfer of undertakings of any staff employed solely for the operation of this service contract. This will be a matter between the current provider and the new one.

6. **RECOMMENDATIONS**

It is recommended that Members:

- 6.1 In respect of Falkirk Council only and in accordance with Standing Order 6.2(iv), approve the acceptance of the tender submitted by Re-Gen Waste Ltd for the payment of £962,500, for the five years of the contract 10th November 2008 to 9th November 2013 with an option to further extend this contract by a further two one year extensions.
- Note the positive impact increasing the material accepted within the blue bin will have in achieving future waste diversion targets.
