MINUTE of SPECIAL MEETING of FALKIRK COUNCIL held in the MUNICIPAL BUILDINGS, FALKIRK on MONDAY 6 OCTOBER 2008 at 3.00 PM.

FC62. MOTIONS

(a) Gas/Electricity Disconnections

Councillor Meiklejohn, seconded by Councillor Thomson moved that:-

Council notes with some disquiet the content of the recently published Ofgem report. This report indicated that:

- The number of gas and electricity disconnections rose to 8,324 in 2007 from 3,270 in 2006
- The total number of customers not reconnected the same quarter almost doubled to 4,028
- The number of pre-paid meters installed under warrant rose by almost 20,000.

With energy costs rising by double digit inflation this year the situation for those suffering financial hardship will only get worse.

Council believes that these trends are unacceptable and calls on the Westminster government to intervene to change the policy of disconnection through legislation, if required.

Council also calls on our local Westminster representatives to raise the issue with the relevant ministers with a view to the production of an action plan to assist those most vulnerable from power disconnections.

By way of an amendment Councillor C Martin, seconded by Councillor C MacDonald moved that:-

"Council congratulates Ofgem on its prompt action in the face of rising energy prices to call a summit involving all those who have a part to play, to protect the most vulnerable in our society from the impact of these rising costs. By this prompt action we have seen a 16.4% reduction in disconnections in the first quarter of 2008.

Council welcomes the Fuel Poverty Action (plan) 4 point Programme agreed by the Fuel Poverty Summit in April 2008 and is encouraged by the £1b Home Energy Saving Programme announced by the UK Government in September 2008. These actions agreed by Ofgem and Government Ministers will improve the situation greatly for those who find themselves in fuel poverty.

But Council is concerned that major energy suppliers still have a process of disconnections and for this reason instructs the Chief Executive to write to those major energy suppliers urging them to follow the lead of British Gas which has a policy of no disconnections".

In terms of Standing Order 21.4(ii) a vote was taken by way of a roll call, there being 28 Members present, with Members voting as undernoted.

Council recognises the contribution of former Councillor David Bryson to the wider Stenhousemuir community over a period of 33 years service. In particular Council recognises the contribution of David Bryson to the regeneration programme of Stenhousemuir Town Centre through his leadership of the Economic Development Committee and chair of the Stenhousemuir Regeneration Working Group.

Council therefore resolves to formally recognise the contribution of former Councillor Bryson by asking group leaders to work together to explore options such as the naming of the new library after David Bryson as a fitting and lasting tribute to one of Stenhousemuir's most popular and longest serving public servants ever.

FC66. CONTRACT FOR THE PROVISION OF DRY RECYCLATE SEGREGATION AND RESALE SERVICE

There was submitted Report (circulated) dated 1 October 2008 by the Director of Development Services (a) advising that Falkirk Council as lead authority for the purchasing consortium of Falkirk and Clackmannanshire Councils had invited eight tenders for the provision of dry recyclate segregation service for the two Council areas; and (b) providing details on the tenders received, the evaluation exercise and officers' recommendations in respect of the award of the contract.

Councillor Mahoney, seconded by Councillor C R Martin, moved the recommendations in the report.

Accordingly, **RESOLVED** in terms of Section 50A (4) of the Local Government (Scotland) Act 1973, to exclude from the meeting the press and public for the following item of business on the grounds that they would involve the likely disclosure of exempt information as defined in Paragraph 9 of Part 1 of Schedule 7A of the said Act.

In terms of Standing Order 31.1 it was agreed to continue the meeting beyond the 3 hour limit, following a short adjournment for lunch. The meeting adjourned at 1.30 pm and re-convened at 2.10 pm with all Members present per the sederunt with the exception of Councillor Fry, who left the meeting after consideration of Agenda Item 1.

FC70. LEASE OF PREMISES: OFFICE 1, WHOLEFLATS, GRANGEMOUTH

There was submitted Report (circulated) dated 1 October 2008 by the Director of Community Services seeking approval to lease Office 1 at Wholeflats, Grangemouth to Oran Ltd.

Councillor C Martin, seconded by Councillor Lemetti moved the recommendations in the Report.

By way of an amendment, Councillor Alexander, seconded by Councillor A MacDonald, moved, in addition to the recommendation in the Report, that,

" Council believes that the farce of the relocation of Oran has damaged the image of Falkirk Council and compromised the "My Future's in Falkirk" economic development strategy.

The indecision and incompetence of the current Labour/Tory Administration is highlighted by the following timetable,

12 August at the Policy and Resources Committee where the leader of Falkirk Council, Councillor Gow, welcomes the report bringing Oran to the Falkirk Community Stadium then refuses to vote for that report.

22 August at the special full council where the terms of the Policy and Resources report were moved yet speeches made by at least one Labour member indicated opposition to the report although that member then voted for the report.

8 October, the previous decision is overturned.

Council requires both decisive leadership and consistency if it is to continue the progress made under the previous SNP/Independent Administration.

This has not been demonstrated by the current leader of the Council nor the Convener of Economic Development in this matter.

Council therefore believes that the current Labour/Tory Administration have demonstrated that they are incapable of strategic decision making and therefore has no confidence in their ability to perform their economic development remit."

On a division, 15 Members voted for the Motion and 14 for the Amendment.

Accordingly, AGREED

(1) to authorise conclusion of the lease of Office 1 at Wholeflats, Grangemouth between Oran Limted and the Council in satisfactory terms;

- (2) to the application of £185,000 from the General Services Capital Programme (Business Property Reinvestment Fund) for additional works which would be repaid by Oran Limited over the terms of the lease; and
- (3) to authorise the Director of Development Services to instruct the fit-out phase of the works with an additional cost to the contract of f_{2} 250,000.

FC71. SUBSTANCE MISUSE

Committee also notes the outcome of the results of the consultation exercise undertaken by Michael Matheson MSP where 82% of those consulted from across the district want to see the age at which you can purchase alcohol from off sales raised from 18 to 21.

Officers are therefore instructed to open up a dialog with the licensing authority on how a scheme to limit off sales in Falkirk District could be implemented and report back to the next Community Health and Safety Committee meeting".

- (1) Council notes the views of officers that the SNP amendment moved at Committee recognised an anomaly within the existing procedures and therefore accepts that in order to meet the terms of the Council's Equal Equality Police this anomaly should be resolved forthwith;
- (2) applicants not in receipt of the Mobility Component of DLA at the higher level, will be assessed by a physiotherapist. The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher level;
- (3) applications relating to disabled children under the age of 3 will require assessment by a paediatric therapist. The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher lever; and
- (4) all applicants with garages not located at their houses will be assessed by a physiotherapist.

- (4) that applications relating to disabled children under the age of 3 will require assessment by a paediatric therapist. The assessment determines whether the applicant has a disability which is comparable with that required to qualify for the Mobility Component of DLA at the higher level.

NOTED that a future report will come to members following the passage of The Disabled Persons' Parking (Scotland) Bill through the Scottish Parliament.


1. INTRODUCTION

1.1 This report aims to update Members on the review of the Community Wardens Service with proposals for their remit and funding beyond March 2009.

2. BACKGROUND

- 2.1 The Community Wardens Service was funded through the Scottish Executive/Scottish Government's Anti-Social Behaviour fund. In 2008, with the introduction of the Concordat between Local Government, the previous antisocial behaviour Scottish Government ring-fenced funding was incorporated into the Council's budget for 2008/2009. Members agreed to continue funding projects until March 2009, and asked for a specific report on how the Community Warden Service could continue and expand.
- 2.2 The Community Wardens Service funding for 2008/2009 is £494,930, which includes an allocation of £103,000 for a priority response service to the reporting of environmental issues by Community Wardens.
- 2.3 In January 2004, a report was approved by Community Health & Safety Committee detailing the remit of the Community Wardens Service highlighting duties, locations, staffing, costs and management arrangements. The Service was designed to offer a reporting and recording resource in relation to ASB for all housing tenures within Falkirk Council whilst forming links with communities to establish greater community cohesion. The main remit of the Community Wardens is split between crime prevention / community reassurance and environmental.
- 2.4 Initially the Community Warden Service consisted of 1 Community Warden Manager, 8 Community Wardens and 1 Clerical Officer covering Hallglen, Camelon, Grangemouth, and Stenhousemuir and their surrounding areas. As mentioned above the funding included an allocation for the provision of a priority service for environmental reports and clear ups.
- 2.5 Where Community Wardens were based was approved by Committee in 2004 using the following:
 - Deprivation 'hotspots' the Deprivation Index 2003, published by the Scottish Executive, was used in conjunction with Social Inclusion Partnership (SIP) and regeneration information to determine the most deprived areas;

- Housing 'hotspots' information was collated from our housing teams to identify problematic areas, including complaints regarding other residents and problems with anti-social/nuisance behaviour;
- Environmental 'hotspots' information gathered by Estates Management on incidences of littering, graffiti, dumping etc contributed to the identification of areas; and
- Police 'hotspots' police information was sought on areas with above average reporting of crime and reporting of anti-social or nuisance behaviour.
- 2.6 The hotspot information was collated, analysed and mapped out to identify areas that would most benefit from the presence of Community Wardens. Other communities had problematic areas but the four communities above had the highest concentration of antisocial behaviour related problems
- 2.7 From the information gathered at that time, it was determined that the Community Wardens would operate in the following areas :
 - Camelon and Tamfourhill;
 - Hallglen and adjacent area;
 - Stenhousemuir and Carronshore; and
 - Grangemouth.
- 2.8 The Community Warden Manager is responsible for the overall co-ordination of the scheme as well as the day-to-day operational management. The scheme was incorporated into the existing management structure of Housing Services.
- 2.9 In 2006, following analysis of updated information regarding the Council's hotspots, the Service was expanded to include Bo'ness and Denny, and a further 4 staff were appointed, including 1 Senior Community Warden.
- 2.10 The current Community Warden Service staffing structure is illustrated below:



2.11 The key functions of the Community Wardens Service are community reassurance and environmental duties which consist of :-

- High visibility within local communities providing re-assurance to residents;
- Engaging positively with local residents, including young people;
- Reporting incidents of anti-social behaviour or crime to the appropriate Council Service or to the Police;
- Acting as a professional witness;
- Directly reporting environmental problems to the Environmental Wardens;
- Reporting incidences of vandalism, graffiti, needles, etc to the relevant services; and
- Point of contact for local communities' concerns about environmental issues and antisocial behaviour.

3. **REVIEW**

- 3.1 The review looked at the following areas to ascertain the best value to be gained from the Community Wardens Service and the associated funding by:-
 - Comparing current provision with original remit;
 - Comparing original and current hotspot information to determine locations that they require to be operating in post March 2009;
 - Reviewing their roles & responsibilities post March 2009; and
 - Identifying funding post March 2009.

4. FINDINGS

- 4.1 As previously reported to the Community Health & Safety Committee in May 2008, the Community Wardens are providing a high level of reporting of incidents, problems and issues to various Council Services, Central Scotland Police and the Fire & Rescue Service The Community Wardens Service is meeting its original remit and have enhanced the service provision through the development of successful partnership arrangements and increasing resources. In particular, there have been significant partnership developments with Central Scotland Police, The Council's Estates Management Service, Conflict Resolution Service, Detached Youth Work team, Fire Service, Community Traffic Wardens, Education's ILC's .
- 4.2 On reviewing the original list of hotspot locations identified in 2004 and subsequently in 2006, additional areas in Braes, Maddiston and Dawson areas, have been identified as hotspot locations.
- 4.3 As part of the review a consultation process was carried out with all stakeholders. This involved a staff workshop, a workshop with all relevant partners and focus groups with service users. There was consistent feedback from each of these consultation sessions which indicated that the Community Warden Service was a good service that had built up effective joint working and communication arrangements with other agencies. In addition the feedback suggested that the service be expanded to cover more areas and the Community Wardens role should be re-defined and to include additional enforcement responsibilities.

4.4 During the 6 - 20 October, a satisfaction survey was carried out and the findings of this survey will be benchmarked with a similar survey carried out in 2006 in order to identify further proposals for service improvements.

Enforcement Team: Litter and Dog Fouling

- 4.5 The Environmental Enforcement team consists of a Co-ordinator and 8 Enforcement Officers. The majority of funding for this service comes from the Council's mainstream budget, with the ASB budget funding two Environmental Enforcement Officers plus the Co-ordinator's post. Operationally between 4/5 of the 8 officers concentrate on enforcement duties and the remaining 3/4 deal with pest control issues. However, the job descriptions are generic in order to provide flexibility within the management of the various activities undertaken by the teams.
- 4.6 The Enforcement team are responsible for issuing for warning letters and fixed penalty notices for :-
 - Dog Fouling;
 - Litter; and
 - Flytipping.
- 4.7 The teams cover similar geographical areas as the Community Wardens and there is the potential for duplication of routes and duties and a perceived lack of clarity from the public over the various team's roles.
- 4.8 When considering the review in May, Members expressed their support of the value of the Community Warden Service and asked if it would be possible to expand the service to cover more areas. By combining the complementary services of Community Warden and Environmental Enforcement, there is an opportunity within current budgets, to expand the geographical spread of the service and increase the role of wardens to cover enforcement duties.

Community Traffic Wardens

4.9 The Community Traffic Wardens are funded by Central Scotland Police. Their main focus is on traffic problems (e.g. abandoned cars, out of date tax discs, unlawful parking) but they are also involved in local Police Initiatives and Public Re-assurance. They cover the Falkirk policing sub-area on a programmed basis. Community traffic wardens currently cover central Falkirk and the retail park, as well as other areas of the Council. It is proposed that discussions take place with Central Scotland Police to ascertain if there is an alignment between the duties of the Community Traffic Wardens and Community Wardens. This would allow the Community Warden / Enforcement Services to be focused areas other than the Town Centre.

Way Forward

4.10 If approved by Members, the above proposals would be developed in consultation with employees, human resources and the trade unions. Further work is required to develop the remit, geographical locations, routes, roles & responsibilities, training requirements, post development, gradings and management structure.

5. **RECOMMENDATIONS**

It is recommended that Members

- 5.1 Note the contents of this report
- 5.2 Agree the proposal to combine the Environmental Enforcement Team and Community Warden Service;
- 5.3 Authorise officers to take forward this proposal in consultation with employees, HR and trade unions; and
- 5.4 Require Officers to report back to Committee as this proposal develops.

1. INTRODUCTION

1.1 This report presents the latest update on the Council's financial position and reflects the information recorded for the 6 months to 30 September 2008.

2. GENERAL FUND

2.1 Appendix 1 sets out both General Fund net expenditure by Service and how it is financed. Movements between budget and projected outturn are expressed in monetary and percentage terms.

In October of this year, I advised Members that expenditure was forecast to exceed income by around £1.7m or 0.54% of approved net expenditure. I am now projecting that the overspend will reduce to c_{\pm} 1.3m, equivalent to 0.41% of the overall budget.

2.2 The most significant deviations from budget are described below:-

Education (+ $\pm 0.35m$; 0.2%)

The cost of residential schools remains a significant cost pressure, being ± 0.6 m above budget. Higher spending on staff costs is mitigated by additional income, with savings in rates (± 0.2 m) and additional income from childcare fees (± 0.1 m) reducing the overspend to ± 0.35 m or 0.2% of budget.

Social Work Services (+ £3.606m; 5.5%)

The forecast overspend is virtually unchanged since last month. Whilst the demand pressures on the budgets for childrens residential care and 24 hour packages for community care have stabilised at this point, it has to be borne in mind that these are volatile budgets which can be subject to significant change.

General Fund Housing Services (+ £1.552m; 13.0%)

The change in the projected overspend is due to an increase in the cost of Housing Benefit net of subsidy, together with a reduction in the anticipated contribution Housing Benefit makes to the cost of the Council's Homeless service.

<u>Miscellaneous Services (- $f_{1.335m; 19.1\%}$ </u>

Interest earned in revenue account balances remains buoyant and is forecast to be around \pounds 1.1m above the budgeted level.

Capital Financing Costs (- £1.073m; 18.0%)

Loan Charges are now forecast to be a further $\pounds 0.3m$ lower as a result of lower interest rates. The total underspend is therefore almost $\pounds 1.1m$ when taken together with changes to the debt profile referred to in previous reports.

3. TRADING ACCOUNTS

Surpluses are currently forecast to be ± 0.148 m above budget, arising mainly from increased income within the Building Maintenance Division. All other trading accounts are operating close to the planned levels.

The Building Maintenance and Roads Statutory Trading activities are therefore well placed to meet their financial objective.

4. HOUSING REVENUE ACCOUNT

Forecast spending within the HRA is now $c \not \leq 0.36$ m below budget. This arises from the combined impact of savings in loan charges and void properties which are partially offset by higher costs of providing services to the homeless. In addition, income remains higher than originally envisaged as a result of the significant slowdown in house sales.

5. CONCLUSION

At the mid-point of the financial year, net General Fund spending is forecast to be $\pounds 1.289m$ above the approved level. There are significant overspends within the Social Work budget ($+\pounds 3.6m$) and General Fund Housing ($+\pounds 1.6m$) which are considerably higher than the additional resources of $\pounds 1.6m$ approved by Council in February of this year.

Reserves are forecast to fall to $\pounds 4.5$ m by the year-end, which is well below the minimum level of $\pounds 5.5$ m contained within the Reserves Strategy approved in August 2006. In addition, the final impact of equal pay claims cannot yet be quantified with any degree of certainty. Directors are well aware of the need to bring spending more in line with the approved budget.

Spending within the HRA is forecast to be $\pounds 0.36$ m below budget, with year-end reserves estimated to be $\pounds 6.115$ m.

6. **RECOMMENDATIONS**

Members are invited to note the projected financial position as at 30 September 2008 and instruct Directors to incur only expenditure which is essential in order to bring expenditure more into line with the approved budget.

Committee therefore believes that Scottish building societies such as the Dunfermline Building Society have demonstrated a high level of financial prudence and sound management in difficult times.

Committee therefore agrees to include Scottish based institutions that have enjoyed the status of "mutual" within its approved list of institutions available to receive short-term investments."

1. INTRODUCTION

The terms of the Council's Treasury Management Practices require that an interim report on the Treasury Management function be produced by 31 December each year.

2. ECONOMIC AND INTEREST RATE OUTLOOK

- 2.1 At the time the Annual Strategy Report was approved in April, it was reported that the global economy was set for a significant slowdown. The US sub-prime mortgage crisis and the resultant liquidity "crunch" in the global banking system had increased the likelihood of recession. In response, western central banks, led by the US Federal Reserve, injected significant levels of liquidity into markets and also in the US and UK interest rates were eased.
- 2.2 In the Strategy Report, it was noted that UK interest rates had reached a level of 5.25% and indeed in April 2008 were further reduced to 5%. At that time, it was recognised that while the outlook for the UK economy had deteriorated, the Bank of England Monetary Policy Committee indicated that monetary policy would err on the side of caution until signs were evident that inflation had peaked. In the intervening period, the outlook for economies has deteriorated sharply to the extent that central governments across the globe have implemented a series of rescue packages to support their own key financial institutions. As part of these measures, in early October, central banks implemented a 0.5% cut in interest rates as a co-ordinated response to the crisis. Given the Bank of England's view that the balance of risk has tilted towards recession at the expense of inflation which is forecast to fall in the coming months, the bank recently announced a dramatic 1½ % reduction in the rate to 3%.

2.3 The Strategy Report indicated that longer term interest rates might rise towards 5% reflecting the need for higher gilt yields to attract the level of investment necessary to accommodate what would be a significant rise in gilts issuance required by the Government to fund its support packages to ailing financial institutions. However, over the remainder of the financial year, it is anticipated that longer term rates may well trade in a range of around 4% for periods of up to five years and nearer 4.5% for longer periods, as they benefit from the anticipated decline in short term rates and the expected healthy demand for government securities as a safe haven for investors during the current market volatility.

3. BORROWING STRATEGY

- 3.1 The Council's longer term borrowing requirement has been revised to $\pounds 11m$, a marked increase of $\pounds 7.4m$ in the level as advised in the Annual Strategy report to Committee in April. The revised forecast reflects a combination of a less than anticipated level of sales in housing stock and a reduction in General Fund capital receipts not being received in the current year. Both of these issues have been highlighted in the regular Capital Programme updates made to this Committee.
- 3.2 In the Strategy Report, it was noted that the Council's longer term borrowing requirement for the year would be relatively minor and as such it was planned to finance any funding linked to short term rates. The report also highlighted the potential for four Market Loans up to a value of $\pounds 26m$ to be repaid during the year should any of the lenders invoke a rate change clause as per their contracts.
- 3.3 In the current year to date, fears of a global recession have increased and resulted in a complete re-assessment of the future direction of interest rates. In particular, short term rates are expected to decline sharply following the reduction in base rate to 3%. Despite the marked increase in longer term funding identified at para 3.1, it is proposed that such funding continues to be met on terms linked to short term rates. The potential for repayment of any of the Market Loans identified at para 3.2 remains low given the current structure of longer term rates.
- 3.4 Members will recall, in previous reports to this Committee, that a policy change by the Public Works Loans Board in November 2007 had effectively brought debt rescheduling activities to an abrupt halt and that it would require a significant upward shift in yields to re-activate this treasury tool. In fact, the extreme market volatility experienced this year created such a scenario to the extent that in mid-October, the undernoted debt rescheduling transaction was concluded.
 - Repay 3 PWLB fixed rate loans totalling ± 24.3 m with an average period to maturity of 43 years and an average rate of 4.52%.
 - Redeemed loans repaid without penalty.

• Replacement funding secured through a reduction in Council's temporary deposits by a similar amount.

The main driver for the transaction was the opportunity to significantly reduce the level of deposits currently on loan with financial institutions in a climate where concerns have been raised over the security of certain counterparties.

4. INVESTMENT STRATEGY

- 4.1 The Council manages its short term surplus funds by investing from time to time with other Local Authorities and financial institutions subject to strict credit rating criteria consistent with the Council's Treasury Management Practices.
- 4.2 Previous reports to this Committee have highlighted the increased counterparty risk which has evolved as the financial crisis worsens and the various interim measures introduced by the Council in light of prevailing market events. Over time, a number of financial institutions have had their credit ratings downgraded and as such have been removed from the Council's approved list. Also, current monetary limits of either \pounds 3m to specific counterparties have been applied, together with a maximum period for lending of one month. The decision to repay the PWLB loans identified at para 3.4 will also have the effect of reducing the level of counterparty risk.
- 4.3 Members may wish to note the criteria used to determine the selection of Building Societies on the Council's approved counterparty list. This is designed to ensure prudent protection for public funds. The main criteria is based on a minimum level Fitch (or equivalent rating agencies) short term credit rating of "F1" and a long term credit rating of "A". Additionally for Building Societies, they must have total assets of greater than £5 billion. Taking both criteria together and given a number of other mergers in the sector, only a few societies currently qualify as approved counterparties, namely Nationwide, Yorkshire, Coventry & Chelsea. Building Societies in Scotland do not qualify under either of the criteria set by the Council.
- 4.4 As previously reported, the Council continues to invest a large part of its Pension Fund cash surpluses with the Fund's custodian, Northern Trust, in its AAA rated Sterling Cash Fund. Only a working balance of pension fund cash is retained and pooled with Council monies for treasury management purposes.
- 4.5 Draft Investment Regulations and a supporting Code, issued for consultation in May 2008, propose a more structured approach to accounting for, and reporting on, local authority investments. While the consultation period has ended, it can be assumed that the financial crisis will at the very least cause the Scottish Government to consider if any further controls/restrictions require to be introduced. An implementation date of April 2009 is planned for the new Investment Regulations.

5. **PRUDENTIAL CODE**

Consistent with the requirements of the Prudential Code, a series of Treasury Management indicators have been devised as part of the overall suite of Prudential Indicators which are used to demonstrate that Council capital spending plans are affordable, prudent and sustainable. Monitoring and review of these indicators are incorporated in the periodic Capital Programme updates made to this Committee.

6. CONCLUSION

The prospects for a sharp fall in short term rates, following the dramatic cut in base rate, will have a beneficial effect on the overall borrowing costs of the Council for the current financial year. Given the unprecedented events unfolding in financial markets, the Treasury Section and our advisers will continue to remain vigilant to any new developments and having particular regard to the Council's exposure to counterparty risk.

7. **RECOMMENDATION**

Members are asked to note the progress of the Council's Treasury Management Strategy for 2008/09.

ED19. TOWN CENTRE REGENERATION UPDATE

There was submitted Report (circulated) dated 26 November 2008 by the Director of Community Services (a) introducing a presentation by the Strategic Projects Manager; (b) outlining progress in respect of the regeneration of Bo'ness, Denny, Grangemouth and Stenhousemuir town centres; (c) highlighting the role of the Town Centre Development Groups in the regeneration projects, and (d) advising of the promotion activities undertaken by Falkirk and District Town Centre Management Ltd.

The Strategic Projects Manager's presentation summarised the progress to date of the regeneration opportunities within the four district centres.

Discussion took place on the following issues:-

- Operation of the traffic lights leading into Stenhousemuir old town centre
- Signage listing existing shops in Stenhousemuir old town centre
- > Use of the bus lane by taxis and other vehicles in Park Drive, Stenhousemuir
- Formalisation of agreement with the developer of Denny town centre
- > Future of the harbour development in Bo'ness town centre
- External grants towards project works to be undertaken in Bo'ness
- Involvement of community groups on Town Centre Development Groups

Councillor C Martin, seconded by Councillor Lemetti, moved the recommendation contained in the Report.

By way of an amendment, Councillor Oliver, seconded by Councillor Hughes, moved that an additional recommendation be included as follows:-

"Councillors should encourage no disparity of Town Centre Development Groups to ensure public participation. All community groups will have the opportunity to attend local Town Centre Development Groups if they express a desire to do so".

1.0 INTRODUCTION

1.1 This report is to advise Committee as to the progress of the Council's Town Centre Regeneration Strategy and in particular the regeneration of Bo'ness, Denny, Grangemouth and Stenhousemuir. A presentation on this progress will be made at Committee.

2.0 BACKGROUND

2.1 Policy & Resources Committee in 2001 approved the regeneration of the Council's district centres by market testing and identifying redevelopment opportunities using Council owned land and property assets to lever and secure private sector investment. This work and additional security and environmental improvements in the four district centres has been supported by the Town Centre Regeneration capital programme. This report summarises progress to date of regeneration opportunities within the district centres.

3.0 STENHOUSEMUIR REGENERATION

3.1 The Policy & Resources Committee approved Macdonald Estates plc as the Council's preferred developer. A town centre masterplan was subsequently finalised including a new 40,000ft² Asda food store, library, shops, health centre, car parking, community rooms and sports facilities at Crownest Park.

Development Progress

- 3.2 Construction of the new town centre has progressed well with completion and pre let of the new shops in January 2008, the new library opening April 2008 and the new Asda store trading from end September 2008.
- 3.3 To date up to 175 people have been employed on the initial construction phase of the town centre. Asda have indicated that they now employ 250 people at the Stenhousemuir store.
- 3.4 Despite agreeing acquisitions of all third party property interests by November 2007, one private owner withdrew from negotiations despite best endeavours by Macdonald Estates and Council officers to secure matters. The consequence of this has been a delay in completing the final component of the masterplan; a 12000ft² retail parade and car park at King Street. This necessitated acquisition of the interest by CPO powers. The

affected building, the former Clydesdale Bank, has not been demolished and the area remains undeveloped and an eyesore to the community.

- 3.5 The Council and Macdonald Estates were formally advised by Scottish Ministers in October 2008 that the CPO was being upheld in their favour. Subject to there being no Appeal, matters will now be progressed whereby the former Clydesdale Bank building will be demolished and development of the final retail block and car parking scheme delivered.
- 3.6 Detailed planning consent for the development of a new Health Centre and Tryst Community Centre was received in April 2005. However, delays in finalising the development agreement resulted in the original construction contract requiring to be retendered. Key to the development of the new health centre is relocation of the Tryst Community Centre. The existing Centre will be demolished, requiring existing services to be temporarily relocated whilst the new building is completed. Work on these new facilities is anticipated to commence in early 2009 with estimated completion by December.
- 3.7 A total of 330 parking spaces have been provided in the new town centre. The new retail block and health centre, with associated car parking will provide an additional 155 car parking facilities in the town centre. The previous town centre provided approximately 100 car parking spaces.
- 3.8 The total development value is anticipated to be £15m with all works completed by end 2009. The formal development agreement between Falkirk Council and Macdonald Estates plc allows for open book appraisal and validation of all costs associated with the development ensuring best market value in terms of transfer of Council assets.

Trader/Business Assistance

- 3.9 Falkirk Council and Macdonald Estates were able to secure existing business from the previous retail parade into the new retail facilities adjacent to the new Asda foodstore. Working closely with Town Centre Management Ltd there has been regular communication with all town centre retailers whilst regeneration works have progressed. This has included regular progress newsletters, trader meetings, promotional events and specific promotion of Non Domestic Rates Hardship Relief. Despite this, there has been some inevitable disruption experienced by traders as particular phases of the regeneration works are delivered.
- 3.10 Officers have liaised closely with the Director of Finance Services to assist traders with Non Domestic Rates Relief claims. Council officers have promoted this scheme to local traders and assisted with the formal applications to the Director of Finance Services. Only those businesses who demonstrate a clear downturn in trade as a consequence of the regeneration works are awarded relief. The scheme continues to be in place during the whole regeneration phase and officers continue to offer assistance to local businesses.

4.0 **BO'NESS REGENERATION**

4.1 Two regeneration initiatives are being progressed as key building blocks in the regeneration of Bo'ness:-

4.1.1 Bo'ness Townscape Heritage Initiative (THI)

- The THI Strategy for Bo'ness town centre concentrates on the restoration and conservation of the historic core of the town. It involves private and public sector match funding to the HLF award, delivering £5m regeneration to this historic town centre.
- Work on the first phase of the THI has been concluded with delivery of public realm improvements and restoration of the Grade A listed Hippodrome Cinema, due to be opened as a major attraction during 2009. Open days at the Hippodrome since completion of the restoration project have shown exceptional community interest and support.
- The next phase of the THI is now underway involving the restoration of key listed derelict buildings in the heart of the town centre. These buildings are derelict and unattractive to visitors and the Bo'ness community. The most significant is 15-17 South Street, a prominent building in the heart of the town. Restoration of this building is now underway and due to be completed by March 2009. This will bring additional retail space and apartments to the town centre.
- Restoration of other key derelict buildings and implementation of smaller building improvements and shopfront grants are presently being satisfactorily advanced through detailed grant award discussions. The success in delivery of the THI to date has been the key role of the THI Project Officer, employed by Town Centre Management Ltd for the duration of the THI initiative. This role has been to liaise with the Bo'ness community and property owners within the THI area to promote the THI objectives and advise and assist with grant applications.

4.1.2 Bo'ness Harbour/Foreshore Redevelopment

- Members will be aware that the original masterplan by the Council's joint venture development partner ING Real Estate required to be rephased. The scheme is to deliver a mixed residential, commercial and marina quayside development around the restoration of the disused harbour with development of the remainder of the site with residential units on the foreshore area.
- This rephasing was as a consequence of the global collapse of financial markets and gave an early indication of its direct and unprecedented effects on financial institutions and the property development sector.
- ING and the Council are working to deliver the regeneration masterplan which received outline planning consent July 2006. ING will commence with residential development at the eastern end of the masterplan site rather than the harbour area as originally proposed.
- The outcome of community consultation on these proposals and the revised phasing of the masterplan were approved at the Council meeting in June 2008. This secured ING's continued partnership and proposed investment in Bo'ness and the Council area. Since June 2008 Council officers and ING have been progressing the redrafting of the development agreement and this will be finalised early 2009.

- As a consequence of rephasing the scheme and despite the further impacts of the economic downturn, ING continue to remain positive about Bo'ness and their delivery of the regeneration proposals for the harbour/foreshore area.
- It is anticipated that following receipt of planning consent for the revised phases, work could commence on site during 2010.

5.0 DENNY REGENERATION

- 5.1 Regeneration masterplan proposals for Denny town centre have been concluded, following extensive consultation with retailers, local businesses and the community. The Council's joint development partner Henry Boot plc has amended the original masterplan to reflect concerns raised during the consultation process.
- 5.2 As outlined previously to Members the finalised scheme identifies a two storey development with investment of over \pounds 11m including 18,000ft² foodstore, 36000ft² new retail units, restaurant/bar, a new library, increased car parking provision and substantial public realm improvements.
- 5.3 A detailed development agreement between Falkirk Council and Henry Boot plc has been finalised on the basis of terms approved by Policy & Resources Committee and ensuring best value in exchange and acquisition of the Council's town centre site land package. The agreement has been referred to the Board of Henry Boot plc and formal approval is awaited.
- 5.4 It is anticipated that formal planning applications in respect of the new town centre will be progressed in early 2009 once formal Board approval is received. Thereafter, upon receipt of planning consent, a site start is currently estimated during 2010.
- 5.5 Meantime Falkirk Council following a report to Policy & Resources Committee in June 2008 is progressing financial assistance to Falkirk Council commercial tenants, traders and businesses who continue to operate within the Church Walk housing blocks and are affected by ingress of water. These blocks will be demolished as part of the town centre regeneration programme likely to commence 2010 and on this basis compensation to businesses is offered until this takes place.

6.0 **GRANGEMOUTH REGENERATION**

- 6.1 Asda opened a new 65000ft² foodstore on land acquired from Forth Ports adjacent to Grangemouth town centre. The development is recognised as bringing additional investment and retail provision to Grangemouth.
- 6.2 In partnership with the Council's joint venture development partner (and joint owner of the centre) extensive community consultation was undertaken in respect of regeneration proposals for Grangemouth town centre which resulted in an agreed Masterplan:-
- 6.3 The regeneration masterplan was subsequently amended to reflect specific community concerns regarding the relocation of the library/museum facilities and lack of a stronger link between the new Asda and the existing town centre. This was reported to Policy & Resources Committee in May 2008, noting the ongoing support for the regeneration scheme.

- 6.4 Since May this year Council officers have been progressing a development agreement with the developer and jointly undertaking discussions with the Health & Safety Executive regarding the influence of Hazard Consultation Zones on the town centre regeneration proposals. Initial discussions with the HSE on the Masterplan have been constructive and have ensured an early full understanding by the HSE of community and Council aspirations for Grangemouth town centre.
- 6.5 Upon conclusion of a development agreement it is anticipated that the developer will progress this regeneration initiative with the submission of a planning application during 2009 and site start estimated during 2010/11.

7.0 TOWN CENTRE DEVELOPMENT GROUPS

- 7.1 Committee in September 2007 approved the establishment of town centre development groups to be held locally in Bo'ness, Denny, Grangemouth and Stenhousemuir town centres.
- 7.2 These groups have met regularly, approximately every two months. They are attended by area local members, community councils and local community planning group representatives as well as retailer and business representatives, Town Centre Management Ltd, the developer and Council officers. In some instances, representations of other local interest groups have been involved and it is suggested that the groups keep their make-up under review to ensure appropriate local representation to reflect the regeneration of their town centres.
- 7.3 The groups provide a forum for bringing together local interested parties to communicate progress of regeneration activity in each of the town centres and address ongoing community concerns either with masterplan proposals, progress of works, or ongoing trading concerns.
- 7.4 The groups have adopted a positive approach and enable understanding of the development process which leads to physical works commencing within a town centre. The groups have received updates on progress of town centre regeneration masterplans and have influenced their design. The groups have consulted on options to deliver change and established sub groups as necessary to examine specific issues.
- 7.5 Members should be aware that the groups do not have formal decision making powers, relying on the Council's formal processes taken through Committee for any decisions to be made. When reporting on the outcome of consultation officers will advise members of the contribution made by a group and its participants.

8.0 TOWN CENTRE PROMOTION

- 8.1 Whilst conclusion of development agreements, planning applications or physical masterplan works are progressed, the continuing performance of the district centres remains a specific concern to local traders and the Council. This has become of greater concern as the impact of the economic decline takes effect.
- 8.2 In addition to non domestic rates relief support available at the outset of regeneration works (outlined in 3.0 above), Falkirk Council continues to provide revenue support to

Falkirk & District Town Centre Management Ltd to undertake key promotion activity within the district centres. Their activity includes:-

- Radio promotion
- Newspaper promotion
- Christmas events and publications
- Farmers Markets
- Craft fairs
- Shop Local initiatives
- Promotional prize schemes to encourage purchases within the town centres
- Welcome packs to new housing developments and estate agents
- Attending/setting up retailer meetings to discuss promotional activity
- Retailer/business newsletters
- Tourism related promotion
- 8.3 The Council's revenue contribution to the district centres and activity delivered is reported annually by Falkirk & District Town Centre Management Ltd. Following the acceptance of Falkirk as one of six Scottish pilots for Business Improvement District status, Town Centre Management Ltd announced in May that businesses within the Falkirk BID area had voted in favour of the formal establishment of BID status. Falkirk is the fourth of six Scottish BID areas to be successful.

9.0 IMPLICATIONS

- *Policy:* The Town Centre Regeneration proposals are consistent with My Future's in Falkirk Initiative, the revised Community Plan, Corporate Plan and Structure & Local Plans.
- *Financial:* The Director of Finance Services is kept fully appraised as to revenue implications for sale of existing Council retail units in Denny and Grangemouth. To date physical investment delivered in the district centres as a consequence of the town centres regeneration strategy is $\pounds 14m$. Currently Falkirk Council is progressing regeneration masterplans for all 4 district centres with a potential of $\pounds 228m$. As the current economic climate has significantly deteriorated since the establishment of masterplan proposals for each centre, members must be aware that each proposal is subject to the ability to deliver a positive outcome by the Council's development partner, with each scheme being subject to market conditions.
- *Legal:* The Acting Director of Law & Administration Services is assisting in the preparation of development agreements with each of the developers to ensure delivery of key Council and community objectives within each of the regeneration initiatives. In addition, the mechanism of transfer of Council assets and of existing and new facilities are also progressed to ensure best value to the Council.

10.0 CONCLUSION

- 10.1 Despite the downturn in the national and global financial economy, Falkirk Council through the promotion and marketing of its land and assets in Stenhousemuir, Bo'ness, Denny and Grangemouth has been able to secure and maintain national and international developer interest to the area. Community consultation has been central to the consensus gained on the proposed masterplans and these now provide a positive way forward for each centre.
- 10.2 Council officers continue to work with the developers, community and traders to ensure progress in each town centre. The physical changes and economic benefits, in terms of new jobs, investment and trading are being witnessed in towns such as Bo'ness and Stenhousemuir. The support of members and the community is recognised with each project contributing to the creation of a safer, more attractive and thriving town centre which meet their aspirations.

11.0 **RECOMMENDATION**

11.1 It is recommended that Committee notes the progress of the town centre regeneration strategy.

1 INTRODUCTION

1.1 The purpose of this report is to recommend a role and remit for an audit committee following the decision taken by Council on 25 June 2008 to introduce such a committee. This role has hitherto been performed by the Council's Best Value and Audit Forum.

2. AUDIT COMMITTEE PRINCIPLES

- 2.1 In 2004, the Chartered Institute of Public Finance & Accountancy (CIPFA) issued guidance entitled "Audit Committee Principles in Local Authorities in Scotland". This guidance set out three fundamental audit committee principles, namely that there should be effective mechanisms in place to provide:
 - independent assurance on the adequacy of the risk management framework and the associated control environment within the authority;
 - independent scrutiny of the authority's financial and non-financial performance to the extent that it affects the authority's exposure to risk and weakens the control environment; and
 - assurance that any issues arising from the process of drawing up, auditing and certifying the authority's annual accounts are properly dealt with.
- 2.2 It is suggested that the principles outlined above would form the core role of the audit committee.
- 2.3 The guidance also provides a template for local authorities to use when establishing an Audit Committee. A proposed remit, based on that guidance, would be as follows:
 - to consider the Council's governance and business management arrangements;
 - to consider the Council's risk management arrangements and action being taken to address risk related issues identified by auditors and inspectors, including consideration of periodic reports from the Corporate Risk Management Group;
 - to consider the adequacy of the Council's control environment;
 - to approve (but not direct) Internal Audit's strategy;

- to consider and agree Internal Audit plans, ensuring that work is planned with due regard to risk, materiality and coverage;
- to review summary Internal Audit reports and seek assurances that action has been taken to address issues identified;
- to consider an Annual Assurance report from the Internal Audit Manager;
- consider the reports of External Audit and other inspection agencies and seek assurances that recommendations made are addressed;
- to ensure there are effective relationships between Internal and External audit;
- to review the Authority's assurance statements, including the Statement on the System of Internal Financial Control or equivalent, to ensure they properly reflect the risk environment.

3. THE COMMITTEE

- 3.1 CIPFA's guidance suggests that an audit committee may function more effectively with a small membership to enable efficient discharge of its role and responsibilities although the guidance also acknowledges that these are decisions for Councils themselves to take. It is suggested that Council may wish to consider a committee of 6 members, politically balanced, with a quorum of four and reporting directly to Council.
- 3.2 Having regard to the decision taken by Council at its statutory meeting on 18 May 2008, a committee of six would have the following membership:
 - 3 Labour
 - 2 SNP
 - 1 Conservative or Independent or non aligned Independent
- 3.3 The guidance advises that "to be fully effective, members of the audit committee need to have certain characteristics above and beyond those which are desirable in all members. In particular, they need to:
 - have a good understanding of how the whole Council works and a broad understanding of the controls which exist or should exist;
 - be able to distinguish between serious control weaknesses and those which are relatively minor;
 - be confident about discussing audit findings with the auditors and management;
 - have the power to make appropriate decisions and to make recommendations to the Council, in accordance with the standing orders; and
 - be respected and trusted by other members of the Council to make remitted decisions on their behalf".
- 3.4 Meetings of the Committee would be attended by the Director of Finance (or his representative), the Internal Audit Manager and such other officers as the committee deemed to be required. The External Auditor may also be invited. In addition, other members of Council would be permitted to attend as the committee considered appropriate, following the existing practice of the Best Value and Audit

Forum. Other members would not, however, have a formal decision making role on the committee.

- 3.5 It is not envisaged that there would be a requirement for the Audit Committee to meet as frequently as the Best Value and Audit Forum. It is proposed, therefore, that the Committee would meet a minimum of 3 times each year, with the proviso that additional meetings would be called if there was business to be considered which could not wait until the next scheduled meeting. The scheduling of meetings should tie in with the annual Internal and External Audit planning and reporting cycle, with meetings in March, May and November.
- 3.6 With the exception of matters now within the remit of the audit committee, the business dealt with formerly by the Best Value and Audit Forum would continue to be dealt with by the re-named Best Value Forum.

4. **RECOMMENDATIONS**

- 4.1 It is recommended that Council agrees:-
 - (a) the proposed role and remit of the Audit Committee as set out in paragraphs 2.1 to 2.3 of the report;
 - (b) that the membership of the Committee should be set at 6 with a quorum of 4;
 - (c) that the Committee should report directly to Council, and
 - (d) to amend the Standing Orders of the Council to reflect these decisions.
- 4.2 Should Council agree in accordance with the foregoing, members are invited to appoint a convener of the Committee, and members thereof, in accordance with the proportionality outlined in paragraph 3.2 of the report.

1. **INTRODUCTION**

- 1.1 Members will recall that, in line with the Council's Strategic Planning and Management System (SPMS), the Council approved a Corporate Plan in March 2008. This Plan covers the period from 2008 until 2011. This report updates Members on progress made towards achieving the outcomes contained within the Corporate Plan and how these are being taken forward through the key policies and strategies of the Council.
- 1.2 Members will also recall that the Council, along with our Community Planning Partners agreed our first Single Outcome Agreement with the Scottish Government in the summer of this year. The Outcome Agreement sets out how our local priorities support national outcomes, along with the indicators we will use to measure progress. This reports progress against these indicators and also notes the requirements for refreshing the Single Outcome Agreement next year.

2. BACKGROUND

- 2.1 The Corporate Plan sets out the goals and values of the Council, i.e. what we are trying to achieve and how we will go about our business. As part of the Corporate Plan, the SPMS was included to ensure that the Council's key priorities are progressed with regard to our strategic policies and strategies, as well as service delivery objectives.
- 2.2 The Corporate Plan refreshed the goals and values of the Council to ensure they meet our continued aspirations, i.e. underpin our vision for our area. Our priorities are aligned with the vision and themes contained within the Strategic Community Plan and thus underpin our contribution to achieving the outcomes within our Single Outcome Agreement. Our revised goals are:

Goals

- Further developing a thriving, sustainable and vibrant economy;
- Continuing to improve the health, safety and well being of our citizens and communities;
- Increasing our effort to tackle disadvantage and discrimination; and
- Enhancing and sustaining an environment in which people want to live work and visit.

Values

2.3 The values of the Council set out the way we will undertake our business. These are:

We are committed to PUBLIC SERVICE, which means:

- fairness;
- listening and responding;
- being accessible and accountable; and
- promoting our services using plain English as far as possible.

We are committed to PERFORMANCE, which means:

- providing quality;
- achieving value for money;
- promoting innovation; and
- seeking continuous improvement.

We are committed to PARTNERSHIP, which means:

- effective communication;
- sharing decision making; and
- encouraging participation.
- 2.4 The purpose of this report is to consider the progress against our three-year Corporate Plan outcomes.

3. **PROGRESS AGAINST THE OUTCOMES IN THE PLAN**

- 3.1 Underpinning each of the goals in the plan, we have four outcomes. These outcomes are incorporated within our Single Outcome Agreement under an appropriate national outcome, along with the relevant indicators that will measure progress.
- 3.2 Appendix one provides an update on the relevant indictors contained with the Single Outcome Agreement under each goal and relevant local outcomes.
- 3.3 Members will note that in the majority of objectives, we are making good progress. An overall assessment of improvement can be made by using a ratio which compares the number of indicators where performance has increased, with those where performance has decreased in a reporting year. For 2007/08 the ratio is approximately 5:1 in favour of improving or sustaining existing performance levels. It is anticipated that we will continue to develop the monitoring statement to ensure it covers all priorities adequately.
- 3.4 The following section provides commentary on some of the Council's achievements in 2007/08 and for the first six months of this 2008/09, against the outcomes set out in our Corporate Plan.

Further Developing a Thriving Sustainable and Vibrant Economy

Our area will be recognised as having a culture and ethos of aspiration and ambition

- (i) The Business Panel continues to be optimistic about the future of the Council area. From the latest survey 92% of businesses think the Falkirk Council area is a good place to be located and that they will continue to consolidate and expand over the coming year.
- (ii) The Council has opened two new schools in Kinnaird and Maddiston thus ensuring our youngest pupils have the highest quality of learning environment;
- (iii) The Council and our partners became an early implementer of the new 16+ learning choices model launched by the Government in February 2008. This will ensure all young people leaving school will be offered arrangements appropriate to their needs e.g. training, employment, further education or indeed continuing at school by December 2010. This is one of the most ambitious schemes of this nature in Scotland. In addition the Council has developed new progression pathways for those young people who need pre apprentice provision. To date this new opportunity has supported 406 young people of which 93% moved into a positive outcome.
- (iv) In 2007/08 schools reported that young people were engaged in 287 entrepreneurial activities, 17 of which were Fair Trade activities. This represents an increase of 16% on the previous year's figures. Schools continue to link with local businesses to promote Enterprise in Education with a total of 427 partnerships established. Carrongrange School was only one of 10 in Scotland to be recognised as Socially Enterprising School at an awards ceremony earlier in summer 2008. It was also short listed as one of the top 3 in the 'most Enterprising Special School' category at the 2008 Scottish Education Awards.
- A new business unit opened in Bo'ness to offer modern accommodation for small businesses and a new unit is under construction at Wholeflats, Grangemouth.

The Wealth and Prosperity of our Area will increase

- (i) Over the last year, the number of modern apprentices taken on by private businesses has increased. We have secured benefit in the community clauses in a number of contracts that have allowed new opportunities for training and apprenticeships to take place. In addition to the new schools contract, a national housing association has adopted our clauses and has appointed 20 modern apprentices who are working within our area.
- (ii) The Council worked to ensure the transfer of responsibilities from Scottish Enterprise tool place timeously. Falkirk Council also has taken the lead for the Forth Valley area in the business gateway. The number of Volume Start ups within the Forth Valley area in the first three months of operation performed ahead of target and above the Scottish average.
- (iii) The Council has also sought to stimulate local employment. In 2007/08 the Council supported 278 new business start ups through the Business Gateway. The Council also increased the uptake of work based training to 560 in

2007/08, compared to 432 the previous year. The Council also increased the number of modern apprentices and skill seekers it managed by 13% in the same period. With Council support a total of 729 jobs have been created or secured in 2007/08.

Our workforce will be highly skilled

- (i) The Council opened a new library in Stenhousmuir and recently opened a further library in Polmont. These new facilities give people within our communities the opportunity to access not only books, but on line facilities. The number of times the public accessed computer terminals in libraries was up slightly last year.
- We also employ 255 modern apprentices within the Council at any one time. This means we are well on course to meet our commitment of 5% i.e. 300 of our workforce being modern apprentices by autumn 2009.
- (iii) In 2007/08 our adult literacy and numeracy team worked with 262 learners to improve their reading, writing, number and English language skills. A number of learners gained accreditation in Communication and Numeracy, and several achieved ESOL SQA units necessary to quality for British Citizenship.
- (iv) Overall, our schools have performed steadily during 2007/08. Against most of the categories assessed and reported on by HMIE, our schools have been assessed at 90% or above as being good or very good. The S4 cohort has performed consistently in terms of attainment between 2006/07 and 2007/08. As a result of the percentage of young people leaving school without progressing into employment, further or higher education or training has fallen from 16% in 2006/07 to 10% in 2007/08.

The quality of our infrastructure will help promote the growth of the local economy.

- Falkirk Town centre was awarded Business Improvement District status in May 2008. This will ensure the town can continue to develop and grow.
- (ii) The plans for regenerating our other town centres continue to develop. The new shopping centre in Stenhousmuir nears completion with the opening of the ASDA store.
- (iii) While the economic situation has impacted our ambitious plans for development, where the Council has an influence, we have continued to progress plans for regeneration. This includes the opening of the Hippodrome in Bo'ness.
- (iv) The Council took the decision to reduce car parking charges in Falkirk Town centre. This has ensured our town centre will be a more attractive destination for shoppers and commuters alike.
- (v) During 2007/08 the number of business advice requests for consumer protection completed within 14 days reached 88.7% compared to 65.9% the previous year.

Continuing to improve the health, safety and wellbeing of our citizens and communities

Our citizens will be supported to make positive health choices and lifestyles in order that they can live longer.

- (i) The Council approved a new Health Improvement Plan in August 2008. This plan sets out clear targets and actions for improving the health of individuals and our communities over the life of the plan.
- (ii) All our primary, secondary and special needs schools and nursery centres have now become health promoting, with 64 establishments achieving level 2 accreditation and 7 level one. 98% of our educational establishments are now health promoting. This helps encourage young people to pursue a healthier lifestyle. During 2007/08, the number of young people participating in Council health promoting activities more than doubled to 5,072 compared to 2,315 in 2006/07. The number of young people attending our leisure centres also increased by over 8,000 during the same period.
- (iii) The Council approved a Core Paths Plan in spring 2008. This plan develops the work contained within the Outdoor Access Strategy, that aims to promote the countryside to both residents and visitors. This last year has seen the implementation of the Braes and Bo'ness / Blackness paths network.
- (iv) The Council launched an Active Campaign in the summer of 2008. This
 promoted a range of activities from tea dances to organised sporting activities.
 This included opening the school swimming pools in Larbert and Braes High
 School to the public.
- (v) 24 active peer educators were recruited and trained in Grangemouth, Denny, Falkirk and Maddiston. These peer educators then delivered 47 training sessions since last year and have made contact with 823 young people.
- (vi) Over 200 young people were involved in the Commonhealth Games, incorporating physical activities and alcohol awareness, with a number of events from cycle trips to football matches. These activities were linked to the Straightalk Peer Education Project.

People will have equitable access to local health, support and care.

- (i) Earlier this year, the Council and our partners established two locality based children's teams that ensure we have a more holistic approach to meeting the needs of children and young people.
- (ii) Services and advice for people with Autism Spectrum Disorder were launched. These provided practical support and advice for young people and their families including ensuring staff have the essential skills required.
- (iii) During 2007/08 the number of carer assessments undertaken experienced a 3-fold increase by 970 assessments compared to 2006/07. We also increased the percentage of home care clients aged over 65 who received personal care by 5.5% in the same period.

Our citizens and communities will be encouraged to take responsibility for their own health and well being

- (i) Further support has been given to develop youth initiatives such as football and rugby. This has meant there has been an increase in the number of young people participating in physical activity over the last year.
- (ii) The Council was the first to introduce 'cool to the touch' containers as part of the meals on wheels service. These containers are 98% biodegradable and ensure that the 42,000 meals delivered every year to the 328 users stay warm when delivered, while being cool when removed from ovens.

- (iii) The Council delivered a 10 week 'Virtual Baby' programme to 40 young people as well as taster sessions to 300 pupils in schools and community based settings. This comprehensive programme gave young people an insight into the knowledge and skills required to make informed decisions about parenting.
- (iv) 'Community Concerns Us' campaign was launched in spring this year. This campaign highlighted how people could report on anti-social behaviour within their communities.

Our citizens will be protected.

- (i) In summer this year the Council started a \pounds 5.2m programme of flood prevention, including approximately \pounds 4 m programme for Bo'ness.
- (ii) The Council established a project to develop closer relationships between parents and schools. This complements a project launched in schools 'Restorative Approaches' piloted in the Braes and Larbert High Schools which recognises the school as a community and that individuals within the school have a responsibility to each other.
- (iii) Further investment in Camelon Children's Centre worth \pounds 1.3m was approved. This will ensure the centre can cater for the youngest and most vulnerable children in our communities.
- (iv) A highly popular taxi marshalling service that was introduced over the Christmas and New Year periods was continued following a successful evaluation.
- (v) Citizens' confidence in their personal safety in their communities has increased. In 2007/08 90% of citizens were confident of their personal safety during the day and 51% during the night. This compares with 84% and 47% respectively in 2006/07.
- (vi) We are seeing the benefits of our investment in tackling anti-social behaviour in recent years. The number of domestic noise complaints fell from 157 in 2006/07 to 19 in 2007/08. The reported levels of anti-social behaviour also fell in the same period from 3474 to 3320.

Increasing our efforts to tackle disadvantage and discrimination

Our citizens continue to access critical services that meet their needs

- (i) The Council approved a number of projects through the Fairer Scotland Fund to be targeted at our individuals and communities of greatest need. These projects included measures to ensure access to debt and money advice services, further support to move people into employment and training and also measures to improve the environment of our areas of greatest need.
- (ii) Our Social Work Services were subject to a number of major inspections this year. This included an inspection of all social work services. To ensure it is understanding and meeting the needs of its customers more fully, the Service has introduced a range of customer feedback mechanisms. These include more consistent arrangements for dealing with complaints, further training and supervision of reception staff and also a revised set of service information leaflets.
- (iii) The MEC service was further developed and modernised. This now provides up to date hardware and software for people living at home, including people with complex needs and head injuries.
- (iv) The Stenhousmuir Children and families Social Work team received a top Social Work Care award which recognised their best practice in tackling alcohol and

vandalism related crime, as well as offering reactive services to our most vulnerable families.

(v) During the course of 2007/08, the Council has improved the number of buildings which are suitable and accessible to disabled people from 56% in 2006/07 to 63.4% in 2007/08.

Our housing continues to meet the needs of people who live and may wish to live in our area

- Our housing repairs service continued to improve with an increase in repairs completed on targets in both emergency repairs and other repairs. In addition, customer satisfaction levels were also high with 91% satisfaction over the last 18 months.
- (ii) 7 specifically designed homes for people with a disability were completed by the Council this year, with a further new 114 Council houses and 210 RSL homes planned over the coming years.
- (iii) We have developed a Home Energy Strategy that will help support our efforts to reduce fuel poverty and raise awareness of energy efficiency in our housing.
- (iv) The Council has implemented a strategy to assist homeless people. This is with a view to supporting and reducing the number of homeless people in our area. We have also introduced a new Housing Allocations Policy. This is set against an increase in demand for social housing. For instance, 1771 sought relocation from their current council house due to changed circumstances.

Vulnerable children will be protected

- (i) The Council continues to review and develop our child protection arrangements. We have, in addition to training our own staff in this critical area, expanded our training to other community and voluntary organisations. These arrangements and other measures to strengthen our child protection measures are being taken forward through the approved Child Protection Committee business plan.
- (ii) Following a successful funding bid, the Council has entered into an agreement with Arberlour Child Care Trust to develop a service for young female care leavers. This service will provide enhanced and intensive support for young women leaving care moving into independent living.
- (iii) We have also plans to expand our provision of residential care with the opening of two additional residential places in Tremanna child care unit. This will ensure our provision for our most vulnerable children is of the highest standards.
- (iv) We have developed over the last year, training and development opportunities for our valued foster carers. This has resulted in over 50% of our Foster Carers achieving SVQ awards.
- (v) The Council, in partnership with key agencies, has further progressed the integration of Children's Services. This has been assisted with the appointment of two locality managers for each of the respective pilots in Denny and St. Mungo's. A number of staff from different partner agencies are now co-located in Denny. Nineteen multi-agency training sessions have also been provided at which a total of 313 members of staff attended.

Disadvantaged communities will benefit from better services

- (i) In order to support some of our most vulnerable people within our communities, the Council developed two very innovative home support schemes earlier this year. The first, in conjunction with Grangemouth Enterprises and the Falkirk Homeless Project (Quickstart), the Council entered into a Public Social Partnership that provides furniture to homeless people and families that maximises the benefits to the wider community in terms of waste management and employment / training opportunities. Secondly, the Council recently appointed a Handyman to provide a small repairs service to all tenures. This service will benefit people aged 60 or over, or any person registered disabled who do not have an able bodied person living with them.
- (ii) The Council published an updated Equalities Scheme this year. This set out the priorities for the coming years and included focusing on looked after children, young males, physical assessments of buildings, as well as building relationships and community engagement. In conjunction with this, the Council, along with our community planning partners, published guides for migrant workers in our local area, highlighting issues such as housing, health, safety and employment. This complemented the Council's recently approved guidance on communicating with minority ethnic communities and people with a sensory impairment.
- (iii) In September this year the Council provided evidence to the Scottish Parliament's Local Government and Communities Committee on Poverty. We were one of only two Councils asked to give verbal evidence on our approach to tackling poverty, following our written submission.
- (iv) The Council working in partnership with the area's three Citizen's Advice Bureaux, have helped 1,266 people who have gone into debt in 2007/08 by assisting them in renegotiating \pounds 32.3m of debt. Although the number of benefit enquiries have dropped during the period, benefit gains have increased by \pounds 1.7m between 2006/07 and 2007/08.

Enhancing and sustaining an environment in which people want to live work and visit

We will be greener

- (i) Earlier this year it was announced that Falkirk was one of only six Councils that had been successful in bidding for Smarter Choices, Smarter Places funding. The Government's grant of \pounds 926,000 will be met with Council and partners funding of \pounds 453,000 to develop sustainable transport options for the Larbert / Stenhousmuir area.
- (ii) In line with our Biodiversity Strategy, progress has been made in a number of areas. These include the production of an Integrated Network Study Programme for the Falkirk Council area, the publication of Biodiversity and Development Supplementary Planning guidance, the development of a bird feeding project in the Council's care homes and the completion of a conservation project which saw the enhancement of three pond clusters.
- (iii) The Council launched a Carbon Busters campaign in autumn this year. This is aimed at reducing the Councils own carbon footprint by 20% in five years. This is in addition to nearly 97% of the Councils vehicles now running on low emissions fuel – an increase of 9% in the last year.

(iv) The Council continues to roll out the 3-bin system across the area to assist in our efforts to increase recycling and reduce the amount of waste going to landfill. Thanks to our communities, steady improvement has been maintained on our recycling rates during the year. In 2007/08 the tonnage of waste collected per 1,000 population fell by 82.4 tonnes compared to the previous year. We also reduced the total tonnage of bio degradable waste being sent to landfill by over 6,500 tonnes in the same period.

We will improve the built environment

- Earlier this year the Council allocated £600,000 that will ensure our major sporting and cultural centres are maintained the standards our communities require. This resulted in investment being made to Callander House, Grangemouth Sports Complex, upgrading our Leisure facilities, as well as improving local football facilities.
- (ii) The Council has improved performance on a number of key indicators to improve our built environment and open spaces. This includes increasing the percentage of planning applications processed within target time. The percentage of special uplifts completed within 5 days has also risen from 78% in 2006/07 to 92.8% in 2007/08. We have also improved on the removal of abandoned cars within 14 days from 85.2% in 2006/07 to 89.4% in 2007/08.

Our open spaces will be attractive, accessible and safe

- (i) The Council supported the development of a project called 'Communities along the Carron' which was successful in being awarded European Funding. This project seeks to connect local communities to the River Carron and develop a vision for using the river as a community resource. The aim is to reconnect communities along the river by gathering information on water quality, ecology and habitats, heritage, access and resources including shops, businesses and local attractions.
- (ii) In September this year the Council launched a new litter strategy. This strategy built on the successes of the last plan. Members will be aware that the cleanliness of the area has improved to its highest level in years. In addition earlier this year, we launched a community support pack for communities and groups who want to take action on local environmental projects such as neighbourhood clean up projects. This was complemented by a small grants scheme that would be made available to groups and organisations to plant trees, shrubs etc in their local communities.
- (iii) The Council approved a Parks Development Plan. This Plan set out ambitious targets for improving parks across the District. Alongside this, $\pounds 200,000$ has been allocated this year to improve our local parks and play areas.

Our profile will reflect our area as a destination of choice

(i) The Council launched the delivery phase of the 'Forth Dimension' a major heritage tourism project in conjunction with Clackmannanshire Council and the Stirling Smith Museum and Art Gallery. This project seeks to enhance the Forth Valley Museums status in the tourism economy by exploiting the potential of the areas advantageous geographical position and the strength of its heritage and existing museum collections.

- (ii) The Antonine Wall was inscribed as a World Heritage Site by UNESCO in July this year, following being chosen as the UK's nomination in February 2008. Following the announcement, the area received a great deal of press attention, given we have the largest and best preserved stretch of wall within our area. Work is now ongoing to ensure the area takes advantage of the World Heritage Site status. This is in addition to the Falkirk Wheel now being Scotland's 8th most popular visitor attraction.
- (iii) The Helix was awarded ± 25 million from the Big Lottery's Living Landmarks programme. In addition, the Council has also committed significant amount of funding to this project, which has recently seen the appointment of key members of staff who will be responsible for taking this exciting initiative forward.

Our Values

- 3.5 In addition to ensuring our services are focused on achieving local outcomes, we understand that we must seek to continually improve the way we do business. This commitment underpins the core values of the Council. To achieve this, the Council has recently reviewed our Best Value Improvement Plan. This follows the progress made in taking forward the areas for improvement outlined in the Audit Scotland Report on our Audit of Best Value and Community Planning.
- 3.6 An updated Best Value Improvement Plan was recently presented to Best Value and Audit Forum, following the report to Council in June this year that noted progress against our previous plan. Members will recall this noted progress on the following areas:
 - (i) Implementing new performance management software that will ensure consistent reporting of information to Members and the public;
 - (ii) Approving a Corporate Asset Management Plan for 2007-2010;
 - (iii) Developing further our approach to procurement including preparing an updated procurement plan;
 - (iv) Developing clear criteria for undertaking Strategic Best Value Reviews and completing the Diagnostic Project;
 - (v) Approving an HR and Workforce Planning Strategy;
 - (vi) Further taking forward our accreditation on IIP with Finance Service being awarded IIP status in summer this year;
 - (vii) Achieving the Healthy Working Lives Award earlier this year; and
 - (viii) Implementing customer service standards.
- 3.7 Future actions that underpin our values have been set out within the revised Improvement Plan.

4. FUTURE PLANS AND FURTHER SCRUTINY OF CORPORATE AND SERVICE PERFORMANCE PLANS

4.1 Each Service revises its service plan to ensure they are maximising their contribution to achieving the outcomes contained with the Corporate Plan. The Single Outcome Agreement as noted before sets out the performance management framework that underpins the Strategic Community Plan and Corporate Plan. This does not however replace the existing service performance reports that are presented to Members.

- 4.2 In line with practice this year, it is anticipated that all Services will present their Service Plans to the Best Value and Audit Forum, along with its first performance report of the new financial year and prior to the summer recess. This will allow Members to ensure that tasks contained within each Service Plan are taking forward the outcomes contained within the Corporate Plan appropriately.
- 4.3 Appendix one, as noted above, sets out the performance information the Council has included within the Single Outcome Agreement. This notes the progress the Council and our services have made against 2006/07 baseline figures. A number of services have further improved performance since March 2008. Some of these examples have been highlighted for Members' further interest. The process of refreshing the Single Outcome Agreement is currently underway with partners. This follows recently received guidance. The refreshed Single Outcome Agreement will contain information from all partners and will include progress against all performance information contained therein.
- 4.4 The refreshed Single Outcome Agreement has to be ready in draft by the end of February for submission to the Scottish Government. The refreshed Agreement will be presented to Members for approval in the New Year.

5. CONCLUSION

5.1 Progress in the first year of the Corporate Plan has been good. It is also heartening to note that while we understand the global economic situation we are in presents us with challenges, recent surveys of young people and our business community continue to show optimism and aspiration for the future of our area. We do not underestimate the challenges we face; we have a firm foundation to build on to ensure the outcomes set out in our Corporate Plan are achieved.

6. **RECOMMENDATIONS**

It is recommended that Members:

- 6.1 Note the progress against outcomes contained within the Council's Corporate Plan;
- 6.2 Note the progress the Council and its services are making against the performance indicators contained within the Single Outcomes Agreement and set out in appendix one of this report; and

1. Introduction

- 1.1 The economy of the Falkirk area faces significant challenges as the "credit crunch" and resultant economic downturn take effect. An economic recession is anticipated during 2009 which could inhibit the regeneration of the Falkirk economy and blight prospects for business, investment and jobs. Action has been initiated at national level to assist business and the economy however concerted action is also needed at local level to mitigate the effects of recession.
- 1.2 Falkirk Council is keen to act on behalf of local businesses, people and communities, leading the response of partners locally to minimise the impact of the economic downturn and maintain the momentum of regeneration. This report sets out the anticipated impacts of the economic downturn, the area's economic strengths, which will aid its response, the actions underway currently to bolster the area's economy and the key actions planned by the Council to respond.

2. The Falkirk area and the economic downturn

- 2.1 It is anticipated that the UK economy will face a significant recession. The UK Government anticipates an economic decline of 1.25% during 2009. The Falkirk area is now experiencing the effects of the economic downturn:
 - Unemployment, which early in 2008 fell to below the Scottish average, its lowest level for 25 years, has increased in the past year and is now 2.7%, with 2,576 people unemployed.
 - Investment in regeneration projects has slowed. The timescales for delivery of key projects in Bo'ness and Falkirk Gateway have had to be extended due to reduced demand and capacity for investment.
 - Several local companies have announced redundancies or plan to reduce staff levels. Many local companies experience difficulties in accessing funds to maintain cash flow or progress new investment. Additional problems result from increased energy costs or supply chains fragmenting.
 - Other evidence of economic stress has been witnessed in reduced trading activity in town centres and increased claims for hardship relief. A substantial drop in house purchases has been witnessed and enquiries for business properties have reduced.

- It is anticipated that 2009 will show increases in unemployment, further decline in business confidence and activity and lower levels of investment.
- 2.2 Despite this, the Falkirk economy has substantial strengths. Partners locally demonstrate resilience and a resolve to face the economic challenge in the year ahead:
 - The Falkirk economy is strong and diverse, with sectoral strengths in petrochemicals, engineering, food and drink and logistics.
 - Falkirk's economy includes major companies such as Alexander Dennis Ltd, BP, Ineos, Forth Ports, Asda and Kemfine. Many companies compete successfully in markets where the recession's impact will be less significant and where opportunities for business growth can be exploited.
 - Public sector investment programmes in new schools, housing, health, and roads are likely to 'cushion' some of the impacts of recession, particularly in construction.
 - The area has capacity to respond to investment opportunities that arise and can exploit the prospects for economic growth to return. Falkirk is well-located; it has a growing population, a strong commercial and industrial base and presents many excellent development opportunities.
 - Recent business surveys have demonstrated that, despite the economic challenge, local companies remain fairly positive about levels of sales, investment and jobs in the coming year.
 - A solid partnership exists between the public and private sectors in Falkirk to carry forward the area's response.

3. The Response to the Economic Downturn

- 3.1 The economic downturn demands a response by many partners, in the public and private sectors. Falkirk Council recognises that its leadership role is vital in harnessing local capacity to address the economic challenge. There is a need to:
 - Exploit opportunities for investment and, despite the financial pressures, maintain expenditure locally, particularly in the hard-pressed construction sector, to upgrade local infrastructure and maintain the momentum of regeneration projects.
 - Manage the impact on local companies, assisting them to access business support in the form of business advice, grant and loan funding and networking opportunities.
 - Ensure that local organisations target their efforts to reduce the impact of unemployment, guiding people to available jobs and other assistance, while minimising the impact for those hardest to reach.
- 3.2 Falkirk Council is a significant player in the provision of business property within the local economy. Its portfolio of industrial, office and retail space comprises over 800 properties and generates a rental income of around \pounds 4.5 million. During the period of the economic downturn, lease rents will require to be reviewed and leases will come to an end. Market conditions play a major part in rent review and lease

renewal negotiations. In some circumstances these may naturally lead to nil rental uplifts. Council officers have examined the option of 'suspending' rent reviews and consider this is not a constructive way forward. It would not be equitable or sufficiently well-targeted towards need. Specifically, it would only impact on a small number of companies who are currently Council tenants and have rent reviews arising over the suspension period. Additionally, such action could have the undesirable effect of distorting the property market at a time when the Council should be working to help stabilize rental and capital values. However the Council has a responsibility to examine how all businesses in its area, not just its commercial tenants, can be supported at this time and how this can be achieved.

- 3.3 Notwithstanding the position with regard to rent reviews and lease renewals, the Council may be able to assist tenants through re-scheduling rental payments, for example by allowing a business to pay less now, more later in the course of the lease term. In considering such courses of action, the Council will need to pay due regard to the financial history and viability of the business concerned. The implications for its own budget position, which is being stretched during the recession, will also be a factor.
- 3.4 However the Council considers that a more comprehensive and targeted approach to the impact of the downturn is needed. The economic recession will impact across many parts of the Council and demands a joint response by all services. This response must build upon the existing commitments which have been initiated to develop the Falkirk economy via "My Futures in Falkirk". It must progress a set of key actions in the following areas to address the economic challenge. These actions are set out in the attached Table and summarised below:

Business Support:

Through the actions of the Business Gateway, Falkirk Council and Scottish Enterprise a range of support services are available for business start-up and growth. Strong links have been established between the business community in Falkirk and the support network via the Falkirk Business Panel. Action is currently underway to review our approach to business support services with the aim of establishing a new "one-stop" service for business in Falkirk. However there is plainly an urgent need to bolster support to businesses at this time. It is therefore proposed to extend local business support services including those delivered through the Business gateway and in the Joint Working Agreement currently operated with FEAT.

In addition to existing business support programmes, the Council will invest £,100,000 to:

- a) Promote a package of local business support assistance delivered via the Business Gateway and the Joint Working Agreement with FEAT to aid companies adversely affected by the recessions and, by engaging with the Falkirk Business Panel, conduct networking opportunities to help address the issues involved;
- b) Assist local retailers, by asserting the value of shopping locally, promoting town centres, and progressing town centre regeneration;
- c) Review the Council's responsiveness to business in its advice services, speed of decision-making, delegation and exercise of regulatory powers.

d) Initiating a programme to promote local tourism, including upgrades to tourist signage, local events etc.;

Transport, Infrastructure & Investment

Falkirk is well-located in Central Scotland, however there are significant constraints to access for its key economic assets including the Grangemouth Freight Hub, the Petrochemical complex and business locations. The funding of infrastructure works has also proven to be a significant constraint to regeneration investment. Work is currently underway to promote improved transport links and maintain investment that reflects the significance of Falkirk to the national economy. Meanwhile it is important to maintain investment levels in the local economy. Investments by the public sector in new schools, affordable housing etc. will help to maintain the buoyancy of the local construction sector and downstream industries.

In addition the Council will:

- e) Pursue the case for accelerated capital investment under the recently announced Scottish Government capital programme fund to upgrade infrastructure links in the Falkirk area;
- f) Promote investment in new affordable housing and stimulate new development through construction of housing for rent and, in partnership with local RSLs and other housing agencies, deliver new homes for rent or low cost ownership;

Business Locations

The provision of sites and premises for business is a key priority for the Council and projects are underway to ensure competitive business locations are available for investment and business growth. Successful schemes have been completed at Alcan, Wholeflats and Bo'ness. However for some schemes, infrastructure, Section 75 requirements and other market constraints have delayed investment. As a result, a responsive and targeted approach is required to ensure that a range of business locations is available to respond when the economy regenerates.

Additionally the Council will:

- g) Seek to accelerate £600,000 of its planned investment in business property through the capital programme;
- h) Adopt a flexible response to maintain investment in regeneration schemes, extending timescales for delivery and reviewing upfront infrastructure commitments;
- i) Extend the flexibility of the Council's approach to planning reviewing its approach to Section75 agreements attaching to planning consents. In addition, we will also be re-evaluating the impact of the impending recession as a material consideration in determining planning applications to attract investment and maintain jobs;

Assisting the workforce

It is important to ensure that Falkirk maintains a skilled and flexible workforce and that the impact of the recession on local people in terms of unemployment, financial exclusion and

homelessness is minimised. Considerable effort has been directed in recent years to promote opportunities for young people to access the labour market. This effort will be maintained, however additional actions by the Council will be taken to:

- *j)* **R**eview access to jobs locally and redundancy support services to ensure a continuing co-ordinated response to unemployment;
- *k)* Assisting local companies to access training advice and support, particularly to engage young people in work based training and/or apprenticeship programmes;
- 1) Engage money advice and social services to assist in directing enquiries for increased support and assistance to meet local need.

Taking the Plan Forward

- 3.5 Importantly, this Action Plan will not divert the Council from its long-term vision of a robust, diverse and thriving local economy. The current strategy is being reviewed and a revised version will be brought forward next year, outlining the longer term ambitions for the area.
- 3.6 The actions proposed for the economic downturn are targeted, short term and involve all Council services. It is anticipated that, in addition to current commitments, the additional actions proposed in this action plan will involve a commitment of $\pounds700,000$ for the Council. These actions have the intended effect of managing the impact of the recession across the Council whilst enabling the area's economy to respond for the longer term, exploiting opportunity and building on the area's undoubted strengths.

4. **Recommendation**

- 4.1 It is recommended that the Council:
 - i) agrees the Action Plan for the Economic Downturn as set out in this report.
 - ii) Agrees to allocate £100,000 of revenue funding, to be committed over the financial years 2008/9 and 2009/10, to permit the extension of business support services delivered through the Council's Joint Working Agreement with FEAT
 - Agrees to accelerate the allocation of £600,000 of capital funds from the 2009/10 budget, earmarked for economic development projects, for investment in business property

1. INTRODUCTION

- 1.1 In May 2007, Council appointed its representatives to the Central Scotland Joint Fire and Rescue Board. Council also agreed to appoint named substitutes to the Board.
- 1.2 In August 2008, Councillor Alexander, who had been a substitute member, was appointed by Council as a full member of the Fire and Rescue Board following the resignation of Councillor Kenna. A named substitute has yet to be appointed in Councillor Alexander's place.
- 1.3 Councillor A MacDonald, a named substitute, has indicated his intention to resign from this post.

2. POLITICAL BALANCE

- 2.1 In appointing members to the Board, Council agreed that the allocation of the 6 places available would be as follows:-
 - 3 Labour
 2 SNP and
 1 Conservative <u>or</u> 1 Independent <u>or</u> the non-aligned Independent

No such stipulation was made for the appointment of substitute members although the appointment to the substitute list reflects this allocation.

2.2 In terms of maintaining the political balance of Falkirk Council's representatives on Central Scotland Joint Fire and Rescue Board, the vacant substitute positions would be filled from the SNP Group which has indicated that Councillor McNally would replace Councillor Alexander and Councillor Meiklejohn would replace Councillor A MacDonald.

3. **RECOMMENDATION**

3.1 Council is invited to appoint two members as substitute members on Central Scotland Joint Fire and Rescue Board.
