

**MINUTE of MEETING of CENTRAL SCOTLAND VALUATION JOINT BOARD

**VJB1. ELECTION OF CONVENER AND DEPUTE CONVENER AND THE  
LOCAL GOVERNANCE (SCOTLAND) ACT 2004 (REMUNERATION)  
REGULATIONS 2007**

There was submitted Report (circulated) by the Clerk summarising the process for the election of a Convener and Depute Convener of the Joint Board and advising of the remuneration arrangements permitted under the Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007.

The Clerk invited nominations for the position of Convener.

Councillor MacDonald, seconded by Councillor Blackwood, nominated Councillor Simpson.

By way of an amendment, Councillor Jackson, seconded by Councillor Carleschi, nominated Councillor Patrick.

On a division, the motion defeated the amendment by 8 votes to 6.

Accordingly, **AGREED** to elect Councillor Simpson as Convener of Central Scotland Valuation Joint Board.

Councillor Simpson then took the chair.

The Convener invited nominations for the position of Depute Convener.

Councillor MacDonald, seconded by Councillor Nimmo, nominated Councillor McLaren.

There being no other nominations, **AGREED** to elect Councillor McLaren as the Depute Convener of Central Scotland Valuation Joint Board.
