<u>CIVIC GOVERNMENT (SCOTLAND) ACT 1982</u> <u>REVIEW OF TAXI TARIFF</u>

Notice is hereby given, in terms of section 17(1) of the Civic Government (Scotland) Act 1982; Falkirk Council has undertaken a review of the scales for the fares and other charges applicable to the hire of taxis within the Council area. In carrying out the review, the Council consulted with and heard representations from persons or organisations appearing to them to be or be representative of the operators of taxis within their area.

The general effect of the review is to propose that with effect from midnight on 31 August 2022 the existing scale of fares and charges shall be altered as follows:

Public Holidays/ Christmas & New Year Tariff

For hirings between 0600hrs and 2100hrs on public holidays -Tariff 2 (i.e., General Tariff Plus 25%)

For hirings between 2100hrs on Christmas Eve and 0600hrs on Christmas morning, 2100hrs on Christmas night and 0600hrs on Boxing Day morning, 2100hrs on New Years Eve and 0600hrs on New Year Day, 2100hrs on New Years night and 0600hrs on 2 January (i.e., General Tariff Plus 50%)

<u>Note</u>

For the avoidance of doubt Tariff 2 will apply from 2100hrs on the evening preceding a public holiday until 0600hrs on the morning following that public holiday.

Such Public Holidays to be recognised as Good Friday; Easter Monday; May Holiday Monday; Falkirk Fair Monday & September Holiday Monday; Day time Christmas Day; Boxing Day, 1 & 2 January.
