Community Schools 2008 Charity is a company limited by guarantee, registered in Scotland (Company Number SC319676) having its registered office at Sealock House, 2 Inchyra Road, Grangemouth, FK3 9XB and is registered as a charity with the Office of the Scottish Charity Regulator (No SC038221).

#### 1. BACKGROUND/LEGAL AND CONSTITUTIONAL STATUS

#### i. What is Falkirk Community Schools 2008 Charity?

The organisation was established as a **company limited by guarantee**. It is a registered charity (SC038221). As a company limited by guarantee it is a separate legal entity. The Company is run by a Board made up of individuals with relevant interests, skills and experience and collectively the Board establishes the strategic direction for the organisation, makes decisions for disbursement of funds and is responsible for seeking additional external grants.

#### ii. Aims and Objectives of Charity

The Community Schools 2008 Charity was established following the four (NPDO) secondary schools being completed. The charity's main aim is to receive and disburse the proceeds that it is contractually due to receive from the NPDO schools project holding company, Gateway. In addition the charity is able to apply for external funding to assist with projects in keeping with the charity's purpose and objectives.

The charity objectives are:

- To advance education within the catchment areas of all the secondary schools.
- To provide (or assist with the provision of) recreational facilities within the operating area with the object of improving the conditions of life for the people for whom the facilities are primarily intended.

The charity board is also responsible for the distribution of grant awards to voluntary groups and organisations throughout the whole of the council area. The charity board assess the applications received and distribute grant awards to successful applicants.

#### iii. Liabilities Insured by Charity

Falkirk Community Schools 2008 Charity is established as a **company limited by guarantee.** This means it is a separate legal entity and can enter into contracts in its own name. Trustees are not therefore personally liable for any debts the organisation may have (other than in circumstances where the Trustee has acted fraudulently or is grossly negligent).

The Memorandum and Articles for the company permit the company to purchase indemnity insurance on behalf of the Directors.

#### 2. PERIOD OF REPORT 2015/16

i. This report covers the period from 1 August 2015 – 31 July 2016.

#### 3. **BOARD COMPOSITION AND APPOINTED DIRECTORS**

#### i. **Board Membership**

#### iv. Reappointment of Directors

Accordingly, the Board approved an amendment of the charity board's Memorandum and Articles of Association to reflect this.

#### 7. SUMMARY OF 2015/16 OPERATIONS

#### i. Update

The Charity Board has had another good and successful year in further developing operational processes and administering and distributing grant awards in accordance with Charity Board requirements.

During this year the Board have been continuing to develop the grant award scheme, the maximum award is £1,000. It was agreed to defer the "challenge fund" this year (the grants to encourage local community groups and organisations to submit bids for larger innovative projects that benefit the local community), given there were a number of outstanding challenge fund projects which had still to be completed. Over the course of the year these have now been completed and all grant instalments have now been paid.

#### Outstanding Challenge Fund Grants (Paid in 2015/16):

- Wallacestone Parents Association (Installation of MUGA) Amount awarded £10,000 – paid.
- <u>Victoria Harriers</u> (Cross Country Events) Amount awarded £5,000 to be paid in 2 instalments 2<sup>nd</sup> payment paid.

#### Falkirk Sports Council and Falkirk Arts & Civic Council

The Board also deferred awarding £10,000 to both Falkirk Sports Council and Falkirk Arts & Civic Council to enable then to:-

distribute grants to individual talented artists or athletes and provide coaching,

This decision was taken to enable the grants to be fully spent and financial reports to be submitted to be the Board for scrutiny.

The financial reports from Falkirk Council Sports Council was submitted to the Board in June 2016 and an award to Falkirk Sports Council was approved but due to timing of the submissions this application will fall into the next financial year.

#### **Grahamston Youth Trust**

During the year discussions also took place with Grahamston Youth Trust (GYT) who were a charity that ceased operation but who had funds still remaining in their bank account. GYT asked the Board to consider taking over responsibility for these funds and distribute to local groups in accordance with our own procedures and rules.

Following examination of accounts and other scrutiny and compliance checks. The Board agreed to this request and funding amounting £ 85,762.43 was transferred to the Charity Board on 12 May 2016 and will appear in the financial accounts next year.

#### ii. Grant Applications

During the year, from the period (1/8/15 - 31/7/16) a total of 33 applications were received. Their status is as follows:-

- £990.50 is pending (awaiting further information).

Two of the Board Members, Gary Greenhorn and Christine Bell are also co-opted Directors of Falkirk Schools Gateway Limited (FSGL) and attend the FSGL Board Meetings. The co-opted Directors provide the Charity Board with regular updates of the meetings.

The Charity Board has an account with the Clydesdale Bank and all funds received from (FSGL) are lodged in to the Charity Board account.
